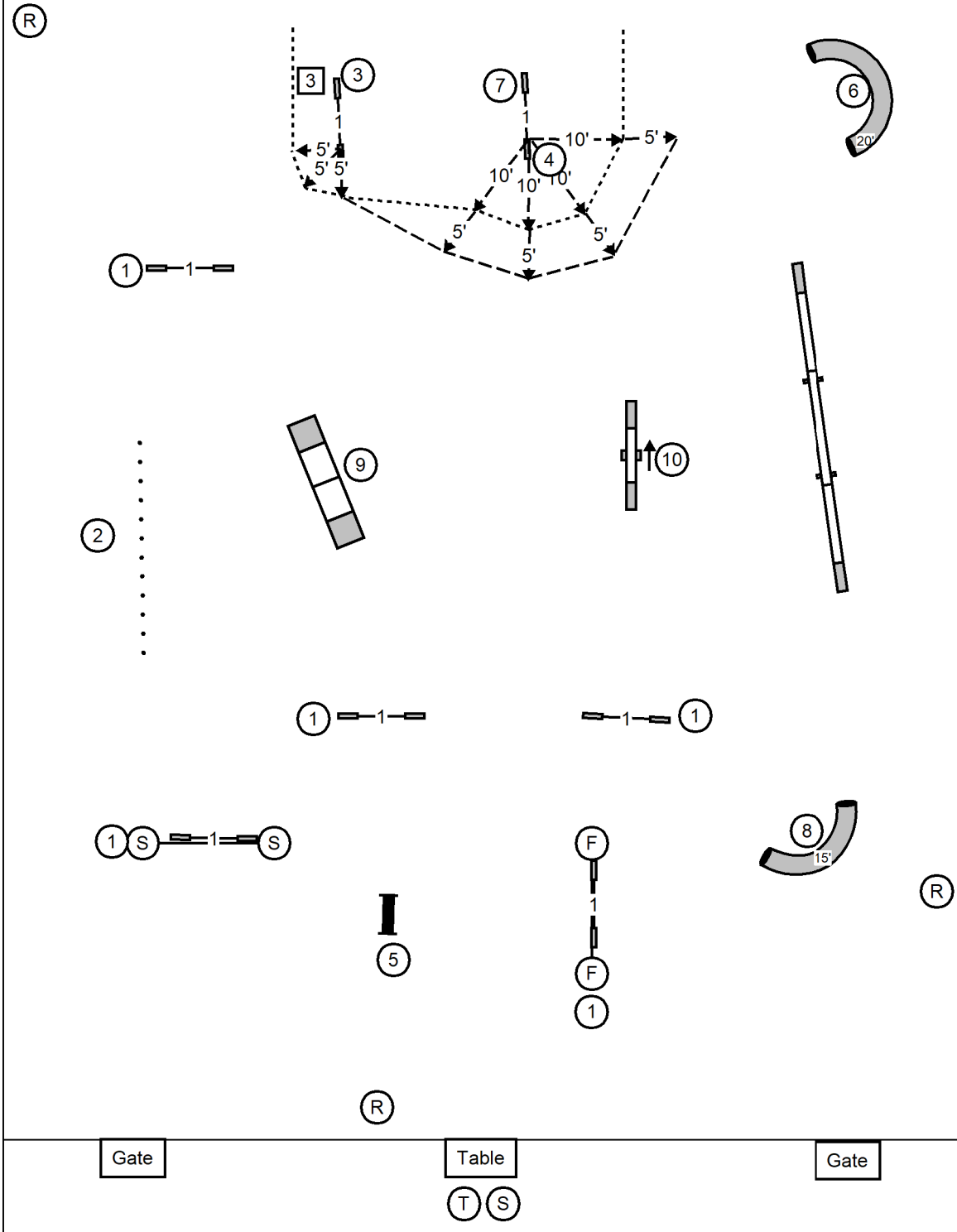
NOTES:

Start Jump = 1pt bi-directional

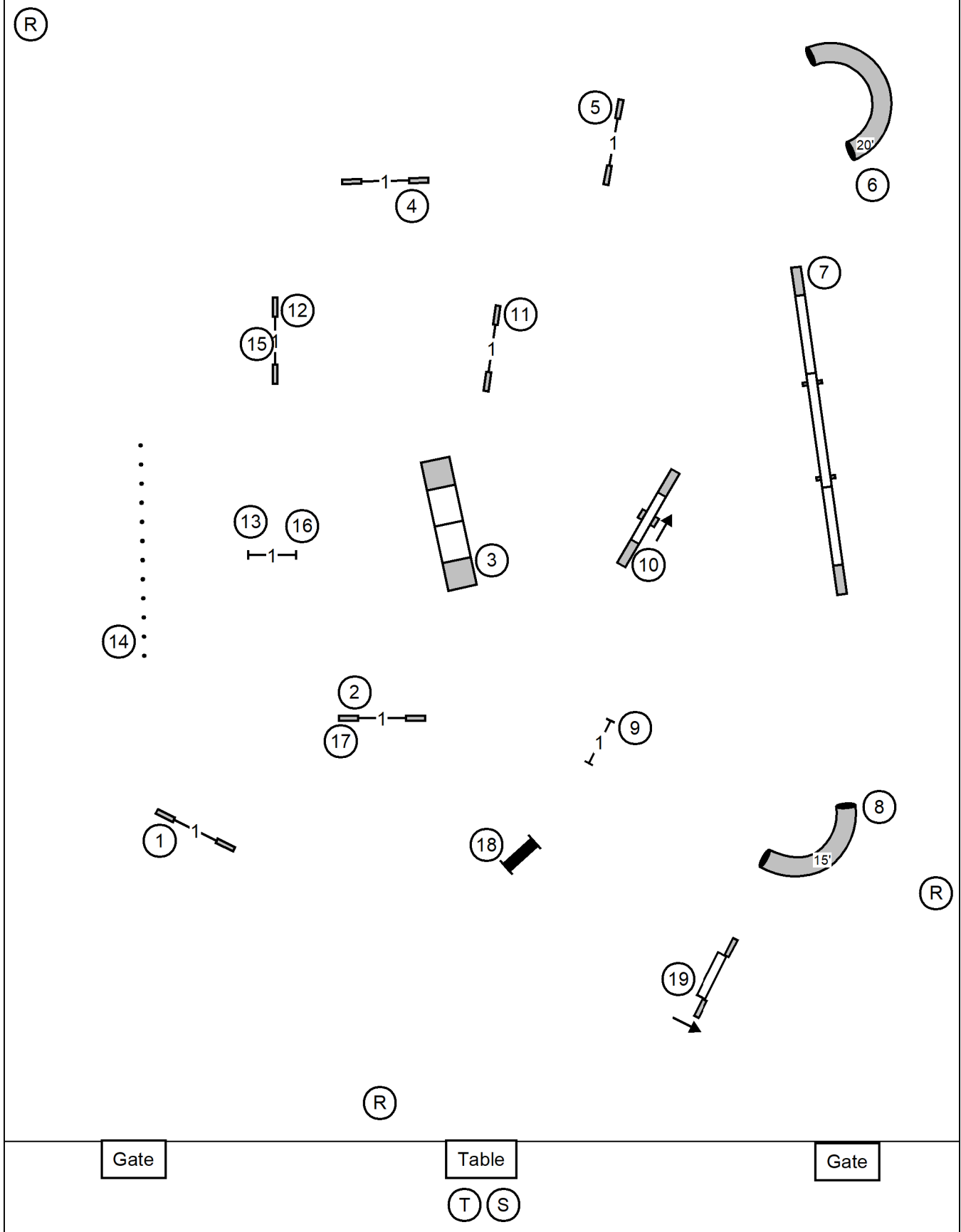
Finish Jump = 1pt bi-directional (ends runs)
