### Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competitions by action of the Event Committee.

Entry fees will not be refunded if the trials cannot open or complete by reason of riots, civil disturbance, fire, and act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Bitches in season are not allowed to compete in AKC Agility Trials. Refunds for bitches that come in season and injured dogs after the closing date, will receive a refund minus \$15 per day. The Trial Secretary must receive written refund request including a veterinary statement by letter hand-delivered, emailed, or postmarked before the trial commences.

People who are experiencing COVID-related symptoms, are self-quarantining or are involved in contact tracing for COVID exposure will be given a refund less \$15 per day. To receive a refund, you must contact the trial secretary 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$10.

Checks for canceled entries will be shredded; no check will be returned.

Owners are responsible for errors in making our entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Exhibitors are responsible for being at the ring gate when it is their turn to run. Failure to be at ring gate could result in the exhibitor being marked absent.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC title on entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors may wear shirts or insignia of their training group if they wish.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Exhibitors are responsible for cleaning up after their dogs(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of the requirement.

Electronic timing will be used at these trials.

### Dogs Eligible to Enter

These trials are open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registrations, or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds. Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

### AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs except those jumping 24" or 26" without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run. **You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form if your dog needs to be measured.**

### Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification had been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

### Online Entries

This trial is accepting online entries through LabTestedOnline.com. All entries submitted online will be accepted until the draw closes. After the draw is completed, if there are runs available, the Trial Secretary will have the option to continue to accept entries online. Any online entries that are not accepted into the trial from the draw will be put on the waiting list. Coupons cannot be used for online entries.

**Paper entries received within the first 24 hours** must include postage or be metered and must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for delivery services, if applicable.

Limit of 10 dogs per envelope. No hand deliveries can be accepted in the first 24 hours.

No FAX or emailed entries accepted.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable and will be returned.

If you would like confirmation that your entry was received before the trial has closed please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. **Please check your entries!**

### Random Draw

Entries for the random draw will be accepted from Monday, March 9th, 2026 at 8am CT to Monday, March 23, 2026 at 6pm CT. The drawing will be held on Monday, March 23<sup>th</sup> at 8pm CT at the Secretary's office, 805 Nancy Lane, Weldon Spring, MO 63304.

### "After Closing" Waiting List

A waiting list (50 run per maximum each day) will be maintained for these trials once they have closed at 6:00pm CT on **May 6**. The waiting list will be active until its deadline – Monday, **May 18** at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the runs.** Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

### Move-ups

**For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, May 18, 2026.** Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

**For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday, respectively and must be submitted at the trial.**

### Trial Information

Trial Hours are 7:00 am to 30 minutes after the completion of the trials.

Ring size: 100' X 90'

The building is climate controlled.

Exercise pens are not allowed.

**Ground Covers (ie: tarps, crate mats, towel) are required under all crates.**

For the safety of everyone, all covers must be completely under your crates.

Personal chairs will be allowed in the building.

Flexi-leads will not be allowed in the building.

Battery operated fans are welcome.

Dogs may not be left in the building overnight.

Please bring crates, water and clean up after your dogs.

Setup time will be announced after closing.

### Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

1st place.....	Blue
2nd place.....	Red
3rd place.....	Yellow
4th place.....	White
Qualifying.....	Green

A jump bar and MACH rosette will be awarded to any handler finishing a MACH title at these trials. A jump bar and PACH rosette will be awarded to any handler finishing a PACH title at these trials.

A new title rosette will be awarded to any dog finishing a title at these trials;. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" ribbon. Dogs qualifying in all three Master Standard, Master JWW and Master FAST in the same trial will receive a 'Triple-Q' ribbon.

High in trial Shetland Sheepdog will receive a crate pad as prize.

### Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

#### **Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

### Fix and Go On (FNG)

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

### For Exhibition Only (FEO) – IS being offered in all classes at this trial

For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.

FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler may declare the day of the show.

Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.

Dogs may be entered at any level (Novice, Open, Excellent or Masters) in FAST, JWW or Standard or in Premier classes. If a dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

Course time for FEO in Time 2 Beat, JWW, Standard, Premier & ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations.

FEO runs will scored as 'absent' in catalog and results.

Exhibitors must exit the ring when the horn sounds.

### Volunteer Worker Form

After closing, a fillable worker form will be sent out to all exhibitors to fill in for volunteering. Volunteers will receive coupons toward lunch and raffle tickets.



INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
