DOGS ELIGIBLE TO ENTER

These events are open to Golden Retrievers which have been registered with the American Kennel Club and are six (6) months of age or older or have an acceptable foreign registration number (subject to restrictions in Chapter 11, Section 1 of the Rules Applying to Dog Shows). **Obedience and Rally classes** are open to dogs of all breeds which are six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or are approved Foundation Stock Service (FSS) breeds. Bitches in season may not compete in Obedience or Rally. *The Golden Retriever Club of Greater St Louis will NOT be accepting Obedience or Rally entries for dogs listed in the AKC Canine Partners Program, which includes All American/ Mixed Breed dogs.*

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

Winners of the Non-Regular classes are eligible for Best of Breed Competition provided they remain undefeated in another class.

BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. Selects, if applicable, will be chosen following Best of Breed. to be followed by NOHS, Awards of Merit, Best Puppy, Best Veteran. See Special Recognition.

SPECIAL RECOGNITION

Best Veteran: Following Best of Breed, the assigned judge will select a Best Veteran from the Veteran Class winners. The Best Veteran award is automatic if an entry from the Veteran class is awarded Best of Breed. Only dogs and bitches undefeated in a Veteran class are eligible for Best Veteran competition. If the first-place winner is not present, the second-place winner may not compete. Neutered and spayed dogs and bitches may compete.

Best Puppy: Dogs & Bitches in the 6-9 Months, 9-12 Months and Puppy Bred-By-Exhibitor will compete for Best Puppy. If a winner from one of the Puppy classes is awarded Best of Winners or Best of Breed, then the win is automatic. Only dog and bitches undefeated in each Puppy class are eligible for Best Puppy competition. If the first-place winner is not present, the second-place winner may not compete.

Judge's Award of Merit: The judge may select, at his/her discretion, up to 10% of the superior quality specimens from the Intersex competition. These would not include those exhibits previously awarded Best of Breed, Best of Opposite Sex to Best of Breed or Select Dog/Bitch.

ATTENTION EXHIBITORS OF FOREIGN DOGS

Effective August 1, 2024 the U.S. Centers for Disease Control and Prevention (CDC) is expanding requirements for the importation/entry of foreign dogs into the United States. Requirements include that all dogs must be at least 6 months of age, microchipped, complete new CDC Dog Import forms, and have a valid rabies vaccination or be able to demonstrate residence in a DMRVV (canine rabies)-free or low risk country for the last 6 months. The Veterans Obedience class is for dogs that have an obedience title and are at least 8 years of age on the day of the trial. The exercises will be performed and judged as in the Novice class. Dogs may be entered in another class or classes.

RALLY

Regular Classes: Rally Novice A, Rally Novice B, Rally Intermediate, Rally Advanced A, Rally Advanced B, Rally Excellent A, Rally Excellent B, Rally Master, Rally Choice, RAE, RACH

Rally entries must include dog's jump height if applicable. Rally ring size: 40' x 60.'

Jump Height Order

Obedience classes will be run short-to-tall on Friday & Sunday and tall-to-short on Saturday. Rally classes will be run short-to-tall for the morning trials and tall-to-short for the afternoon trials. Exhibitors entering classes with jumps are required to include their dog's jump height on the entry form. Tall to short will be accomplished with reverse catalog order for all classes. Every effort will be made to accommodate handlers with multiple dogs in the same class.

SWEEPSTAKES & VETERAN SWEEPSTAKES

SWEEPSTAKES

The Sweepstakes is open to all Golden Retrievers who are 6 months & under 18 months of age on the day of the show. All dogs entered in Sweepstakes must also be entered in a Regular Class. AKC Champions of Record may NOT be entered. Sweepstakes will be judged prior to the Regular Classes. Indicate Sweepstakes and age division on the regular entry form under "Additional Classes." No Handler Restrictions for Sweepstakes. Entry fee is \$25.00.

Champions of Record, neutered dogs and spayed bitches may be entered in Veteran Sweepstakes. If entered in both classes, the regular entry fee and the Veteran Sweepstakes Class entry fee will both apply. Indicate Veteran Sweepstakes and age division on the regular entry form under "Additional Classes." No Handler Restrictions for the Veteran Sweepstakes. Entry fee is \$25.00.



All exhibitors must be responsible for cleaning up after their dogs on the motel and show grounds. Motels require that dogs be crated when unattended. From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately ½ mile, turn left on MM at gas station. Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.

From West: Take I-70 to Hwy 47, Exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit to Gray Summit. Follow directions above.

NOTICE TO EXHIBITORS

- The Event Center will be available to Conformation/Obedience/Rally exhibitors on Thursday, January 15 from 4:00PM - 6:00PM.
- There are NO night time security personnel on site. NO DOGS will be allowed to remain in the building overnight.
- Grooming with electricity is plentiful in the Gateway Hall at no cost to exhibitors.
- CRATING & GROOMING: Grooming and crating in designated areas only. Bathing of dogs limited to bathing area, located next to grooming area. No dogs allowed in bathrooms. No Ringside crating in the Great Hall with the exception of the Agility, Obedience and Rally Trials. NO CRATES MAY BE PLACED DIRECTLY ON THE FLOORING SURFACE IN THE GREAT HALL. THERE MUST BE PLASTIC OR A RUG UNDER THE CRATE. ALL GROOMING TABLES MUST HAVE RUBBER OR PLASTIC CAPS ON THE END OF THE LEGS OF THE TABLE.
- No cones are allowed inside building.
- NO EX-PENS allowed on the blacktop, the grass around the Event Center or in the Event Center. This includes the Gateway Hall.
- All dogs must be on-leash at Purina Farms at all times (except when crated or as required to be judged).
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies Vaccination Certificate - Missouri requires you to have proof of current rabies vaccination with you. Tags are not accepted.
- Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- No dogs wrongly entered in a class may be transferred to another class except as provided for in Chapter 11, Section 6 of the AKC Rules Applying to Dog Shows: "a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve to Eighteen Month Class at a show prior to judging, and except that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging at the show."
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors of their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Obedience and Rally Trials - Entries for Golden Retrievers only will be accepted until closing; all other breed entries will be put on a waiting list. At closing entries from other breeds will be accepted into the trial in order of receipt until the limit is reached.
- All exhibitors MUST abide by the 15 minute unloading/loading parking time limit designated around the Event Center. All vehicles must leave their headlights on while unloading. NO VEHICLES MAY BE PARKED NEXT TO BUILDING OR IN ANY ROADWAY. VIOLATORS WILL BE TOWED AT OWNER'S EXPENSE.

- First entry of a dog in Conformation or Obedience, a \$3.00 Event Service Fee and \$.50 Recording Fee, plus a \$3.50 Service Fee for each additional entry of the same dog.
- First entry and each additional entry of a dog in Agility or Rally, a \$3.50 Service Fee.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.**
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Clubs is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. - Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
