### **Dogs Eligible to Enter**

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or ap- proved Foundation Stock Service (FSS) breeds. Dogs enrolled in the AKC Canine Partners Program are excluded.

Dogs with a PAL/ILP number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

**Class Order** – Regular, then Preferred, will run at each height

Thurs FAST (all levels run per jump height), Standard (M/Ex, Open, Novice), Time2Beat, Jumpers with Weaves (M/E, Open, Novice)

Fri FAST (all levels run per jump height), Standard (M/E, Open, Novice), Premier Jumpers, Jumpers with Weaves (M/E, Open, Novice)

Sat Jumpers with Weaves (M/E, Open, Novice), Premier Standard, Standard (M/E, Open, Novice),

Sun Standard (M/E, Open, Novice), Time2Beat, Jumpers with Weaves (M/E, Open, Novice)

**Jump Order** –

All days Small to Tall

## Move-Ups

**For the Thursday trial: MOVE-UPS close at 6:00 pm CT, Monday, July 13, 2026.** Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

**For the Friday, Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday, respectively and must be submitted at the trial. Mailed/mailed move-ups close at 6:00pm CT, Monday, July 13, 2026.**

## Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

## "After Closing" Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on July 1, 2026. The waiting list will be active until its deadline — Monday, July 13, 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full

## Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

The American Spaniel Club, Inc. may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$10.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The American Spaniel Club, Inc. has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

American Spaniel Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$12.

Checks for cancelled or incomplete entries will be shredded. No check will be returned.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

The American Spaniel Club, Inc., its Board, Members, and Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

No smoking or vaping is allowed in the Event Center.

Electronic timing will be used at these trials.

## Agility Ribbons & Awards – All Days, All Breeds

Rosettes will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons. Rosettes will be awarded in each jump height division in each class as follows:

1st place.....	Blue
2nd place.....	Red
3rd place.....	Yellow
4th place.....	White

Dogs earning a AGCH, MACH, or PACH will receive a commemorative rosette and bar. Dogs earning a PAX will receive a rosette. If both a PACH & PAX are earned, only a PACH rosette will be presented. Dogs earning a new title will receive a New Title rosette and dogs earning a qualifying score in Master Standard and Master JWW classes at the same trial will receive a Double Qualifying ribbon (does not include Premier classes).

Note: All prizes, awards, rosettes and ribbons must be claimed the day of the trial. No prizes will be mailed. Awards require a qualifying score.

Additional Tie Calculation Information:

\*If there is a tie for any award utilizing the MACH/PACH like formula of points, the last means of calculating the winner will be determined by utilizing the fraction of seconds of a MACH/PACH point (i.e. the lowest fraction of dog's total time is winner; 40.20 wins over 40.30 seconds).

NOTE: Handlers are responsible to sign up for High Scoring Special Awards and Additional Special Awards on Thursday prior to the start of the Master Standard class in order to be eligible to win. There will be a table with sign-up sheets near the ring Thursday before the trial begins. Cockers not listed on an award sheet will not be considered.

#### **“AJ Award”**

(Classes Thursday)

This award is offered by the Cocker Spaniel Club of Rhode Island for Olga Evelyn and Rosemary Collin in memory of Amunique Sir AJ Donohue Louis. A plaque displaying the likeness of the original AJ Trophy, an attached frame for the winner's photo, a neck rosette, and \$200 will be awarded to the cocker who accumulates the highest number of MACH points on the Cocker Only Day of the agility trial held at the ASC Cocker Spaniel National. Qualifying points are from the Standard and/or Jumpers Master Classes.

#### **“The CCCC Award”**

(Classes Thursday-Saturday)

This award is offered by the Capital City Cocker Club to a Cocker Spaniels under the age of 7 showing at the Masters level in Standard, Jumpers and Premier over the first three days of the ASC Cocker Spaniel National agility trial. The winning score will be calculated based on MACH points earned in each regular class, plus 5 additional points for a double qualifying score. Premier points will be calculated in the same fashion, but with 10 additional points awarded for a qualifying score in both Standard and Jumpers. Cockers in both regular and preferred classes are eligible, but the Preferred competitors will be scored using the same course time as the regular classes. The winning Cocker and handler will receive a statue trophy with an engraved plaque.

#### **“The Bailey Award of Agility Excellence”**

(Classes Thursday-Sunday)

This award is offered by Vivian Hudson (Bar - Bax Cockers) in memory of Bailey (MACH16 Bar - Bax's Makin' New Waves, CD, MXB5, MJS5). A crystal trophy, ry and rosette awarded to a Cocker Spaniel 7 years or older showing in both Master Standard and JWW classes

(Preferred cockers are not eligible) who accumulates the most points during the total days of the ASC Cocker Spaniel National agility trials. Points are accumulated by calculating each MACH point earned (points under course time) and 10 points per Double Qualifying score per day.

### **“The Star Premier Award”**

(Classes Friday-Saturday)

This award is offered by Sylvia Martinez in honor of Star (MACH2 St. James Bright Star Angel, MXC, MJC, MXP, MJP2, MXF, T2B3). A trophy and rosette will be awarded to a Cocker Spaniel who is entered in all Premier classes (regular or preferred) during the days of the ASC Cocker Spaniel National. The winning score will be calculated based on MACH/PACH like formula of points (i.e. points under course time). Cockers in both Regular and Preferred classes are eligible, with Preferred dogs being scored using the same course times as the Regular dogs. If there is a tie with full points, the winner will be determined by utilizing the fraction of seconds of a MACH/PACH point (i.e. the lowest fraction of dog's total time is winner; 40.20 wins over 40.30 seconds).

### **Entering a Mixture of Regular and Preferred Classes**

#### **Within the Same Trial Weekend**

#### **Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

#### **Fix and Go On (FNG)**

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

#### **For Exhibition Only (FEO) – IS being offered in all classes at this trial**

For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.

FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler may declare the day of the show.

Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.

Dogs may be entered at any level (Novice, Open, Excellent or Masters) in FAST, JWW or Standard or in Premier classes. If a dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

Course time for FEO in Time 2 Beat, JWW, Standard, Premier & ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations.

FEO runs will scored as 'absent' in catalog and results.

Exhibitors must exit the ring when the horn sounds.

### **PURINA and/or ASC GUIDELINES AND RESTRICTIONS**

(for other guidelines/restrictions see the ASC Show Premium)

Purina Farms and the American Spaniel Club have placed the following guidelines and restrictions in place for the 2026 ASC National Cocker Spaniel Specialty. Anyone planning on attending this event will be required to comply with the following:

It is the responsibility of each exhibitor to ensure they carry proof that each dog in their possession is properly vaccinated, and each is healthy and showing no signs of illness (e.g., coughing) before arriving onsite at Purina Farms.

Day crating for Agility exhibitors will begin at 3:00 on Wednesday and is adjacent to the Agility ring in the main show arena. Day crating for Obedience/Rally (if needed) will be located near the obedience/rally rings.

The Conformation, Agility and Obedience/Rally rings will be laid out approximately the same as they have been for previous ASC National Specialty shows.

FOOD/DRINK: The Café will be open.

RESTROOMS: Attendees may only use restrooms on the main floor of the Purina Event Center. Restrooms on the upper level are restricted for use by Purina staff only.

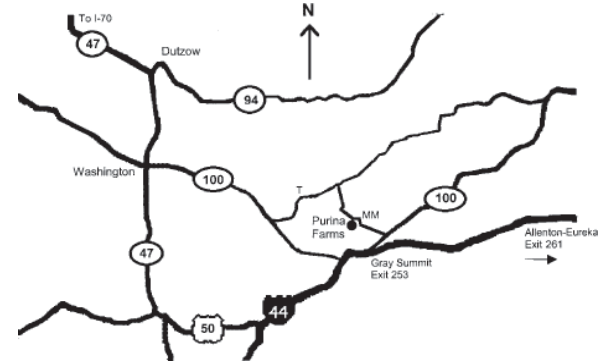

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
