## **RV Hookups**

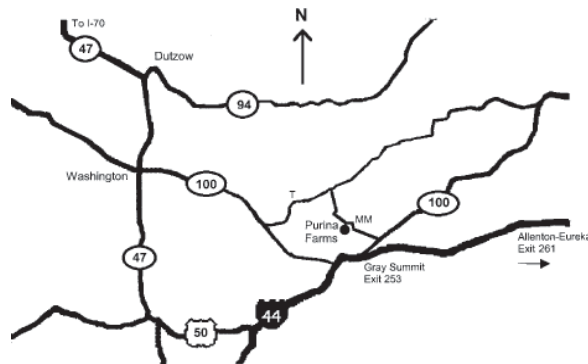
Coordination of the RV parking will be done through the Purina Farms Events Center. Purina Farms offers two different RV lots on property. The Full Service Purina Event Center RV lot offers water and sewer, as well as 30 and 50 amp electric. The electric only Main Show Field RV lot offers 30 and 50 amp electric. Spaces are assigned first come, first served. See the Purina RV Map if you want to request a specific spot. There is a nightly charge of \$40 in the Full Service Purina Event Center Lot and \$25 in the Electric Only Main Show Field RV Lot.

Reservations need to be paid in full within 2 days of receiving a confirmation email. Full payment by credit card must be received before the space can be confirmed and finalized. Credit cards only.

## **Routes to the Show Site**

**From North/East/South:** Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately 0.5 mile, turn left on MM at gas station. Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.

**From West:** Take I-70 to Hwy 47, Exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit to Gray Summit. Follow directions above.
