### **Hotel/Dog Show Guidelines**

When you sign the show entry form, you automatically agree to the following terms concerning motels. They have been established for the good of all exhibitors and will ensure future use of these facilities.

- 1. Maximum dogs per room vary per hotel/motel.
- 2. Dogs left unattended in a guest room MUST be in a crate. Plastic sheeting MUST be under each crate in the guest room.
- 3. Hotel guests with dogs in the room need to use the special door hanger provided by the hotel. This hanger will leave instructions to the housekeeping staff. Housekeeping will not enter the room unless the door hanger is present.
- 4. Housekeeping must be allowed to INSPECT a guest room (with dogs) daily. Guests who have special request (e.g. a certain time of the day that room will be vacant) can discuss them with the housekeeping staff upon arrival.
- 5. Bathing and/or grooming of dogs in or outside the guest room is not allowed.
- 6. The individual guest will be responsible for any damages to a guest room or any hotel property. This includes, but is not limited to replacement cost of carpeting if odors or stains cannot be removed by traditional cleaning methods. Damage claims must be settled on the spot.
- 7. Dogs are to be on leash at all times when out of the guest room.

Or, examination to determine that she is in season is performed by the National Trials Chairman, the Assistant Nat'l Trials Chairman, The Obedience Trial Chairman or the Agility Trial Chairman, within the same time constraints as mentioned above.



The conformation and bone structure of the Shetland Sheepdog is important to the performance handler. Does your Sheltie have a proper front and rear? Do you struggle with the concept of straight shoulders? Don't get confused when you hear the word "conformation", it is not just an event, it is the structure and the most important thing you will ever learn about your dog.

The front, consisting of the shoulders and the front legs, provides the lift, the direction and the landing. The rear, consisting of the back legs and pelvic area, provide that forward movement. Join us for a hands-on evaluation into the importance of the structure when picking your next performance puppy. If you struggle with the concept of straight shoulders, the hands-on approach might clarify it for you. We will be looking at how the front-end assembly balances the rear, and how that impacts your performance sport.

Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class but do not receive the participation point as well. The Participation point in performance events is awarded only if the dog competes but does not qualify in the event. Dogs competing in multiple classes at the same event will be credited with the highest placement received in any one class.

Dogs that make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable to the award, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same two points as dogs that make one cut. Dogs excused from the breed ring shall still be awarded a point for participation. Dogs disqualified from the breed ring shall not be awarded a point for participation.

Preferred agility classes are scored equally to the corresponding regular agility class. Non-regular obedience classes are scored as the regular class with similar or next lower difficulty level. For example, Veterans obedience qualifying score is worth 2 pt. because Novice exercises are used. Beginner Novice qualifying score is worth only the one point for participation because exercises are less difficult than Novice.

Partial points will not be awarded. In the event of a tie, event scores shall be used to break the tie. The dog with the highest total score will receive the award. The official catalog markings taken from the judges' books. for each event shall be used to determine eligibility, participation, placements and official scores.

#### Bonus Point: 1 pt. — Dog competes in ALL 5 venues

Note: Herding Instinct Evaluation is not included in this award and will not be awarded a participation. Note: Agility Premier classes will not count toward Best All Around Sheltie Points.

### NOTICE TO ALL EXHIBITORS



The AKC will collect a \$3.50 AKC Recording Fee for each entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees will be collected on each entry.

- Please note: Rally is considered a separate trial from obedience.
- At every licensed or member club Rally Trial, a Recording Fee of \$3.50 shall be required for the entry of each dog. (AKC Rally Regulations, Chapter 1, Section 3).
- A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- Canadian Exhibitors must submit entries with checks drawn on U.S. Accounts or with international money orders in U.S. funds.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or agents of Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, E-mail and



#### Class Changes Effective January 1, 2021

# Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2021, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1<sup>st</sup> run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

#### Fix and Go On (FNG)

As of January 1, 2021, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

  disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show
  site. In such cases, no refund of any fees will be made.
- All dogs present must be held on leash or confined to their crate at all times except when in the ring or when in the designated agility warm-up area. The site will be monitored and offenders will be asked to leave. In such cases, no refunds will be made.
- We ask for the cooperation of exhibitors in helping to keep the location as clean as possible in order for us to retain the use of the facility in the future.
- A return check fee of \$25.00 will be added for each check returned. Subsequent returned checks from the same exhibitor may result in entries only being accepted on a C.O.D. basis.
- No refund for duplication of entries.
- Exhibitors must be governed by any rules or regulations of civil authority, building and parking restrictions. Vehicles parked contrary to regulation will be subject to towing at owner's expense.
- Dogs under six months of age are prohibited at AKC events.
- Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of
  internal and external parasites, any communicable diseases and have appropriate
  vaccinations.

### AGILITY

There will be <u>NO early crating on Thursday</u> due to outside crating (Grass Area outside Arena). Please bring your pop-up tents if you would like cover. All crating will be available Friday morning at 7am!

### **Dogs Eligible to Enter**

This trial is open to **Shetland Sheepdogs only** over the age of 15 months that are registered with the American Kennel Club or that have AKC ILP/ PAL numbers. Bitches in season may not compete. Handlers in each class may walk the course without a dog prior to the start of the class. A warm-up area, consisting of a regulation agility jump will be provided.

Dogs may be moved up to a higher class at the request of the owner, provided that the request is made in writing to the Trial Secretary no later than Monday, April 12, 2021 before 5:00 pm CST.

#### **Height Divisions**

Owners are responsible for entering the proper height divisions. Handlers may opt to run at a higher division. Dogs that run in a height division lower than their proper height division will be eliminated.

FREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- . The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vígorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- · Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
