- If you would like confirmation that your entry was received before the trial has closed please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. Please check your entries!

#### "After Closing" Waiting List

A waiting list (30 run per maximum each day) will be maintained for these trials once they have closed at 6:00pm CT on **June 9**. The waiting list will be active until its deadline – Monday, **June 21** at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the runs. Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

#### **Class Description**

#### <u>Move-ups</u>

For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, June 21, 2021. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday, respectively and must be submitted at the trial.

#### Trial Information

Trial Hours are 7:00 am to 30 minutes after the completion of the trials. Ring size: 100' X 90' The building is climate controlled. Exercise pens are not allowed. There is plenty of crating on concrete around ring. **Ground Covers (ie: tarps, crate mats, towel) are required under all crates.** For the safety of everyone, all covers must be completely under your crates. Personal chairs will be allowed in the building. Flexi-leads will not be allowed in the building. Battery operated fans are welcome. Dogs may not be left in the building overnight. Please bring crates, water and clean up after your dogs. Setup time will be announced after closing.

## Dogs Eligible to Enter

These trials are open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registrations, or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds. Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

## Change of Entry

- As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is The safety of the dogs is our primary concern. entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, after the close of entries a dog may be moved down in their class level (ie Master to Excellent). The request for the move to the class for which the dog is eligible must be in Entry fees will not be refunded in the event that a dog is absent, disgualified, excused, or writing and submitted to the superintendent or the trial secretary at least 30 minutes prior to the start of the trial.
- After the close of entries, a dog may be moved down in their class level (ie Master to Excellent). The request for the move to the class for which the dog is eligible must be in to the start of the trial.
- If a VMO or Field Representative measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run in any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Bitches in season are not allowed to compete in AKC Agility Trials. # Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

## Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial dav.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

## Fix and Go On (FNG)

As of January 1, 2020. Fix and Go On will be offered on a one-year pilot basis in order to Exhibitors may wear shirts or insignia of their training group if they wish. give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle and then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying Exhibitors are responsible for cleaning up after their dogs(s). Any exhibitor failing to do so score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

#### Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. Contacts are rubberized.

#### Notice to Exhibitors

- By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- barred from competitions by action of the Event Committee.
- Entry fees will not be refunded if the trials cannot open or complete by reason of riots, civil disturbance, fire, and act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- writing and submitted to the superintendent or the trial secretary at least 30 minutes prior. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
  - come in season and injured dogs after the closing date, will receive a refund minus \$15 per day. The Trial Secretary must receive written refund request including a veterinary statement by letter hand-delivered, emailed, or postmarked before the trial commences.
  - People who are experiencing COVID-related symptoms, are self-guarantining or are involved in contact tracing for COVID exposure will be given a refund less \$15 per day. To receive a refund, you must contact the trial secretary 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.
  - All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee. No refunds will be issued for overpayment of less than \$10.

- Checks for canceled entries will be shredded; no check will be returned.
- Owners are responsible for errors in making our entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Failure to be at ring gate could result in the exhibitor being marked absent.
- Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC title on entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the It is the option of the club to allow day-to-day move-ups. Exhibitors should refer to a Time 2 Beat and FAST classes, FEO will be of value to new exhibitors or exhibitors that are club's premium list to verify the club's policy for moving a dog up. If offered, dogs shall be having difficulty with a specific obstacle and/or ring environment. Competitors must enter in moved up to a higher class at the request of the owner, as a result of the dog qualifying for T2B and/or FAST. Participation in FEO is non-gualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date. pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible . jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the . dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be • declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring .
  - Toys must be non-audible
    - Toys may not leave the handler's hand
  - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time .

#### INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by *a* Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, t may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the ace of this form, what is the relationship of the Junior Handler to the Owner?

# <u>CORONA VIRUS</u> \* \* <u>Notice to Exhibitors</u> \* \*

Due to the state of Illinois guidelines pertaining to COVID-19, the following rules and procedures will be in place during the entirety of the trial.

The number of people allowed in the building will be dependent on the current state and local policies. There will be no outside spectators. The only individuals allowed in the building are volunteers, handlers, owners, co-owners, and parents of junior handlers.

There will be TWO entrances/exits to the building: the Entrance/Exit in the front of the building and one entrance and one exit in the back.

Crating will be pre-assigned. After closing, a crating signup link will be sent to exhibitors to allow them to choose their crating spaces. Personal chairs may be brought into the building. Chairs must fit into the crate space. No extra chairs for spouses or extra owners will be allowed in the crating reservations unless there are available spaces. There will be no sharing of open chars at this time.

We will be using swing gate for ring entry and exit.

There will be a 6' boundary around the gate steward. Only the gate steward will be allowed to check dogs in, move, etc. There will also be 6' boundaries around the timer, scribe, trial secretary and awards table. Please respect these boundaries and practice social distancing.

Masks/facial coverings (which you are to provide) will be required while in the building INCLUDING during your run.

A leash runner will be provided. The leash runner will use a "grabber" to move the leashes. You may choose to wear your leash or put it in your pocket per AKC rules.

No printed course copies will be distributed. Course maps will be posted inside the building. Course maps will also be posted at <u>www.mickys-secretary-service.com</u> the night before each trial. The running order, judges briefing, trial chair briefing and results will also be posted at this site.

If you park your vehicle in the back of the building you will not be allowed to run your engine.

There will be no hospitality room. All food must be consumed outside of the building. Please do not bring any snacks or MACH/PACH cakes to share.

Our awards chairperson will prepare ribbons and awards after the completion of the class. NO SELF-SERVE.

People who are experiencing COVID-related symptoms, are self-quarantining or are involved in contact tracking for COVID exposure will be given a refund less \$15 per day. To receive a refund, you must contact the trials secretary 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.
