All entries must be submitted on official AKC entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable. If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard. Entries cannot be changed once the trial has closed.

Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog’s physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word “dog” is used in these regulations, it includes both sexes.

Pre-Order Catalogs

Catalogs may be pre-ordered at \$5.00 per catalog. Please include payment with your entry fees. Catalogs must be pre-ordered.

Waiting List

The trial will have a waiting list in the event the limits are reached prior to closing.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely. Missouri Rhineland Kennel Club may cancel this event in extreme weather conditions. Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Since bitches in season are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. Missouri Rhineland Kennel Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete back of form. Include only AKC titles on entries. All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked. Owners are responsible for errors in making out entry forms, whoever may have made such errors. Dogs under 6 months of age are not permitted on the show grounds of AKC events. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations. Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee. No refunds will be issued for overpayments of less than \$10. Exhibitors are responsible for cleaning up after their dog(s) at the show site and at all hotels, motels, and campgrounds where they are staying while competing in these trials. Missouri Rhineland Kennel Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event. Missouri Rhineland Kennel Club, its Board and Members, and Nestlé Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

NO SMOKING or VAPING is permitted in Purina Event Center. Weapons of any kind, illegal drugs and fireworks are not permitted on the premises. The arena is air-conditioned with indoor restrooms. Please bring crates and water for your dogs and clean up supplies. Ex-pens are permitted. **ALL CRATES MUST BE ON A MAT.**

All dogs must be on leash held by an exhibitor or crated at all times except when in the ring. Warm-up must be done on lead. No Flexis leads allowed.

Trial Information Setup information will be sent after closing Trial hours are 7:30 am to 30 minutes after the trial in completed. Trials will be held consecutively on Friday and Saturday. Please bring crates and water for your dogs and clean up supplies. No outside food or beverage is allowed on Purina Farms property. Violators will be reported to the AKC. No exhibitors shall be in the building before or after show hours.

Routes to the Show Site

From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately 0.5 mile, turn left on MM at gas station. Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.

From West: Take I-70 to Hwy 47, Exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit to Gray Summit. Follow directions above.

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

Purina Farms Overnight Camping Reservation Request Form

Thank you for your interest in reserving an RV space at Purina Farms. Check-in time is 3p.m. on the arrival date shown on your reservation confirmation and check out time is by 11a.m. on the departure date shown on your reservation confirmation.

Purina Farms offers 2 different RV lots on property. The Full-Service Purina Event Center RV lot offers water and sewer as well as 30 and 50amp electric*. The Electric only Main Show Field RV lot offers 30 and 50amp electric.

Quiet time in the RV area is from 11:00PM to 6:00AM. Any RVs arriving between these hours will be placed in a holding lot until after 6:00AM when they can then move to their designated spots or after 3:00PM depending on when designated arrival date on the reservation.

Day camping is available in 3 different designated lots on property. Spaces are limited and are available on a first-come; first-served while there is still availability. Day campers must vacate the lots by 11p.m. on the same day of arrival. Day campers do not need a reservation, but they must be represented on a Club guest list, abide by all guidelines and be entered/participating in an event on property.

RV reservations for the MO Rhineland Kennel Club Obedience, Rally, & Agility Trials must start no earlier than July 1, 2021 and must end by July 5, 2021. Please email this request form to rvparking@purina.nestle.com by June 17, 2021. All requests must be RECEIVED by June 17, 2021 in order to be considered.** Again, there is a nightly charge of \$40 in the Full Service Purina Event Center Lot* and \$25 in the Electric Only Main Show Field RV Lot. Reservations need to be paid in full within 2 days of receiving a confirmation email. Full payment by credit card must be received before the space can be confirmed and finalized. Credit cards only.

** Water is not available in the Full Service Purina Event Center RV lot from November 1 through April 14. Due to this, the nightly fee in this lot is reduced by \$5.*

Overnight Camper Information at Purina Farms

Thank you for requesting an overnight camping space in one of the Purina Farms designated RV lots. Our RV Engagement Specialist will respond back to your reservation request within 3-5 business days to let you know whether your reservation is confirmed. Reservations are taken on a first-come; first-served basis and are assigned based on length of equipment (rig) and space availability. If confirmed, you will receive an emailed confirmation that must be shown upon arriving at the front security gate at Purina Farms. You will also receive instructions on how to pay for your space. Full payment by credit card must be received before the space can be confirmed and finalized. Credit cards only.

Check-in time is 3p.m. on the arrival date shown on your reservation confirmation and check out time is by 11a.m. on the departure date shown on your reservation confirmation.

Any RVs bigger than 50' must reserve a spot in the full-service Purina Event Center lot. Max size of RV on property is 55'. Tow vehicles are not factored into the length of the spaces as they must be unhooked.

Spaces are refundable if cancelled more than 7 days out from the arrival date listed on the reservation confirmation. Otherwise, no refunds will be given. Spaces are non-transferable.

Please note that RV reservations are only accepted for those entered (or those who have dogs/cats entered) in an event that has contracted space which includes the overnight camping lots. Upon request, participants must be prepared to show proof of event entry upon arrival at Purina Farms.

The Purina Farms RV lots are only open to vehicles specifically designed with overnight sleeping accommodations including motorhomes, fifth wheels and travel trailers.

RV rental reservations must terminate Mon-Saturday. Rental providers won't pick up or drop off on Sundays. Rentals may be ONLY be moved by the rental companies. Plan accordingly with the supplier if you have reserved more than one space during your stay.

Any false or inaccurate information provided when booking a reservation will result in the reservation being null and void with no refunds given.

ADDITIONAL SPECIFIC EVENT PROCEDURES DURING COVID - KNOW BEFORE YOU SHOW OR GO

PARKING/ENTERING/EXITING

- Staggered show and trialing times for exhibitors to alleviate congestion at the front gate, entrance into the facilities and entering and exiting the rings.
- Pre-registered guests and exhibitors only. No spectators*. For shows and trials, clubs and/or superintendent/trial secretary will capture names of all guests prior to the event and provide the list to Purina Farms.
- Security will issue wristbands to guests who pass the health screening each day. Colors will vary per day and per event. Screenings include a health questionnaire with questions related to guests and their dogs.
- Every other parking spot is marked off to allow for social distancing between vehicles (this does not apply to the RV lots). This practice will be phased out by the end of April.
- Doors on both the North and South sides of the facility serve as designated entrances and exits to allow entering and exiting from both the North parking lot and the South RV lot. A stanchion is set up in between the double doors to keep guests separate. The East and West doors of the facility will not be accessible.
- A security officer or Purina Farms team member is staged at each entry/exit door with radios and tablets to keep in contact and work together to keep an accurate count and to regulate capacity.

* Limited to exhibitor and essential person (ppl) accompanying exhibitor who is involved in the showing/handling of the dog or those involved in organizing the event. All must appear on the guest list provided by the hosting Club
