Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Waiting List

This trial will have a waiting list in the event the limits are reached prior to closing.

<u>Transfers</u>

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely.
- Tri-County Agility Club of Missouri may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- <u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked <u>before the trial commences</u>.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. - All dogs must be on leash or crated at all times except when in the ring.
- Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. Tri-County Agility Club of Missouri has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and <u>must include the signed Agreement</u> <u>and Rules</u>. <u>Junior Handlers</u> must complete back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety your are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 inches, over 13 in., but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles); Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been made to AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All American Dog/Mixed Breed". Sire and Dam information shall remain blank for mixed breed entrants.

Current Guidelines for Tri County Agility Club Obedience and Rally Trials to be held July 16-18, 2021

Please bear with us as some of these may change as the trial gets closer. We will keep exhibitors updated if we make changes.

General

- 1. Everyone MUST wear a mask at all times when in the building. Including in rings.
- 2. Social distancing will be enforced
- 3. One person in the bathroom at a time.
- 4. Check in for all classes: We will have tables set up that will have the numbers spread out on it (Not stacked). There will be several postings that show exhibitor name and number so exhibitors can look to see what their number is if they do not remember.
- 5. Gate steward will be set up by the area where the turf and mats meet. They will be the only ones that can touch the pen. Gate stewards will also be in charge of the flow to and from the turf area.
- 6. Two of the four rings will be warm-up areas, one person in warm up ring at a time. The warm-up area will be the about 1/3 the size of a normal ring. **There will be no warming up anywhere else inside the building**. Only one dog in each warm-up area at any time.
- 7. The only dog and handler(s) that will be allowed in the middle area between rings will be the next one getting ready to show in the ring and those leaving the ring.
- 8. The obedience and rally rings will be diagonal from each other.
- 9. Placement Ribbons will be handed out by the judge. The green ribbons will be on the table for individuals to pick up. Placement ribbons will be in or on a container for the judge to retrieve.
- 10. Judges will have to take the paperwork to the Trial Secretary. There will be a box for the judge to put their paperwork in that will be near the Trial Secretary computer. No one will be allowed in the six-foot bubble around the secretary except judges.
- 11. Crating will be spread out. No chairs next to crates and no chairs next to each other.
- 12. NO lunch will be served. The club will order in food for the judges.
- 13. The club will take everyone's temperature each day and will issue a wristband to wear and show to enter the building. If exhibitors, judges or volunteers feel sick the morning of the trial they are asked not to come. We will give a refund to exhibitors for all but \$15 per day if you are not able to attend because of feeling ill. Exhibitors need to let the trial secretary know ½ hour before the trial starts to receive the refund. If you come and your temperature is to high you will not be allowed in and your entry fee will not be refunded.
- 14. The number of entrants will dictate how many people will be in the building at any given time, we will try to have no more than 50 people in the building at any time. This will include workers, exhibitors and judges. The number of people allowed in the building will be in accordance with Local, State & Federal laws.
- 15. There will be no outside spectators **only** exhibitors and volunteers will be allowed in the building.
- We will announce approximate start times for each class after closing. Exhibitors will not be allowed in for their class until approximately 15 minutes before their posted start time.
- 17. The entrance and exits will be clearly marked. DO not leave by the entrance.
- 18. Fees are as follows if your dog has an accident on the turf at Westinn:
 - a. \$20 for urination
 - b. \$30 for defecation
 - c. \$50 for loose stool or vomiting

Handlers will be responsible for these fines.

Obedience

- 1. We will be not be using ring stewards for posts. We will use tomato cages.
- 2. We will have tongs that will be wiped after each dog. The tongs will be used to put all articles out and gloves.
- 3. Handler will put leash on a holder at a designated area set by the judge.
- 4. We will only run one obedience class at a time since we will only be using one ring for obedience.

<u>Rally</u>

- We will use plastic containers for the handler to drop the leash into at the start. The container will then be put on a chair near the exit for the handler to retrieve the leash. The steward will never touch the leash - only the handler. There will be two containers and they will be wiped out after each dog by ring steward.
- 2. There will be NO maps. There will be several posted on the walls. Please do not gather around. Bring a phone to take a picture.
- 3. The table steward will have to take the scores down to the gate steward probably two at a time.
- 4. The table steward and the judge will be the only people at the ringside table.
- 5. The table steward, ring steward, or the leash runner will also serve as the timer.

As the exhibitor or guardian of a minor I have read all of these precautions and will adhere to them. If I do not adhere to the above guidelines, I will forfeit my entry fees and will be asked to leave and not return.
