Entries must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for delivery services, if applicable. No FAX entries accepted.

All entries must be submitted on official AKC entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. **Please check your entries.**

Liability

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. PWCCA or AKC and its agents and employees, as well as the facility owners and livestock handlers, will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, & further assume no responsibility for injury to children.

Site Information

This event is being held at a working farm. Please close all latches and gates. **Exhibitors MUST clean up after their dogs and themselves!** Morning coffee/snacks will be available; donations are appreciated. Lunch will be available only by reservation, see lunch order form for more information.

Dogs **MUST** be confined in vehicles or crated. Crates/ex-pens need to be placed only in the areas designated by the Trial Committee. Dogs should be leashed when not in the arena. Flexi leashes are not allowed. Bring your shade tents, chairs, water and rain gear.

All sheep trial classes will be in a 135'x235' arena. A course duck classes will be in a 50'x100' arena. B course outruns will be 60 feet for Started, 75 feet for Intermediate and 100 feet for Advanced. HT will be in a 100'x100' arena, PT in a 100'x200' arena.

Move-up requests need to be given to the Trial Secretary at least 30 minutes before the start of the day's test/trial. If there are Alternate entries, all alternates must report to the Trial Secretary before the start of the day's classes. If you do not, your spot may be given to an alternate in an earlier class.

Bitches in season will run last in the Test classes and in catalog order in the Trial classes.

HERDING HIGH IN TRIAL CHALLENGE TROPHY- GCh DC SUA MAH BEACH BOY HXAsdc HXBd CHALLENGE TROPHY ("The Wilson"), a bronze sculpture of a Pembroke Welsh Corgi atop a walnut base with three bronze reliefs each with a Pembroke, one with a cow, one with ducks and the other with sheep. The challenge trophy has been donated by Mary Ann Wehmuller and Judy Hart in honor of DC Wilson. For permanent possession, this trophy must be won three times by the identical owner(s), not necessarily with the same dog. At least one of the wins must be from the Intermediate or Advanced classes. The trophy will remain in the possession of the club until it is won outright. A rosette and 10" Pewter Apple Bowl will be awarded to the winner.

IN HONOR OF REBA CHALLENGE TROPHY, A bronze study of a Pembroke Welsh Corgi herding sheep mounted on a wood trophy base. Originally donated by Judy Garbarino - Pokies Country Kennel to be awarded to the High Combined qualifying score (all stock, all courses, all days, with at least two qualifying scores being on different stock) winner at the PWCCA National Specialty Herding Trial, in honor of WTCH HTCH HC Pokies Country Gal, HXAsdc HRDIII HTADIII NAP NJP CD TD, "Reba". Retired in October, 2016, by DC Caamora Aston Martin, HSBd HSAc HXAsd BN, "Speed," the Reba Challenge Trophy was re-donated by Vicki Northway, Drifan, and Patricia and Dennis Seifert, Caamora. Commencing with the 2017 PWCCA Herding Trials, competition for the retirement of this trophy will begin anew and must be won three

[3] times by the identical owner(s), not necessarily with the same Pembroke. A wooden plaque, donated by Pokies Country Kennel, or Drifan Kennel and Caamora Kennel, will be given each year to the winner of the "Reba" trophy to commemorate their win.

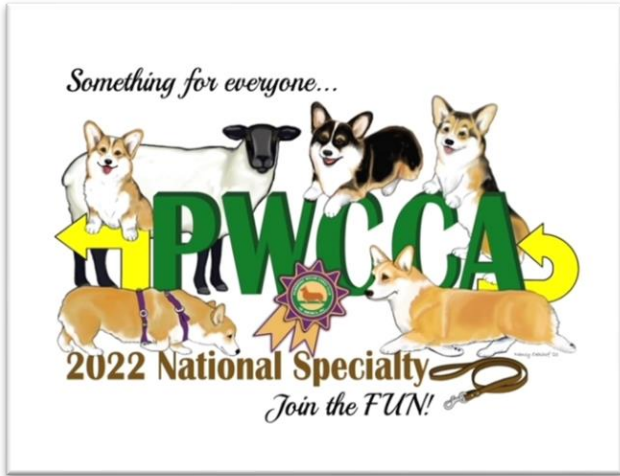
