Paper entries received within the first 24 hours must include postage or be metered and must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for delivery services, if applicable.

Limit of 10 dogs per envelope. No hand deliveries can be accepted in the first 24 hours. No FAX or emailed entries accepted.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable and will be returned.

If you would like confirmation that your entry was received before the trial has closed please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. Please check your entries!

Online Entries

This trial is accepting online entries through **LabTestedOnline.com**. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be 175 runs online (50%), 175 runs paper (50%) each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one. Coupons or vouchers will be accepted for mailed entries only and cannot be used for online entries. PLEASE CHECK SECRETARY WEBSITE FOR WAITLIST AND RUN AVAILABILITY LabTested in an on-line ENTRY SERVICE only.

"After Closing" Waiting List

A waiting list (50 run per maximum each day) will be maintained for these trials once they have closed at 6:00pm CT on **June 5.** The waiting list will be active until its deadline – Monday, **June 17** at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the runs.** Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Move-ups

For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, June 19, 2023. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday, respectively and must be submitted at the trial.

Trial Information

Trial Hours are 7:00 am to 30 minutes after the completion of the trials.

Ring size: 100' X 90'

The building is climate controlled.

Exercise pens are not allowed. There is plenty of crating on concrete around ring.

Ground Covers (ie: tarps, crate mats, towel) are required under all crates. For the safety of everyone, all covers must be completely under your crates.

Personal chairs will be allowed in the building.

Flexi-leads will not be allowed in the building.

Battery operated fans are welcome.

Dogs may not be left in the building overnight.

Please bring crates, water and clean up after your dogs.

Setup time will be announced after closing.

Dogs Eligible to Enter

These trials are open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registrations, or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds. Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is Fix and Go On is not pre-entered; rather, it occurs during the course of the run. entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, after the close of entries a dog may be moved down in their class level (ie Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or the trial secretary at least 30 minutes prior to the start of the trial.

After the close of entries, a dog may be moved down in their class level (ie Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or the trial secretary at least 30 minutes prior to the start of the trial.

If a VMO or Field Representative measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run in any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement form when requesting the class change.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

For Exhibition Only (FEO)

For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes Participation in FEO is non-qualifying.

FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.

Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.

Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

(Note to Trial Secretaries – the above line has been updated to match the regulations. It had said: "The exhibitor must declare FEO in the ring prior to leading out.

FEO will be offered at this trial in all FAST & T2B classes

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. Contacts are rubberized.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge All dogs competing in agility must possess an official AKC Jump Height Card. You are not familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or http://www.akc.org/events/agility/jump_height_card.cfm barred from competitions by action of the Event Committee.

Entry fees will not be refunded if the trials cannot open or complete by reason of riots, civil disturbance, fire, and act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Bitches in season are not allowed to compete in AKC Agility Trials. Refunds for bitches that come in season and injured dogs after the closing date, will receive a refund minus \$15 per day. The Trial Secretary must receive written refund request including a veterinary statement by letter hand-delivered, emailed, or postmarked before the trial commences.

People who are experiencing COVID-related symptoms, are self-quarantining or are involved in contact tracing for COVID exposure will be given a refund less \$15 per day. To receive a refund, you must contact the trial secretary 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee. No refunds will be issued for overpayment of less than \$10.

Checks for canceled entries will be shredded; no check will be returned.

Owners are responsible for errors in making our entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Exhibitors are responsible for being at the ring gate when it is their turn to run. Failure to be at ring gate could result in the exhibitor being marked absent.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC title on entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors may wear shirts or insignia of their training group if they wish.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Exhibitors are responsible for cleaning up after their dogs(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of the requirement.

Electronic timing will be used at these trials.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height livision for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular ump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of ecord, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partnerssm program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, t may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
