

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Paper entries received within the first 24 hours must include postage or be metered. Entries must be delivered by multi-state or multi-national postal or carrier service, including but not

limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for

delivery services, if applicable. No FAX entries accepted.

Limit of 10 dogs per envelope

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. Please check your entries.

Online Entries: This trial is accepting online entries through LabTestedOnline.com. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be 150 runs online (50%), 150 runs paper (50%) each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one. Coupons or vouchers will be accepted for mailed entries only and cannot be used for online entries.

From June 17th to July 1st, Standard Schnauzer & Giant Schnauzers will have priority into this trial. All other breeds received during this time will be kept in the order they were received. After July 1st, if the trial limits are not met with Schnauzers, all other entries will be processed in the order in which they are received.

Move-Ups

Dogs may be moved up at the request of the owner as a result of qualifying for an agility title, provided that the request is made to the Trial Secretary in writing. (E-Mail is acceptable) All moveups must be received by the Trial Secretary no later than Wednesday, August 14th, 2024 at 6PM CT. Day-to-day move-ups over the weekend will be accepted but must be made to the Trial Secretary no later than the day preceding the event (by the end of that days trial).

No moving down or changing or height after closing except as specified in Chapter 1 Section 21 of the AKC Regulations For Agility Trials.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification had been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

"After Closing" Waiting List

A waiting list (50 run maximum each day) will be maintained for these trials once they have closed on August 7th 2024. The waiting list will be active until its deadline – Wednesday August 14th, 2024 at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the runs. Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A <u>separate entry form must be submitted</u> when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

The Fix and Go On changes have been made a permanent regulation.

For Exhibition Only (FEO)

For Exhibition Only will be offered all days at this trial.

Prizes and Awards

Ribbons will be awarded for First through Fourth place in all divisions. In T2B only 1st place will be awarded for each height.

Qualifying Ribbons will be awarded to all dogs receiving a qualifying score.

(Dogs must qualify to receive placements and awards)

Wednesday & Thursday Special Awards

Special prizes will be awarded for High in Trial and High in Trial Preferred Giant Schnauzer.

Prizes will be awarded for placements in all regular classes.

Wednesday's SSCA Agility trial will be supported by GSCA as the Southern Regional Agility Trial. Thursday's SSCA Agility trial will be supported by GSCA as the National Specialty Agility Trial.

Friday Special Awards

Special prizes will be awarded for High in Trial and High in Trial Preferred Standard Schnauzers.

Prizes will be awarded for placements in all regular classes.

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions. Judge reserves the right to measure dogs entered in the trial. Handlers may opt to run in a higher height division in the Regular program, but not in a lower division than their proper height division. Handlers must run in their proper height division in the Preferred program. Height divisions are as follows:

AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs except those jumping 24" without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run. You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form if your dog needs to be measured. For more information please visit: http://www.akc.org/events/agility/jump height card.cfm

Routes to the Show Site

From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately 0.5 mile, turn left on MM at gas station. Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.

From West: Take I-70 to Hwy 47, Exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit to Gray Summit. Follow directions above.

Notice to Exhibitors

- THE SAFETY OF DOGS is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- TELEPHONE, FAXED, INCOMPLETE AND UNSIGNED ENTRIES cannot be accepted.
- ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE. Unsigned entries or entries missing information other than the dog's call name will be returned.
- **ERRORS ON ENTRY BLANKS** Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.
- **ENTRIES RECEIVED WITHOUT FEES** will not be accepted
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. Express mail entries must include signature permitting them to be left at the secretary's address without recipient's signature.
- ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of extreme weather, riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.
- JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The owner of each dog is solely responsible or having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. If handlers have a ring conflict and so inform the gate steward, every effort will be made to accommodate you.
- TRIAL COMMITTEE WILL NOT BE RESPONSIBLE for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.
- ALL DOGS MUST BE ON LEASH AT ALL TIMES EXCEPT WHEN IN THE RING OR IN THE DESIGNATED WARM UP AREA. Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show site. In such cases, no refund of any fees will be made. All dogs present must be held on leash or confined to their crates at all times except when in the ring or when in the designated agility warm-up area. All exhibitors must pick up dog waste everywhere on the show grounds AND HOTELS. The site will be monitored, and offenders will be asked to leave. In such cases, no refunds will be made.
- This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative
- Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive, blind or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.
- **OBSTACLES:** Obstacles will conform to the requirements in the current edition of the AKC Regulations For Agility Trials.
- COURSE FAMILIARIZATION AND TIMING: Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.
- BITCHES IN SEASON: Since bitches in season are not allowed to compete. There will be partial refund minus \$12.00 per day due to bitches which come in season after trial has closed, provided that the owner provides a veterinary statement to the trial secretary. All documentation must be received by the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

VOLUNTEERS! WE NEED YOU!

Agility trials cannot survive without volunteers. The Club appreciates everyone who can give of their time to help the trial run smoothly. Volunteer duties will not interfere with running your dog because you choose your own volunteer schedule. Volunteer Sign up boards will be available at the check in table.

Motel & RV Information

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Exhibitors must obey any motel rules regarding leaving dogs in rooms. Any damage to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitors entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
