#### **Notice to Exhibitors**

The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely.

Tri-County Agility Club of Missouri may cancel this event in extreme weather conditions.

<u>Entry fees will not be refunded</u> if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

<u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Since <u>bitches in season</u> are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked <u>before the trial commences</u>.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring.

<u>Exhibitors are responsible for being ready for judging when called to the ring.</u> The judge need not wait for any dog holding up a class. Tri-County Agility Club of Missouri has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and <u>must include the signed Agreement</u> and <u>Rules</u>. <u>Junior Handlers</u> must complete back of form.

All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

All dogs must be on lead or crated at all times. Warm-up must be done on lead.

Dogs under 4 months of age are not permitted on the show grounds of AKC events.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

<u>Exhibitors are responsible for cleaning up after their dog(s)</u> at the show site and at all hotels, motels, and campgrounds where they are staying while competing in these trials.

Tri-County Agility Club of Missouri does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Tri-County Agility Club of Missouri, their Board, Members, and Westinn Kennels and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

**NO SMOKING** is permitted in Westinn Kennels.

DOGS NOT OWNED OR HANDLED BY EXHIBITORS ARE NOT ALLOWED IN THE TRAINING ROOM AT THESE TRIALS.

All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested with Tri-County Agility Club of Missouri, or in persons to whom assignments of such rights have been made in writing by the Club.

#### Notice to Exhibitors (con't)

Photographs and/or video recordings taken for any reason other than personal use are strictly prohibited.

No SOLICITATION permitted on the trial site.

Use of laser pointers (or laser pointer type devices) prohibited on the trial site.

Set-up time will be announced in the confirmation information after closing.

Please bring crates and water for your dogs and clean up supplies.

No X-pens are allowed in the building.

No mats under crates.

Event Committee members may rearrange crates to maximize space if needed, including restricting placement of chairs in the crating area.

Bitches in season are not permitted on the trial grounds.

Rally ring size: 40' x 50'.

#### Awards

A qualifying score is required for all awards.

#### Ribbons/Rosettes

Rosettes will be awarded to all placements in the Obedience 'A' classes and Rally classes. Ribbons will be awarded to all placements in the 'B' classes and Optional Titling classes. Ribbons will be awarded to all qualifiers.

#### **Jump Height Order**

Obedience classes with jumps will be run tall-to-short.
Rally classes with jumps will be run tall-to-short all days.
Every effort will be made to accommodate handlers with multiple dogs in the same class.


#### Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

#### **Routes to the Show Site**

**From the West**: I-70 East to Exit 208. Turn right at the end of the ramp into roundabout, then immediately right again onto the South Service Road. Turn Left on Swantnerville Dr. (at First Bank Sign). WestInn Kennel is 500 feet down on the left.

From the East: I-70 West to Exit 208. Turn left at the end of the ramp, then cross bridge and at light turn right onto the South Service Road. Turn Left on Swantnerville Dr. (0.5 mi, at First Bank Sign). WestInn Kennel is 500 feet down on the left.



#### **Motel & RV Information**

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee.
