Move Ups:

Move Ups: For the Friday trial – move ups close at 6pm on Monday, May 18th. For the Saturday/Sunday trial: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial.

Measuring

Measuring: Judge Dan Wolfson is not a VMO. If your dog is under 2 years old and has never been measured, or if your dog has turned 2 years old and has not been measured – it needs to be measured before your first run of the day.

Crating

There will be set up at 6pm on Thursday ONLY for those who help with trial set up – no saving spots please.

Exercise pens are not allowed.

Ground Covers (ie: tarps, crate mats, towel) are required under all crates.

For the safety of everyone, all covers must be completely under your crates.

Personal chairs will be allowed in the building.

Flexi-leads will not be allowed in the building.

Battery operated fans are welcome.

Dogs may not be left in the building overnight.

Please bring crates, water and clean up after your dogs.

From South:

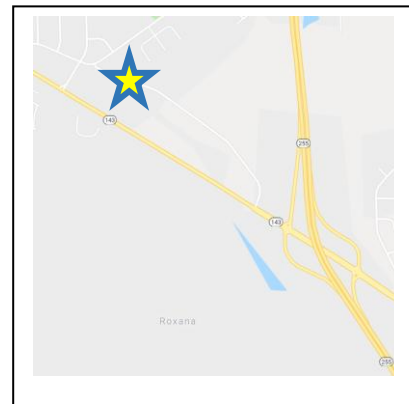

At the intersection of Shop N’ Save and Federico Car Dealerships, take a right at the light. Triune Canine Training and Event Center is located between the two Federico dealerships.
