Please do not put mats under your crate and / or chairs. Unentered dogs WILL NOT be assigned a space. If you bring unentered dogs, they MUST fit into your assigned space – be prepared to stack crates. If you are not entered on Friday, you will not be able to set up your crates until Saturday.

If you would like to crate out of your vehicle, you will be given a reserved spot off to the side for parking and you will get a space inside of the building for your chair. **UPDATED WESTINN FEES FOR ACCIDENTS ON TURF:**

Urination on the turf - \$25 per occurrence

Stool on the turf - \$40 per occurrence

Diarrhea, loose stool, vomiting, blood or bleeding on the turf - \$75 per occurrence
