Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- <u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee or the judge. The clubs may cancel this event in extreme weather conditions.
- <u>Entry fees will not be refunded</u> if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an Act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the Event Committee.
- Since <u>bitches in season</u> are not allowed to compete in this trial the clubs will refund all but \$5.00 of the entry fee per day for bitches unable to compete for this reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.
- The clubs will refund all but \$10.00 of the entry fee per day for injured or ill dogs. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The clubs have no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. If dogs are not checked in before the end of their jump height walk through, dog & handler team may be marked absent. Failure to be at ring gate could result in the exhibitor being marked absent.
- Entries must be made on Official AKC Entry Forms or copies <u>and must include the signed</u> <u>Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form.

Include only AKC titles on form

- <u>Owners are responsible for errors in making out entry forms</u>, whoever may have made such errors.

 No entry will be refunded in the event of such errors or cancellation of entries after the published closing date.
- Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate
- The clubs do not agree to arbitrate claims as set forth on the Official AKC entry form for this event. Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$12.
- No checks will be returned if an entry is cancelled. Checks will be shredded.
- Exhibitors are responsible for cleaning up after their dog(s) at the show site as well as hotel sites. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested with the clubs, or persons to whom the assignments of such rights have been made in writing by the Clubs. Photographs and/or video recordings taken for any reason other than personal use are strictly prohibited.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.
- No Solicitation permitted on the trial site.
- Electronic timing will be used at these trials

Dogs Eligible to Enter

This trial is open to all Cardigan Welsh Corgis fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration,.

Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions. Judge reserves the right to measure dogs entered in the trial. Height divisions are as follows:

AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs except those jumping 24" or 26" without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run. You are not required to show your height card or send a copy with your entry. All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

Entries cannot be changed once the trial has closed. Please check your entries.

Move-Ups

MOVE-UPS close at 6:00 pm CT, Monday, May 12th 2025. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification had been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

Directions from trial site: Turn right on MM. Turn right on Hwy 100. Turn left on Osage Street and follow Osage east for 2.7 miles. Turn right on W. Flier Dr. Clinic is on right.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free from internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A <u>separate entry form must be submitted</u> when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

For Exhibition Only (FEO)

For Exhibition Only will not be offered at this trial.

Class Description

Please see the AKC Regulations for Agility Trials for current class descriptions.

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. All contacts are rubberized.

Prizes and Awards

Rosettes will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

MACH, PACH ribbons and bars will be awarded to any dog finishing a MACH, PACH title at these trials.

High in Trial

Criteria for the HIT: Qualifying scores in both Standard (STD) & Jumpers with Weaves (JWW) classes of the same trial are required. Each dog will be assigned points based on the STD class ENTERED for that trial (30 for Ex/Mas; 20 for Open; 10 for Novice). These points are added to the dog's speed points (judge's course time minus the dog's course time) plus the dog's score for each course. The dogs with the most points are HIT.

HIT Veteran: for dogs age 10yrs & above. To be eligible, handler must register at check in



INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it
