If possible, a letter from a licensed veterinarian on clinic letterhead stating the date which she came in season is presented to the trial secretary no later than ½ hour prior to the start of the first class of the trial. Or, examination to determine that she is in season is performed by the National Trials Chairman, the Assistant Nat'l Trials Chairman, The Obedience Trial Chairman or the Agility Trial Chairman, within the same time constraints as mentioned above.



Hotel/Dog Show Guidelines

When you sign the show entry form, you automatically agree to the following terms concerning motels. They have been established for the good of all exhibitors and will ensure future use of these facilities.

- 1. Maximum 4 dogs per room.
- 2. Dogs left unattended in a guest room MUST be in a crate. Plastic sheeting MUST be under each crate in the guest room.
- Hotel guests with dogs in the room need to use the special door hanger provided by the hotel. This hanger will leave instructions to the housekeeping staff. Housekeeping will not enter the room unless the door hanger is present.
- 4. Housekeeping must be allowed to INSPECT a guest room (with dogs) daily. Guests who have special request (e.g. a certain time of the day that room will be vacant) can discuss them with the housekeeping staff upon arrival.
- Bathing and/or grooming of dogs in or outside the guest room is not allowed. HOLIDAY INN has a grooming house on the grounds which will be available for use. The hotel does provide some towels to the grooming area. Grooming is not allowed on any sidewalks.
- The individual guest will be responsible for any damages to a guest room or any hotel property. This includes, but is not limited to replacement cost of carpeting if odors or stains cannot be removed by traditional cleaning methods. Damage claims must be settled on the spot.
- 7. Dogs are to be on leash at all times when out of the guest room.
- The hotel and the show committee will investigate any problem areas that are outlined above. Any guest not following the above guidelines will be asked to check out of the hotel without refund.
- 9. Guests in violation of any rule or failure to comply may be cause for an official event committee hearing and possible suspension of AKC privileges.
- 10. Dogs will not be allowed in the following public access areas: lobby, restaurant, lounge.
- 11. All furniture must remain in the room at all times.
- 12. Extension cords are not allowed to be plugged into rooms from a vehicle, trailer or camper in the parking lot.

American Shetland Sheepdog Association Best All Around Sheltie Competition Rules

- *To be eligible for this award, dogs must compete in at least **FOUR OF FIVE** events
- *One bonus point is awarded to dogs that compete in all five events
- *The dog with the highest cumulative score will be awarded as the Best All Around Sheltie
- * Runner-Up Best All Around Sheltie will be awarded to the dog receiving the second highest cumulative score
- *Advance registration is required.

 REGISTER USING THE ONLINE SUBMISSION FORM ON THE ASSA NATIONAL WEBSITE. http://www.assanational.com
- *Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class, but do not receive the participation point as well. The participation point in performance events is awarded if the dog competes but does not qualify in the event.
- *Dogs competing in multiple classes at the same event (for example, Standard & JWW agility, Master & Premier agility, Open & Utility obedience) will be awarded points for the highest-level class in which they receive a qualifying score. Dogs will not receive points for qualifying in more than one class in any event.
- *Dogs that make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same two points as dogs that make one cut.
- *Dogs excused from the breed ring will still be awarded a point for participation. Dogs disqualified from the breed ring will not be awarded a point for participation.
- *Preferred agility and preferred obedience classes are scored equally to the corresponding regular classes.
- *Non-regular obedience classes are scored as the regular class with similar or next lower difficulty level. For example, a Veterans obedience qualifying score is worth two points because Novice exercises are used. A Beginner Novice qualifying score is worth only one point for participation because exercises are less difficult than Novice. A Graduate Novice qualifying score is worth two points because it is similar to Novice and less difficult than Open. A Graduate Open qualifying score is worth three points.
- *Herding Instinct evaluation and Farm Dog certificate are not included in this competition and will not be awarded points.
- *Partial points will not be awarded.
- *In the event of a tie, event scores will be used to break the tie. The dog with the highest total score will receive the award. HT & PT qualifiers do not receive a numerical score, so a score of zero will be used in calculating their total score.
- *The official catalog markings from the judges' books for each event will be used to determine eligibility, participation, placements, and official scores.

NOTICE TO ALL EXHIBITORS

The AKC will collect a \$3.50 AKC Recording Fee for each entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees will be collected on each entry.

- Please note: Rally is considered a separate trial from obedience.
- At every licensed or member club Rally Trial, a Recording Fee of \$3.50 shall be required for the entry of each dog. (AKC Rally Regulations, Chapter 1, Section 3).
- A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- Canadian Exhibitors must submit entries with checks drawn on U.S. Accounts or with international money orders in U.S. funds.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated
 to furnish any service for notifying exhibitors or agents of Class Judging. Judges need not wait for any
 dog holding up a class. Owners or agents alone are responsible for the presence of dogs in the judging
 rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, E-mail and
 unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms, and
 Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT
 ACCEPTABLE. The club and/or its Superintendent assume no responsibility for wrong or incomplete
 information given on the entry blank by the owner or the owner's agent. Responsibility for
 completeness of any entry rests solely with entrant.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by
 the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it
 has been entered incorrectly. There is no refund for duplicate entries or overpayments. The
 Superintendent/Secretary will make every effort to find all duplicate entries, but if entry has been
 processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the
 control of the management it is impossible to open, or to complete the show, NO REFUND will be
 made.
- Returned checks do not constitute a valid entry fee. The Superintendent/Secretary will add a \$25.00 collection fee to the amount of each returned check.
- Refunds for cancellations due to judge change or cancellation made prior to entries closing will be
 mailed to said exhibitor or agent after the show.
- Entries will be acknowledged after entries close with entry acknowledgement and judging program to address on entry. Should Exhibitor NOT receive an acknowledgement within a reasonable time, PLEASE notify the Secretary/Superintendent applicable to the specific trial as noted in the premium list.
- Loss or Damage: The Show Committee will use due care and diligence for the welfare of dogs and







Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

- The safety of dogs is our primary concern. By entering this trial, exhibitors acknowledge that

Dogs Eligible to Enter

This trial is open to **Shetland Sheepdogs only** over the age of 15 months that are registered with the American Kennel Club or that have AKC ILP/ PAL numbers. Bitches in season may not compete. Handlers in each class may walk the course without a dog prior to the start of the class. A warm-up area, consisting of a regulation agility jump will be provided.

Dogs may be moved up to a higher class at the request of the owner, provided that the request is made in writing to the Trial Secretary no later than Monday, March 27, 2024 before 5:00 pm CST.

Height Divisions

Owners are responsible for entering the proper height divisions. Handlers may opt to run at a higher division. Dogs that run in a height division lower than their proper height division will be eliminated.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bulaws, rules, regulations and policies governing. the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
