ASSA POLICY REGARDING THIS REFUND: We will issue a refund of entry fees, less \$10 for administrative expenses provided the following conditions are met. If possible, a letter from a licensed veterinarian on clinic letterhead stating the date which she came in season is presented to the trial secretary no later than 1/2 hour prior to the start of the first class of the trial. Or, examination to determine that she is in season is performed by the National Trials Chairman, the Assistant Nat'l Trials Chairman, The Obedience Trial Chairman or the Agility Trial Chairman, within the same time constraints as mentioned above.

Hotel/Dog Show Guidelines

When you sign the show entry form, you automatically agree to the following terms concerning motels. They have been established for the good of all exhibitors and will ensure future use of these facilities.

1. Maximum 4 dogs per room.
2. Dogs left unattended in a guest room MUST be in a crate. Plastic sheeting MUST be under each crate in the guest room.
3. Hotel guests with dogs in the room need to use the special door hanger provided by the hotel. This hanger will leave instructions to the housekeeping staff. Housekeeping will not enter the room unless the door hanger is present.
4. Housekeeping must be allowed to INSPECT a guest room (with dogs) daily. Guests who have special request (e.g. a certain time of the day that room will be vacant) can discuss them with the housekeeping staff upon arrival.
5. Bathing and/or grooming of dogs in or outside the guest room is not allowed. HOLIDAY INN has a grooming house on the grounds which will be available for use. The hotel does provide some towels to the grooming area. Grooming is not allowed on any sidewalks.
6. The individual guest will be responsible for any damages to a guest room or any hotel property. This includes, but is not limited to replacement cost of carpeting if odors or stains cannot be removed by traditional cleaning methods. Damage claims must be settled on the spot.
7. Dogs are to be on leash at all times when out of the guest room.
8. The hotel and the show committee will investigate any problem areas that are outlined above. Any guest not following the above guidelines will be asked to check out of the hotel without refund.
9. Guests in violation of any rule or failure to comply may be cause for an official event committee hearing and possible suspension of AKC privileges.
10. Dogs will not be allowed in the following public access areas: lobby, restaurant, lounge.
11. All furniture must remain in the room at all times.
12. Extension cords are not allowed to be plugged into rooms from a vehicle, trailer or camper in the parking lot

RV Hookups

Coordination of the RV parking will be done through the Purina Farms Events Center. Purina Farms offers two different RV lots on property. The Full Service Purina Event Center RV lot offers water and sewer, as well as 30 and 50 amp electric. The electric only Main Show Field RV lot offers 30 and 50 amp electric. Spaces are assigned first come, first served. See the Purina RV Map if you want to request a specific spot. There is a nightly charge of \$40 in the Full Service Purina Event Center Lot and \$25 in the Electric Only Main Show Field RV Lot.

NOTE: NO WATER will be available at the sites during the winter months. However, you may fill up your reservoir at Purina's service center. Because there is no water, the cost for the Full Service Lot will be decreased to \$35.

Reservations need to be paid in full within 2 days of receiving a confirmation email. Full payment by credit card must be received before the space can be confirmed and finalized. Credit cards only.

Exhibitors are responsible for maintaining the cleanliness of their spaces, including immediate clean up of dog waste. Discharge onto the grounds is not permitted. Anyone abusing this privilege may forfeit future RV parking spaces and could be subject to disciplinary action by the Event Committee, including expulsion from this and future trials.

All owners/exhibitors should be aware that RV sites, and the entire motel grounds are considered within the trial grounds. All exhibitors are responsible for immediate clean up of their dogs waste on RV, motel, and trial grounds. Please bring sheets to protect motel beds and furniture. Any abuse or damages to motels, RV sites or the trial site may be subject to disciplinary action in accordance with AKC rules, including expulsion from this and future trials. Entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

PayPal Entries will be accepted as an option for Obedience, Rally, and Herding Certificate Entries ONLY under the following rules! Please read carefully!

PayPal Payments Accepted as Follows:

- Entries must be submitted on official AKC Obedience/Rally or Herding entry form, must include the “agreement” and be **“physically signed”** (no typed signatures).
- Completed and signed entry forms **MUST BE SCANNED** as a “PDF” file. photographs and/or jpeg files **WILL NOT** be accepted.

American Shetland Sheepdog Association Best All Around Sheltie Competition Rules

- To be eligible for this award, dogs must compete in at least FOUR OF FIVE events
- One bonus point is awarded to dogs that compete in all five events
- The dog with the highest cumulative score will be awarded as the Best All Around Sheltie
- Runner-Up Best All Around Sheltie will be awarded to the dog receiving the second highest cumulative score
- **Advance registration is required.**

REGISTER USING THE ONLINE SUBMISSION FORM ON THE ASSA NATIONAL WEBSITE. <http://www.assanational.com>

- Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class, but do not receive the participation point as well. The participation point in performance events is awarded if the dog competes but does not qualify in the event.
- Dogs competing in multiple classes at the same event (for example, Standard & JWW agility, Master & Premier agility, Open & Utility obedience) will be awarded points for the highest-level class in which they receive a qualifying score. Dogs will not receive points for qualifying in more than one class in any event.
- Dogs that make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same two points as dogs that make one cut.
- Dogs excused from the breed ring will still be awarded a point for participation. Dogs disqualified from the breed ring will not be awarded a point for participation.
- Preferred agility classes are scored equally to the corresponding regular agility class.
- Non-regular obedience classes are scored as the regular class with similar or next lower difficulty level. For example, a Veterans obedience qualifying score is worth two points because Novice exercises are used. A Beginner Novice qualifying score is worth only one point for participation because exercises are less difficult than Novice. A Graduate Novice qualifying score is worth two points because it is similar to Novice and less difficult than Open. A Graduate Open qualifying score is worth three points.
- Herding Instinct evaluation and Farm Dog certificate are not included in this competition and will not be awarded points.
- Partial points will not be awarded.
- In the event of a tie, event scores will be used to break the tie. The dog with the highest total score will receive the award. HT & PT qualifiers do not receive a numerical score, so a score of zero will be used in calculating their total score.
- The official catalog markings from the judges' books for each event will be used to determine eligibility, participation, placements, and official scores.

Notice to Exhibitors

The AKC will collect a \$4.50 AKC Recording Fee for each entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees will be collected on each entry.

- **Please note: Rally is considered a separate trial from obedience.**
- At every licensed or member club Rally Trial, a Recording Fee of \$3.50 shall be required for the entry of each dog. (AKC Rally Regulations, Chapter 1, Section 3).
- A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- **Canadian Exhibitors must submit entries with checks drawn on U.S. Accounts or with international money orders in U.S. funds.**
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or agents of Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, E-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms, and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The club and/or its Superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. Responsibility for completeness of any entry rests solely with entrant.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for duplicate entries or overpayments. The Superintendent/Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the show, NO REFUND will be made.
- Returned checks do not constitute a valid entry fee. The Superintendent/Secretary will add a \$25.00 collection fee to the amount of each returned check.
- Refunds for cancellations due to judge change or cancellation made prior to entries closing will be mailed to said exhibitor or agent after the show.
- Entries will be acknowledged after entries close with entry acknowledgement and judging program to address on entry. Should Exhibitor NOT receive an acknowledgement within a reasonable time, PLEASE notify the Secretary/Superintendent applicable to the specific trial as noted in the premium list.
- **Loss or Damage:** The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune to either dogs or exhibitors participating in these shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children on the day of the show.



Notice to Agility Exhibitors

- The safety of dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are able to perform all obstacles safely. Ring size will be 90' x 100'. Agility will be indoors at Purina Farms on padded flooring topped with Turf cover.
- Conditional, unsigned, incomplete, telephone or telegraph entries cannot be accepted. Entries must be on Official AKC Entry forms or photocopy with agreement and rules on back.
- Express mail entries must include signature permitting them to be left at the secretary's address without recipient's signature.
- Owners are responsible for all errors on entry forms and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.
- Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by action of the trial committee. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.
- Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show site. In such cases, no refund of any fees will be made.
- All dogs present must be held on leash or confined to their crate at all times except when in the ring or when in the designated agility warm-up area. The site will be monitored and offenders will be asked to leave. In such cases, no refunds will be made.
- We ask for the cooperation of exhibitors in helping to keep the location as clean as possible in order for us to retain the use of the facility in the future.
- A return check fee of \$25.00 will be added for each check returned. Subsequent returned checks from the same exhibitor may result in entries only being accepted on a C.O.D. basis.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman/judge judges only on the merits of the dogs and considers no other factors.
- The sportsman/judge or exhibitor accepts constructive criticism.
- The sportsman/exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman/exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
