**PETITIONERS' RESPONSE TO RESPONDENT'S "EMERGENCY
MOTION FOR INVESTIGATION BY MANDATED JOINDER PARTIES
CARR AND CFPB"**

Petitioners file this brief response to Respondent Christopher M. Hunt, Sr.'s recently filed "Emergency Motion for Investigation by Mandated Joinder Parties Carr and CFPB" (the "Emergency Motion"), which was embedded within Respondent's Reply in support of his "Notice of Filings" submitted on August 15, 2025.

Mr. Hunt's argument appears to be connected to his previous requests for the Court to allow him access to a recording of the hearing in this case from December 2023—requests the Court denied in September 2024. There is no good cause for the Court to reconsider that order. Concerning Mr. Hunt's suggestions that the Attorney General and the Consumer Financial Protection Bureau (the "CFPB") are "mandated joinder parties," Mr. Hunt makes no attempt in his motion to discuss the elements of O.C.G.A. § 9-11-19, and much less does he make any effort to show how those elements are met. And he could not in any event. The Emergency Motion is just one more of Mr. Hunt's frivolous and harassing filings to which this lawsuit seeks to put an end. The Court should deny Mr. Hunt's "Emergency Motion."
