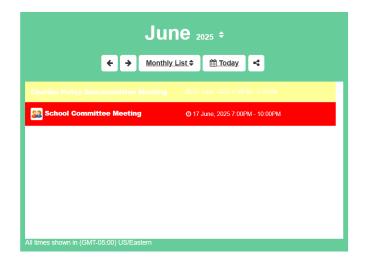

- Ms Picard, as allowed by her contract, requested consideration of a one year extension for personal planning as the sole breadwinner in her household.
- Donna Chambers, Jessica Purcell, Karen Reynolds, and Linda Lyall gave both positive and constructive feedback.
- Dianne Tefft was on the fence. She said feedback from the community was negative- when pressed stated academic progress, availability to general public & parents, (unspecified) "outcomes."
- Laura Chapman said she received "up to 100" emails that were mostly not favorable. Though she acknowledged Ms Picard is driven with an excellent work ethic, she would vote no due to issues that came up since the review.
- Other members had not received more than a dozen or so emails.
- Pat Pouliot was not satisfied that district is not 98% proficient in reading and math.

- In the past, Ms Picard has declined a salary increase due to level funding.
- A superintendent search is a costly undertaking.
- The public was denied the opportunity to address the committee on this matter. There was about 10 min of public outcry, asking for the right to speak.
- Louise Dinsmore became defensive and even disparaged residents attempting to be heard. She would not entertain public comment for fear of violations filed against herself and the committee, and that it would devolve into a performance review in open session.
- The topic went to vote and the public was not pleased.
 Catherine Giusti requested a roll call of the vote so that the public would know who voted how.
- Motion failed 7:5.

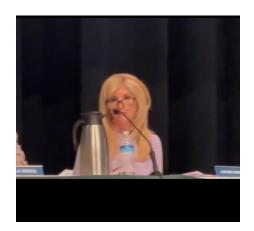

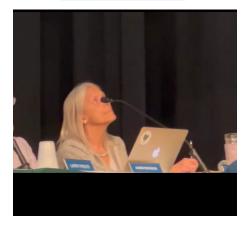

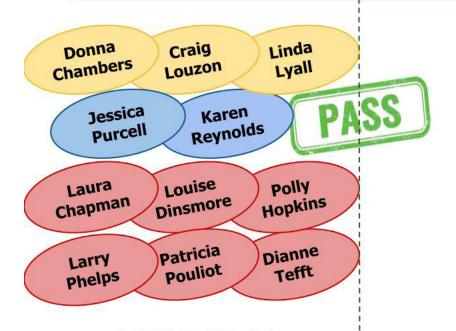

Jessica Purcell felt more families need this policy with redistricting elementary school lines and consolidation. It allows students school of choice based on the specialty of their interest. The goal is to address the concerns with the consolidation of schools, transition of enrollment to towns of residence to district enrollment based on transportation lines.

Louise Dinsmore felt this was a conversation for the subcommittee. Due to materials being shared late, she couldn't vote on this.

Ms Picard said this policy doesn't affect how teachers do instruction, the committee can discuss changes because it's a management decision. The policy subcommittee could help get a consensus as long as there is no more than six, creating a quorum. She recommended it to go before the school improvement teams.

Polly Hopkins made a motion to transfer to policy subcommittee.

Laura Chapman seconded the motion.

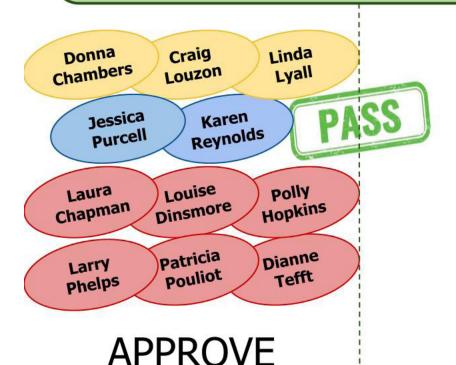
Jessica Purcell preferred to table until next month's agenda.

Louise Dinsmore asked if the subcommittee could meet before the next committee meeting. Karen Reynolds suggested an amendment that if the

subcommittee cannot meet in a timely manner before the school committee meeting in June, then it should be moved to the committee's regular agenda.

Amended motion: Approved Unanimously

FUNDRAISING POLICY – CHANGE/WAIVER FOR RES PLAYGROUND May 13, 2025



OPPOSE

Linda Lyall made the motion for the following language to be waived: "Fundraising activities should not be used for the purpose of funding items that should be included in the school budget." Seconded by Craig Louzon.

Mr Zenion advised that it should include Ashaway.

Ms Picard worked with RIDE, the school building authority and district project manager. A solution to incorporate RES playground work for this summer and Ashaway playground for next summer into work with the main campus' capital plan, using capital dollars, allocated from state reimbursements. Both will be addressed with the finalization of Stage II with RIDE for the campus- **Not as the bond, but as the district plan.**

Linda Lyall rescinded her motion. A new motion was made to waive the policy for fundraising by PTO for Ashaway and RES. Craig Louzon seconded.

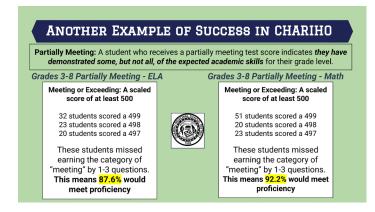
Public comment: Thea Brennan asked for clarification of including school personnel. **Ms Picard** answered that it's a Parent Teacher Organization.

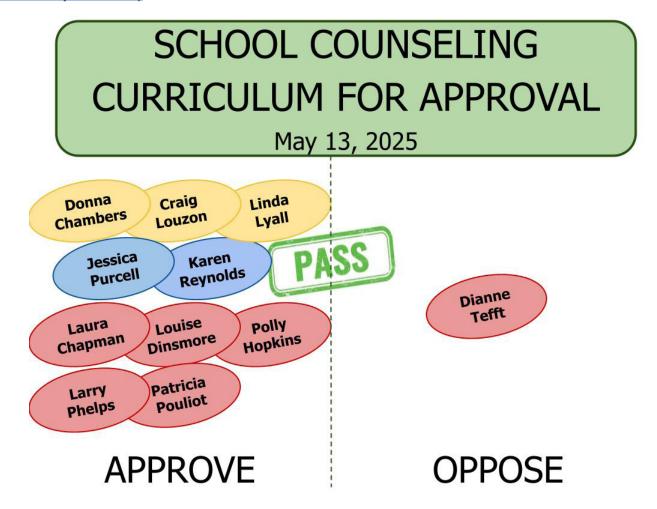

D. SCHOOL COUNSELING CURRICULUM FOR APPROVAL

(Timestamp: 2:12:23)



Ms Picard recommended approval.

Karen Reynolds moved the motion. Craig Louzon seconded.

Dianne Tefft expressed concerned with the "Mindset and Behavior Standards," specifically identifying social skills as something that should be taught at home. "Not the school's job." She felt it's like religion and didn't think that type of education belongs in the school.

Karen Reynolds assured that the district encourages and supports the parental role. The school's role is to teach kids to handle their emotions in an appropriate manner while at school. That is beneficial to themselves and the classroom.

Linda Lyall supported Karen Reynolds' comment with an example of a learning environment that teaches kids to be cooperative, good friends at different developmental points in a student's life.

Jessica Purcell pointed out that kids are learning all the time and in this framework, there are changes with each school stage. Formal counselors are introduced in middle school, whereas at the elementary level, it's worked into the morning meeting. There are guidelines with boundaries and leaders. Expressed concerns with lack of elementary staff and would like to bridge student engagement.

Dr. Comella clarified that morning meeting at elementary level does embed some of the standards. The district curriculum planning council does include student representation and is reviewed by school improvement teams, which has student representation well.

Ms Picard shared that for the middle school a poll is taken of the students for advisory.

Laura Chapman asked Dr. Comella when it was sent to the SIT teams. (Early to mid-March) She wondered if there were summaries of changes that were made.

Dr. Comella answered that the presentation they received thoroughly explained the changes. The ASA standards haven't really changed. They aim to reform it.

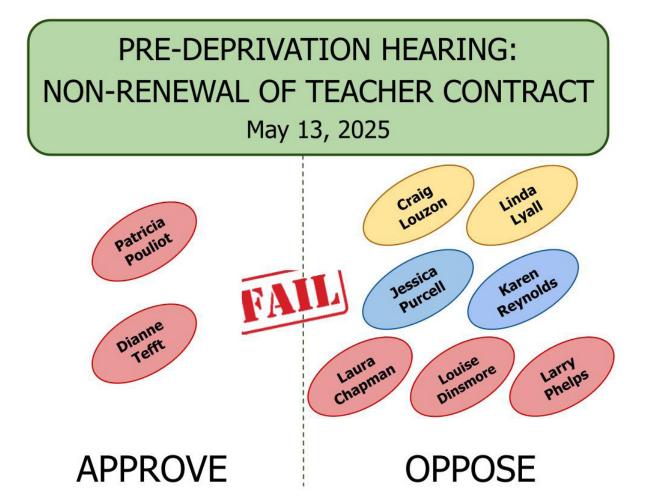
Dianne Tefft felt that social and emotional learning doesn't always work.

Laura Chapman commented that during the last health and wellness subcommittee, someone had alluded to absenteeism being a result of taking mental health days. She understood why it may happen, specifically with girls, more frequently than with the boys.

Vote: Motion carried. Opposed: Dianne Tefft

E. PRE-DEPRIVATION HEARING: NON-RENEWAL OF TEACHER CONTRACT-

Claire Leathham- requested-in open session (Timestamp: 2:25:45)



Polly Hopkins requested to exit the meeting to get her son home because he had school in the morning. She'd only "planned until 10." Louise Dinsmore responded, "You've gotta do what you've gotta do."

Attorney Anderson: Stated that this item concerns a non-renewal of a teacher's contract. In 30 years of representing Chariho this is usually handled in executive session, but a teacher has the right to hold it in public session. Explained the procedure-

- 1. The superintendent has to explain why she is making the recommendation of non renewal or in this case to reduce the hours of the teacher.
- 2. The teacher is entitled to make a short statement with why she disagrees.
- 3. The committee then can entertain the motion to support Ms Picard's decision or not.

Ms Picard shared that Ms Leathham is a World Language teacher, teaching French. Based on enrollment and the course requests from students, her position would go from a 5 day/week position to a 3 day/week position.

Ms Leathham spoke to reducing her position. She expressed concern that the French program would be cut entirely after next year. Cutting the French and the Mandarin programs is occurring just as RIDE is making WL more of a priority. She agreed that there has been a decrease in enrollment, not due to interest, but because of a decrease in opportunities. She indicated if Chariho could commit to giving the French program a full chance, not only will enrollment improve, but also a rise in SAT score average would occur, given the documented English vocabulary gains from learning French. Lastly she noted, "The vibrancy from the WL department at Chariho derives partly from offering a variety of languages at all levels. To continue to rank in the top 10 high schools in the state Chariho needs to have a rich WL program."

Public comment: 3 present and former Chariho students spoke in support of the program and "Madame L." cultural diversity- baking program included anyone in the HS that was interested in French culture students need to have choices provides an advantage while applying for college students look forward to this while moving up to HS It builds relationships and gives opportunities for learning experiences. Losing educators of this caliber and WL programs would be an immense detriment. Budgeting is hard, but "What is left when we cut programs that are specifically designed to create leaders in our competitive world." WL programs are an "investment in fostering intellectual, creative and cultural growth." learning a language is an opportunity to excel in other subjects. "Paint WL as a part of being a citizen to the world…it's a part of being human in this generation where communication is more important than ever."

Linda Lyall was impressed with Lucy, Virginia and Penelope for being articulate, and to Ms Leathham... "your kids love you and that says a lot." She felt that a comment a member made during the budget meeting was shortsighted, and being bilingual is important.

Louise Dinsmore stated that the comment was an observation, but "in the end, this committee did not move forward to cut WL."

Laura Chapman clarified she was the one who made the comment when she became aware of class sizes, because her child attends Chariho. Nothing was cut from WL in the budget. She's confused and felt the recommendation to cut the program was coming from the Superintendent, not the committee.

Ms Picard corrected the program is not being cut. Class sizes were discussed and her advice was to not call out specific positions during budget season, because the committee's role is budget dollars and allocation of funds. It is up to her and the principals to take appropriate measures when applying funds, and make staffing decisions. The committee seemed concerned about maintaining classes having low enrollment, and she and her team tried to address that. This year, that resulted in changing a position from 1.0 to .6. Only 20 8th graders were interested in French. She fears the committee is looking to reduce enrollment "in many ways, French is just one example." In the past, giving students opportunities was prioritized. The committee needs to determine what their expectation is for class sizes.

Louise Dinsmore responded that they made an investment in the WL programs and were asking questions to make informed decisions.

Ms Picard noted that decisions are being made based on the budget passed.

Laura Chapman "I'm a new committee member..." She based her comments on her daughter's class.

Point of order to get back on track was made.

Linda Lyall remarked that enrollment is low now. She's concerned about losing WL teachers. With it being a graduation requirement, it may bring enrollment back up, but good teachers will already have been lost.

Ms Picard was concerned that committee members making comments in public causes teachers to sense job insecurity and seek employment elsewhere. Currently, every student can be offered a language, but there is less of an interest in Mandarin and French. Jessica Purcell thought small class sizes were beneficial for learning and she supported Lyall's concerns about losing qualified teachers.

Ms Picard explained budgetary decisions happen in March and Enrollment is in June. The budget meeting is not the time to highlight enrollment. Smaller class sizes means more opportunities for students (by extension higher class sizes decrease opportunities). The committee is sending mixed messages. To keep the position at 1.0, there won't be enough French classes to give her.

Karen Reynolds confirmed the current freshman class will need 2 full years of WL for graduation, and was curious to know how many are currently interested in French.

Ms Picard answered there were 20, but schedules aren't yet finalized.

Craig Louzon asked about an overall significant decrease, and if they were "cutting off our nose to spite our face."

Ms Picard pointed out that most are interested in Spanish and Italian. Chariho is one of a few schools offering more than 1 language. In the end, she cannot anchor teachers to the district.

Pat Pouliot felt similar to Louzon and wanted to know if the WL program, as a requirement, can fulfill the needs of every student.

Ms Picard responded that there is enough space in all of the world languages for every student to take a WL even with this reduction.

this reduction.

The chair asked for a motion, and no one called one. She attempted to move on to the next item, but Ms Picard reminded her that a vote needed to be taken. The law requires them to make a decision.

Public Comment: Nina Rook-Cast: Expressed confusion about the item listed on the agenda, was it about eliminating the French and Mandarin programs.

Ms Picard said she cannot determine if a program could be cut during budget season, but that virtual high school could be an option. A French teacher was not budgeted. A WL teacher was budgeted.

Public Comment: William Cotton stated that most colleges expect students to have studied the same foreign language for at least 3 consecutive years. What about students already on the French track? When Picard said that virtual high school was an option, Cotton asked what happens if the particular course isn't offered via VHS. He wants an avenue for students currently enrolled in French 1 or 2 to complete French 3.

Laura Chapman seemed confused about the separation between the budget and enrollment. Ms Picard explained again.

Jessica Purcell stated perception was that by reducing this contract, it's eliminating the French program.

Ms Picard clarified that a 0.6 is what's needed to cover French, and that a 1.0 is needed for enrollment in classes. Since Ms Leathham only teaches French, she cannot be used in another subject area.

Karen Reynolds asked if there was a plan to run French I next year and the answer was no. **Ms Picard** noted there are 20 8th graders who may be interested in French.

Vote: Louzon, Chambers, Phelps, Reynolds, Chapman, Dinsmore, Purcell, Lyall Opposed reduction Pouliot and Tefft Approved reduction

Donna Chambers suggested the student advocates make a video promoting the course.

G. RFQ- STAGE 2 ARCHITECT- ELEMENTARY SCHOOL CAPITAL PLANNING FOR APPROVAL- approved unanimously (<u>Timestamp: 3:07:35</u>)

Begin to plan stage II for elementary plans which will encompass a review of renovation costs and the opportunities for new schools with as many possibilities to discuss the difference between new schools and renovations. Discussion-Reynolds: Questioned the timeline for submission. Picard: Stated if it is not submitted by Feb 15th, the district must pay for Stage I again, this being our 5th round. Dinsmore: Questioned whether the RFQ costs anything (no). Asked who reviews the bids when they come in. Picard: Responded "The Necessity for School Construction" subcommittee; who will then provide it as a recommendation to the committee. Reynolds called the motion. Pouliot Seconded.

J. INCREASE OF STUDENT MEAL PRICE FOR APPROVAL (Timestamp: 3:15:45)

Discussion-Lyall: Asked how much the increase was. Zenion: Responded approximately less than a dollar. Louzon: The subcommittee hasn't been utilized. (Because he was the only member) Purcell: Asked if it could be negotiated down more, though doesn't want to see participation decrease. Zenion: Stated if an increase didn't occur, there would be a \$40,000 deficit in the budget next year. With a lunch cost increase, there will be a projected profit of \$34,000. Purcell: Wanted the cost to be reduced by even 5 cents. **Vote: approved 9:1, Purcell opposed**

There is no middle ground with this Opt-out provision. Requesting referral to STI and/or Policy Subcommittible as

 5. Library Media Policy Member Hopkins is requesting that this Committee REMOVE and DEFUND the American Library Association from this policy and budget. Citing that the ALA has participated in Political and ideological initiatives that do not support ALL kids.
