As required by the AKC Tracking Regulations, a written certification must accompany the TD entry for any dog which has not previously passed an AKC TD or TDU Tracking test.

In accordance with Chapter 1 Section 17 of the AKC Tracking Regulations, a drawing to fill entry limits will be held at 252 Jones Rd, Somerville, ME. This drawing is open to all interested persons. The drawing shall be random among all entries received except that priority will be given to dogs that have not previously earned a tracking title. Alternates will be given the option to accept, or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who opt to decline will have their entry fees returned. Entrants and alternates who do not run in a test but are replaced by alternates who run in the test will have full entry fees returned. Following the draw, the test secretary will attempt to contact all entrants and advise them of the outcome within 48 hours. E-mail and telephone inquiries are welcomed. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall assume the vacant position.

No entries will be accepted which require a signature for delivery. Entries will not be accepted without fee. Returned checks do not constitute a valid entry fee. The Test Secretary will add the fee charged by the bank to the amount of each returned check. Faxed, telephone, E-mail, and unsigned entries cannot be accepted. Entries not on an official AKC form and photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry forms are not acceptable. No refunds for duplicate entries or errors on entry blanks. Owners are responsible for errors in filling out entry forms and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Bitches in season may participate in this test in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge or barred from competition by action of Tracking Committee. If because of riots, civil disturbances, or acts beyond control of OTAC and/or the Tracking Committee it is impossible to open or to complete the test, no refund of entry fee will be made.

A worker draw will be used for this test in accordance with the parameters set forth in Ch. 1, Sec. 17d of the Tracking Regulations and as determined by the Board of Directors.
