## Drawing for TDU Tracks at 7:45 AM EDT

Will be held at test headquarters at The Viles Arboretum, 153 Hospital Street, Augusta, ME.

**First TDU track will run after the TDU draw when the first track is ready.**

Exhibitors should be aware that a gallery will be encouraged to observe and follow along on the tracks at a respectful distance from the dog/handler team to enjoy the experience of an AKC tracking test.

**The judges will plot an alternate track and use it as a titling track if it is available and the test has an alternate present.**

## Directions

**Traveling NORTH** Take I-95 Exit 113 for Augusta/Belfast. Continue straight on ME Route 3 through 2 traffic lights crossing the Kennebec River. After the bridge, turn right at the traffic light at the intersection of ME Route 3 and US Route 201/ME Route 100 and follow US Route 201/ME Route 100 South. Staying on US 201, US Route 202 will join on the left and in another half mile there will be a traffic circle. Take the ME Route 9/Stone Street exit (the third after entering the circle). Continue ME Route 9 for 1.2 miles (going straight through a traffic light). Viles Arboretum will be on the left.

**Traveling SOUTH** on I-295: Take Exit 49 (Route 201) Turn right onto Route 201 towards Gardiner. Stay on 201 through Gardiner to bridge (4.5 miles). Cross the bridge. Take a left on to Route 9E (Water St.) Go 5 miles. Viles Arboretum is on the right.

**Drawing for Entries into TDU Test

In accordance with Chapter 1 Section 17 of the AKC Tracking Regulations, a drawing to fill entry limits will be held at 252 Jones Rd, Somerville, ME. This drawing is open to all interested persons. **The drawing shall be random among all entries received except that priority will be given to dogs that have not previously earned a TD or TDU title.** Alternates will be given the option to accept, or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who opt to decline will have their entry fees returned. **Entrants and alternates who do not run in a test but are replaced by alternates who run in the test will have full entry fees returned.** Following the draw, the test secretary will attempt to contact all entrants and advise them of the outcome within 48 hours. E-mail and telephone inquiries are welcomed. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall assume the vacant position.

**No entries will be accepted which require a signature for delivery. Entries will not be accepted without fee. Returned checks do not constitute a valid entry fee. The Test Secretary will add the fee charged by the bank to the amount of each returned check. Faxed, telephone, E-mail, and unsigned entries cannot be accepted. Entries not on an official AKC form and photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry forms are not acceptable. No refunds for duplicate entries or errors on entry blanks. Owners are responsible for errors in filling out entry forms and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.**

Bitches in season may participate in this test in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations. Entry fees shall not be refunded if a dog is absent, disqualified, excused by the Judge or barred from competition by action of Tracking Committee. If because of riots, civil disturbances, or acts beyond control of OTAC and/or the Tracking Committee it is impossible to open or to complete the test, no refund of entry fee will be made.

Exhibitors should follow their veterinarians' recommendations to ensure their dogs are free of internal and external parasites and any communicable disease and have appropriate vaccinations.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the

forementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

**INSTRUCTIONS**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
