Thursday ♦ Davis, WV

This morning, we'll get an early start on our way to Romney, WVA where we will board the Potomac Eagle Scenic Railroad. We will enjoy our three-hour narrated excursion through a tranquil and pristine mountain valley with lunch included. View historic farms and lush mountain greenery as we ride along. Don't be surprised to see bald eagles overhead in pursuit of prey or gliding gently across the blue mountain skies. Following our train excursion, we board the coach and head to Davis, WV and check-in to the Canaan Valley Resort. We will enjoy our included dinner at the hotel.

Friday ♦ Davis, WV

Enjoy an early included breakfast at the hotel before departing for our day's adventure. Today, we are going to Sulphur Springs, WV where we will take a behind the scenes tour of the declassified Bunker at Greenbrier. Carved deep into the mountainside beneath our West Virginia Wing is an emergency Cold War fallout shelter. Once a top-secret U.S. government relocation facility for Congress, The Bunker is now open to anyone interested in reliving a legendary piece of The Greenbrier history. Following our Bunker Tour we will enjoy a Bunker lunch at Sam Sneads Restaurant located on the golf course. Our afternoon adventure takes us to the Green Bank Telescope where we will tour the National Radio Astronomy Observatory is intentionally located in one of America's most quiet spots. Here the scientists are listening to sounds from space. We will return to the resort and enjoy dinner on our own. (B, L)

Saturday ♦ Davis, WV

Enjoy our included breakfast before departing for Elkins, WV where we'll board a vintage diesel-powered passenger train. This train has gained a reputation as one of the most relaxing mountain wilderness excursions. Our 4-hour, 46-mile round trip departs from the restored Elkins Depot on Railroad Avenue. Lunch included while on the train. The trip culminates at the High Falls of Cheat, an 18' high, 150' wide waterfall located in one of the most remote and pristine settings in the region. Upon our return to Elkins, we will visit the West Virginia Railroad Museum located in the historic Darden Mill. The Darden Mill was built in 1902, on land purchased from the West Virginia Central and Pittsburgh Railway Company. We will have some free time in downtown Elkin. We will take our seats for a dinner and a show at Gandy Dancer Dinner Theater. Our musical show pays tribute to musical legends as Dolly Parton, Kenny Rogers, Elvis and many more. We will return to the hotel following the show. (B, L, D)

Sunday ♦ Davis, WV - Home

Breakfast included at the hotel. Our morning stop on our way home will be at the Blackwater Falls Boardwalk with time on our own. We'll enjoy a farewell lunch at The Smokehouse at Blackwater Falls. Reservations can be made by mail, phone, or email and will be held for seven days pending the receipt of the your check deposit/payment. Credit Card payments are accepted with Visa, MasterCard or Discover.

One Day Trips Full payment or a per person deposit is due within 7 days of making your reservation which confirms your seats: Coach seating assignments are based on the date your first payment is received at our office.

Day Trip Payment Policy:

Sightseeing/Attractions/Dinner Theater: \$30 PP
Deposit

Ticketed trips (Show, Concerts, etc.): Deposit varies
Day Trip that require full payment with reservation will be noted at the end of the trip description.

Day Trip Cancellations made within 60 days before the trip date are subject to a penalty fee equal to the amount of monies that have been advanced on your behalf for components of the trip. These include but are not limited to event/show tickets, pre-ordered meals, transportation, attraction & sightseeing costs. Please note that some event/show tickets are non-refundable once we receive your deposit. Cancellations within 14 days prior to the Day Trip are subject to no refund unless a replacement is found by you or us.

Multi-day Motorcoach Payment Policy: A minimum \$150 pp deposit is required.

Payments made on multi-day motorcoach tours are accepted by check, cash or credit card. You can choose to (1) pay in full at reservation or (2) pay your deposit at reservation and final payment by the balance due date.

Air Tours & Cruises Payment Policy can vary depending on the policy of the cruise line or third party tour operator.

If you choose to **pay by credit card**, either **one or two payments will be accepted**. The first credit card payment required is the minimum deposit amount (or more if you desire). The second credit card payment required is the final balance amount due by the "Balance due" date listed on the payment schedule.

Multi-day Tour & Cruise Cancellation Policy

Regarding airline tickets, an airline cancellation fee of up to 100% of airfare is usually in effect immediately upon ticket purchase.
