

New Hampshire Mountain Climb

June 2 - 5, 2024

4 Days, 3 Nights

Sunday ♦ Travel Day

Travel to Lincoln, NH – gateway to the White Mountains. Here we'll discover a pine-scented natural playground dotted with crystal clear lakes and streams, the highest mountain peaks in the Northeast. Home for the next three nights is the Indian Head Resort, surrounded by the majestic beauty of New Hampshire's White Mountain National Forest. The resort sits on 180 acres near the southern entrance to Franconia Notch State Park. The resort's facilities include panoramic scenic view lodging indoor & outdoor pool, whirlpool and saunas, exercise room, nature trails, paddle boats, their award-winning Profile Dining Room, the Thunderbird Lounge and a large gift shop. After our arrival enjoy an evening reception then an included dinner. Evening entertainment is featured in the Thunderbird Lounge. (D)

Monday ♦ North Conway, NH

Enjoy a buffet breakfast this morning at the resort. This morning we depart with our local guide to travel the Kancamagus Highway to North Conway. New Hampshire Route 112 is a 56.39-mile-long east-west state highway in northern New Hampshire. The highway winds across the state, connecting Bath to Conway through the heart of the scenic and mountainous White Mountain National Forest. A village set amid mountains and forest, North Conway is a jumping-off point for hiking excursions on Mt. Washington and scenic tours on vintage trains, as well as ski trips and visits to Diana's Baths cascades. Hotels and restaurants host year-round visitors, who also come for bargains at the many outlet malls. Mt. Washington Observatory's science center features exhibits about the peak's extreme weather. We will have time for lunch on our own, shopping and exploring this quaint village. We return to the resort to relax and freshen up for the evening. Tonight we gather together for a beer, wine and cheese reception before dinner in the Profile Dining Room. Following dinner there is entertainment in the Thunderbird Lounge. (B, D)



Tuesday ♦ Mount Washington Cog Railway

Enjoy a buffet breakfast this morning at the resort. We depart for the famed Mount Washington Cog Railway. Here we climb (by railway) three climate zones to the top of New England. Conditions at the top can be quite a bit different than those at the base station, so be sure to bring a jacket for this mountain rail journey. As we leave the train, notice that it's at least a little cooler and windier than it was at the Base Station. After all, the subarctic tundra up here is similar to that of far northern Canada, and hurricane-force wind gusts occur on the summit an average of 110 days per year. Trains lay over at the summit for approximately one hour, plenty of time to explore the State Park's Sherman Adams Visitor Center and its rooftop observation deck, Extreme Mount Washington (an interactive weather exhibit), a cafeteria, and two gift shops. Send a card to friends and family with a unique Mount Washington post mark from the summit Post Office!

Afterwards we will return to the Indian Head to relax and freshen up for the evening. Tonight we gather together for a beer, wine and cheese reception before a dinner in the Profile Dining Room. Following dinner there is entertainment in the Thunderbird Lounge. (B, D)

Wednesday ♦ Travel Home

Enjoy our final a buffet breakfast this morning at the resort before saying goodbye to our new "White Mountain" friends and the beautiful scenery of New Hampshire. (B)

Reservations can be made by mail, phone, or email and will be held for seven days pending the receipt of the your check deposit/payment. Credit Card payments are accepted with Visa, MasterCard or Discover.

One Day Trips Full payment or a per person deposit is due within 7 days of making your reservation which confirms your seats: Coach seating assignments are based on the date your first payment is received at our office.

Day Trip Payment Policy:

Sightseeing/Attractions/Dinner Theater: \$30 PP
Deposit

Ticketed trips (Show, Concerts, etc.): Deposit varies
Day Trip that require full payment with reservation will be noted at the end of the trip description.

Day Trip Cancellations made within 60 days before the trip date are subject to a penalty fee equal to the amount of monies that have been advanced on your behalf for components of the trip. These include but are not limited to event/show tickets, pre-ordered meals, transportation, attraction & sightseeing costs. Please note that some event/show tickets are non-refundable once we receive your deposit. Cancellations within 14 days prior to the Day Trip are subject to no refund unless a replacement is found by you or us.

Multi-day Motorcoach Payment Policy:

A minimum \$150 pp deposit is required.

Payments made on multi-day motorcoach tours are accepted by check, cash or credit card. You can choose to (1) pay in full at reservation or (2) pay your deposit at reservation and final payment by the balance due date.

Air Tours & Cruises Payment Policy can vary depending on the policy of the cruise line or third party tour operator.

If you choose to **pay by credit card**, either **one or two payments will be accepted**. The first credit card payment required is the minimum deposit amount (or more if you desire). The second credit card payment required is the final balance amount due by the "Balance due" date listed on the payment schedule.

Multi-day Tour & Cruise Cancellation Policy

Cancellations are subject to any non-recoverable expenses or penalties charged by hotels, transportation companies, sightseeing companies, airlines, cruise lines & attractions, as well as a cancellation administration fee charged by C and Bea Tours & Cruises.

Multi-day Cancellations Prior to Trip 60 days or more, on most trips, a refund less any non-recoverable charges and 90 days on most air tours & cruises.

60 - 30 days - \$150pp cancellation administration fee plus any non-recoverable charges.

29 -8 days - \$200pp cancellation administration fee plus any non-recoverable charges. Cancellation penalties from cruise lines and tour operators will be assessed and will increase as the trip departure date approaches.

Within 7 days - trips may be 100% non-refundable unless a replacement is found.

Regarding airline tickets, an airline cancellation fee of up to 100% of airfare is usually in effect immediately upon ticket purchase.

Optional Travel Protection will be offered on our overnight tours and cruises providing coverage for canceled or interrupted trips, medical costs, travel accident, lost or stolen luggage, bankruptcy and acts of terrorism. We will send you the insurance information to you with the receipt of your first trip payment. **We strongly recommend the travel insurance to protect your vacation investment.**
