**One Day Trips** Full payment or a per person deposit is due within 7 days of making your reservation which confirms your seats: Coach seating assignments are based on the date your first payment is received at our office.

## **Day Trip Payment Policy:**

Sightseeing/Attractions/Dinner Theater: \$30 PP Deposit

Ticketed trips (Show, Concerts, etc.): Deposit varies Day Trip that require full payment with reservation will be noted at the end of the trip description.

Day Trip Cancellations made within 60 days before the trip date are subject to a penalty fee equal to the amount of monies that have been advanced on your behalf for components of the trip. These include but are not limited to event/show tickets, pre-ordered meals, transportation, attraction & sightseeing costs. Please note that some event/show tickets are non-refundable once we receive your deposit. Cancellations within 14 days prior to the Day Trip are subject to no refund unless a replacement is found by you or us.

# Multi-day Motorcoach Payment Policy: A minimum \$150 pp deposit is required.

Payments made on multi-day motorcoach tours are accepted by check, cash or credit card. You can choose to (1) pay in full at reservation or (2) pay your deposit at reservation and final payment by the balance due date.

**Air Tours & Cruises Payment Policy** can vary depending on the policy of the cruise line or third party tour operator.

If you choose to pay by credit card, either one or two payments will be accepted. The first credit card payment required is the minimum deposit amount (or more if you desire). The second credit card payment required is the final balance amount due by the "Balance due" date listed on the payment schedule.

#### **Multi-day Tour & Cruise Cancellation Policy**

**Multi-day Cancellations Prior to Trip** 60 days or more, on most trips, a refund less any non-recoverable charges and 90 days on most air tours & cruises.
