COSTS: Filing Fee - \$10.00 for claims equaling \$1,000.00 or less, and \$15.00 for claims exceeding \$1,000.00.

Both summonses will be mailed by the Court Office and copy will be mailed to you to notify you of date and time of the hearing - bring evidence and witnesses to hearing.
