## Town and County Tax Collecting Season is Here

The Virgil Tax Collectors' office has been collecting the Town and County Taxes for the tax payers in Virgil for the 2020 tax season.

The Virgil Town Board did a wonderful job at keeping the town's budget flat for 2020, so if you look at your tax bill you will notice a 0% increase on your town tax levy for the Town of Virgil. There is a

2.90% increase in the County taxes and a 1.80% increase in the Virgil Fire District tax levy.

You are able to look up and pay your tax bills on our website at [www.virgilny.org](http://www.virgilny.org). When looking up your tax bill do not fill in all the fields, simply enter your last name or bill number if you know it. You

can pay with a credit card or e-check. There are fees associated with paying this way.

We will be collecting taxes here at the Town Clerk's Office until May 31st after that date we will turn all unpaid taxes over to the County Treasurer. Please let us know if you have any questions on taxes.

## Virgil Historical Society

Virgil Historical Society meets on the third Thursday of September, November, March, and May at 7PM at the Virgil Town Hall, 1176 Church St. The next meeting will be March 19, 2019 and the speaker will be Virgil Historian Marsha Powell on "Virgil's Big Fire"

Marsha will speak on the house fire of March 14, 1899 that led to a murder conviction and appeals all the way to the Supreme Court. Don't miss it!

At the last meeting, Tom Jewett gave a sensational talk about the Cortland County soldiers who fought in the New York 76th Infantry Regiment in the Civil War and helped to turn the tide at Gettysburg. It seems like a long time since that meeting, but now that spring is around the corner

## Primary and Early Voting

April 28, 2020 is the date scheduled for the Presidential primary. The primary will be held at the Virgil Town Hall from 6 AM– 9 PM on that date.

Beginning on April 18, 2020 to April 26, 2020, you will be eligible to vote early before the April 28, 2020 Presidential Primary.

The Early Voting polling site for Cortland County is located on 112 River Street, Cortland NY 13045. The entrance at the front of the building is handicap accessible.

Early voting votes will be canvassed and reported after 9pm on Tuesday, April 28, 2020.

Absentee ballots are available if you are out of your home county, or if you live in New York City, are outside of the five boroughs, or if you

are permanently or temporarily disabled, ill or are the primary care giver for one or more people who are ill or physically disabled, or a resident of a Veterans Hospital, or detained in jail awaiting Grand Jury action or incarcerated for an offense other than a felony you may apply for an absentee ballot.

## Hollenbeck's

Hollenbeck's Cider Mill will conclude its 87th season on March 15th, 2020. Your favorite goodies will be available on their usual schedule until then. The last day to pre-order pies will be March 12th for a March 13th pickup. On the 14th and 15th (Saturday and Sunday), pies will be available on a first-come, first-served basis. Pies, donuts, pretzels, and cider will be available while supplies last.

After closing at 6PM on the 15th, Hollenbeck's will re-open in June for their summer season. Stay tuned to ads in the Standard, the Shopper, and on social media for an exact date. During the summer, the mill will be open Fridays and Saturdays 9AM-8PM and Sundays 9AM-3PM. They'll have pies, breads, pretzels, and pizza all summer, but you'll have to wait until the fall season for apple products.

## Georgic Farm 2020 CSA

Georgic Farm is beginning its second year, right here in the heart of Virgil. The farm grows a variety of vegetables, as well as selling rabbits for meat. Last year the farm grew nearly 70 varieties of fruits and vegetables, and this year we plan to grow more than 90, without using any harmful chemicals! Most of those veggies are old standbys like carrots, beets, broccoli, and lettuce, but there are also a few unusual members of the cast like mustard, sweet potatoes, and fennel. All the fruits and vegetables Georgic Farm produces are sold either at the Virgil Farmers Market (Saturdays 9-12 in the summer), or through the farm’s Community Supported Agriculture program (CSA). CSA is a popular way for consumers to purchase farm-fresh products in a way that maximizes benefits for the farmer and minimizes costs for the customer. In short, it’s sort of like a vegetable sub-

scription. The consumer pre-pays upfront for a “share” of the farm, and then gets to pick up vegetables every week from June-October. When a crop does really well, the shareholder gets to enjoy the bounty right along with the farmer. This system helps the farmer because then they have money at the beginning of the season to buy things like seeds and supplies, and it helps the customer eat their veggies at a great price.

What are the benefits of joining a CSA? First, a CSA makes it easy and inexpensive to eat lots of high-quality vegetables. Picking up a share of fruits veggies each week means that CSA members always have great seasonal ingredients for healthy, delicious meals. And even though the up-front cost of a CSA might seem like a lot, it’s actually cheaper than buying all those veggies

from a supermarket or farmers market! In addition, CSAs are great for the environment because they reduce the carbon footprint of shipping and storage, and they build community by bringing farm members together. Plus you can see exactly where your food comes from, just like in days gone by. Georgic Farm still has openings in its 2020 Summer CSA. The cost of a share is \$550 for the whole season (only \$25/week), which includes 8-10 types of vegetables each week, along with a newsletter chock-full of farm news and delicious recipes. Pickups are held at Hollenbeck’s Cider Mill on Fridays from 4-7PM during the summer.

## Public Hearing & Vote to be Held on Parker School

The Cortland City School district will hold a public hearing of qualified voters of the Cortland Enlarged City School District on March 24th, 2020 at the Kaufman Center, 1 Valley View Drive, Cortland NY, at 6:30 PM. The Public Hearing will be held for the public to speak on a proposition vote that will be held by paper ballot upon the adoption of a resolution to sell the Parker Elementary School building to the City of Cortland for the purchase price of \$91.00.

The vote will be held on March 31st between the hours of 12:00 noon and 9:00 PM at the Kaufman Center, 1 Valley View Drive, Cortland New York.

**Proposition:** Shall the Board of Education be authorized to sell to the City of Cortland the building, grounds and improvements known as the former Parker Elementary school, being further known as tax map parcel # 86.49-01-02.000, containing 2.30 acres, and tax map parcel #86.49-01.000 containing 0.33 acre for a purchase price of \$91.00?

## Cortland County Legislator

People on the legislative agenda: Catherine Fuerherm, Public Health Director, is retiring after 31 years of service. Mark Thayer, Mental Health Director, is moving on after nine years of stellar service. Shannon Phillips was appointed Employment & Training Director. Best wishes to each.

March was designated Agriculture and Awareness Day in recognition of Cortland County's number one industry. Approval was given to distribute fourth quarter sales tax. Harford will receive \$72,470.32 and Virgil \$196,786.29. I voted no along with Ron Van Dee. All other legislators voted yes on a resolution to "Amend 2020 Budget \$ Transfer \$600,000 from the Jail Reserve to the Cortland County General Fund"; specially \$250,000 for professional services, \$29,675 for association dues and \$320,325 for a capital project reserve. My thinking was this. I supported paying the planning groups dues. I could support putting money in the general fund to fix the COB roof if that project proceeds. I do not support spending of up to \$250,000 on an efficiency study. I support transferring the money, but due to the details I couldn't support the resolution.

I support efficiency but not at that cost. We have talented people in our community including our newly appointed county administrator with the skills to help lead us to possibly the same conclusions. And guess what - in years past we have held successful summits at no costs to do just that. Maybe not a slick colored brochure at the end, but there were results none the less.

A few short months ago we were all anguishing over cutting senior center hours, and many other worthy budget considerations. Now to throw that amount of money for that is not my idea of a prudent spending.

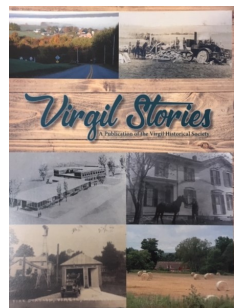
The first volume contained tales of history, mystery and coming of age. Readers enjoyed the retelling of local ad-

For this particular evening's entertainment, someone suggested having a mock wedding. A very willing couple volunteered to act as bride and groom. Bridesmaids and Ushers were assigned. The minister, Mr. Crumb, lived next door to the West Meeting House and was called over to perform the ceremony.

The ceremony proceeded. A delightful celebration followed the ceremony, as is usual at weddings. In the days that followed, the story of the evening's activities was spread through town and it

came to Mr. Crumb's ears that this was supposed to have been a mock wedding. He disagreed with this, stating that no such idea had been made clear to him, and as far as he was concerned, the couple was legally married.

The participants were horrified. The town was abuzz with gossip. Finally, calmer heads prevailed and all involved appeared at the home of Page Green. Mr. Green practiced law in the area, although he was not a member of the bar.

After listening to all the evidence, Mr. Green charged them \$5.00 and declared: "What God and the old minister has joined together, I, Page Green, set asunder." Everyone breathed a sigh of relief.
