

Raffle Official Rules

April 1 – April 25, 2025

- 1. Ticket Availability & Requirements: A maximum of 1,000 tickets will be sold, numbered 000 to 999. Keep your ticket safe—it is required to claim a prize.
- 2. Ticket Donation: Each ticket is available for a \$35 donation, or you can get 4 tickets for \$100. There is no limit to the number of tickets you may purchase. Ticket sales end when all 1,000 tickets are sold or at midnight on March 31, 2025, whichever comes first. Raffle ticket donations do not qualify as tax-deductible contributions under IRS rules.
- 3. Prizes: All prizes are awarded as stated.
- 4. Daily Drawings:
- Drawings occur daily from April 1 to April 25, 2025.
- The winning number each day is based on the Florida Lottery Midday Pick-3 drawing.
 - 5. Winning More Than Once: If your ticket number matches the Florida Lottery Midday Pick-3 more than once, you can win multiple times. All 1,000 ticket numbers are entered into each daily drawing. Prizes will only be awarded to ticket numbers sold.

- 6. Winner Announcements: Winning ticket numbers will be posted on the Grillin' in the Breeze Facebook page. Winners' names will not be publicly posted.
- 7. Claiming Prizes:
- Winners will be contacted using the email and phone number provided on their ticket stub.
- Instructions will be given on where to pick up prizes.
- Winners must present the winning ticket (physical or electronic copy) to claim their prize.
- All prizes must be claimed, and transfers completed within 30 days of the draw date.
 - 8. Gift Certificate Prizes:
- Issued as a gift certificate redeemable at The Butcher Shoppe, 2405 Langley Ave, Pensacola, FL 32504.
- The certificate can be used for any in-store items, including local and state taxes and shipping costs (fresh or frozen).
 - 9. Prize Pick-Up: Many prizes are large and heavy. Winners must pick up oversized items from the designated location, as shipping is not available.
 - 10. About the Event:
- Grillin' in the Breeze is an annual event in Gulf Breeze, FL, organized by the 501(c)(3) Santa Rosa Education Foundation.
- Proceeds benefit the foundation's programs, including Take Stock in Children.
 - 11. Legal & Compliance:
- FL Registration # CH 16219 Official registration and financial information are available through the Florida Division of Consumer Services/Check-A-Charity website.

- 12. Prize Funding: Raffle prizes are funded through sponsorships and proceeds from Grillin' in the Breeze.
- 13. Eligibility: Participants must be at least 21 years old and legal residents of the U.S. to obtain a ticket.
- 14. Legal Restrictions: The raffle is void where prohibited. No purchase necessary, contact us for directions.
- 15. Liability: By obtaining a ticket, participants agree that the liability of the Santa Rosa Education Foundation and Grillin' in the Breeze is limited to the donation amount for that ticket.
- 16. Taxes: Winners are responsible for any applicable federal, state, and local taxes.
- 17. Prize Substitutions: All prizes have been prepurchased and will be awarded as-is with no guarantees from The Santa Rosa Education Foundation. If a prize becomes unavailable for any reason, The Santa Rosa Education Foundation reserves the right to substitute an item of equal or greater value.
- 18. Odds of winning: Odds of winning depend on the number of tickets sold. If all 1,000 tickets are sold, each ticket has a 1 in 1,000 chance of winning daily.
