CIRCULAR TO ALL BRANCHES/ OFFICES IN INDIA.

Re: Revision in Staff Housing Loan Scheme.

We request reference to circular No. BCC:BR:106/484 dated 8.12.2014, circular No. BCC:BR:107/117 dated 9.3.2015 advising revisions in the Staff Housing Loan Scheme of the Bank and Master Circular on Staff Loans No. HO:BR:112/284 dated 29.6.2020 *inter alia* compiling the various guidelines issued thereafter in the matter.

We are now pleased to inform that the Board of Directors, in their meeting held on 25th March 2021, have approved further revisions in the limits of Staff Housing Loan Scheme taking into consideration, the increase in the real estate prices since the last revision in staff housing loan limits in 2014. The revised limits are detailed as under:

A. <u>Loan Limit – 90% of the total cost of the house, subject to maximum limits prescribed</u> below, whichever is lower :-

^{*} Part-time sub-staff members will be eligible for applicable fraction of Rs. 45 lacs, pro-rata to the scale of wages drawn by them or 90% of the total cost of the house, whichever is lower.

It has been decided to include the Whole Time Directors for grant of home loan upto Rs. 125 lacs or 90% of the total cost of the house, whichever is lower, on the same terms and conditions of Staff Housing Loan Scheme of the Bank.

B. Additional Staff Housing Loan for Repairs, Maintenance, Enlargement, Renovations :-

All other terms and conditions of Staff Housing Loan remain unchanged.
