# Subject to repayment capacity [i.e. Total deductions on account of income Tax, Provident Fund, LIC premium, recovery towards loans (including interest servicing on Staff Overdraft & excluding flood/cyclone loans) and any other recovery, etc., should not exceed 60% of gross salary]

Employees who have availed the Clean overdraft facility for staff will not be eligible for availing any other staff loans except Housing loan, Conveyance loan, Special Demand loan for medical purposes and PF loan sanctioned by Trustees as per terms and conditions of sanction of the Staff overdraft facility.

All other terms and conditions of aforesaid circulars will remain unchanged.

We trust that this will provide more operational freedom to employees in matters pertaining to their financial affairs and requisite flexibility to plan out their financial outlay.
