There being a quorum, Mayor Penrod called the meeting of the Vienna City Council to order at 6:30 p.m.

# **NEW BUSINESS**

Mayor Penrod presented a plaque to Max Hook for his many years of service to the city. Penrod expressed the city's gratitude for Hook's dedication maintaining the ballpark fields and grounds.

Alderman Hill made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the October 15, 2025 Meeting Minutes, the Warrant (\$36,759.46) and the September Treasurer Report. Alderman Pitts seconded the motion. All in favor, motion carried.

Council reviewed Johnson County 911 letter of existing address changes to be made on North 6th Street. The council was in consent for the city to accept and adopt the new addresses.

Alderman Racey made a motion to Authorize and Approve Ordinance 25-08, An Ordinance extending the term of the Vienna Tax Increment Financing Redevelopment Plan and Project Area and Redevelopment Plan #1 to December 31, 2043. Alderman Elliot seconded the motion. All in favor, motion carried.

Alderman Moore made a motion to Authorize and Approve the city to sponsor the Johnson County CEO Program Escape Room in the amount of \$425.00 (General Funds). Alderman Tuey seconded the motion. All in favor, motion carried.

Alderman Racey made a motion to Authorize and Approve holiday ham/turkey for city employees in the amount of \$50.00 Kroger gift cards. Alderman Tuey seconded the motion. All in favor, motion carried.

# **PUBLIC COMMENT** – None

### **ELECTED/APPOINTED OFFICIALS**

Clerk Wright said she was contacted by the executive director of Shawnee Mass Transit inquiring if the city would provide a monthly donation to support the Vienna shuttle. Wright said they were trying to increase ridership as some could not afford the fares/pass fees. Council discussed and requested to have someone from Shawnee MTD attend the next council meeting for more detailed information.

Alderman Moore said the Halloween Trunk or Treat hosted by Britton Wrecker Service was a success.

Alderman Tuey briefly discussed 2026 Fourth of July fireworks.

Chief Miller said the Vienna High School was awarded a Cops Grant which included two Flock system safety trailers for the police department. Miller said the city would receive an invoice from Flock for the trailers but would be reimbursed. Miller also discussed amending a portion of the city's code of ordinances section 71.37-Trucks/Semis prohibited on certain streets and section 73.01-No parking places, to insert language regarding the blocking of mailboxes.

Fire Chief Williams said the department would submit for a small equipment grant. Williams updated that the state fire marshal grant received for department construction looked to break ground in mid-2026. Williams also said the primary engine needed repairs.

Mayor Penrod said the blessing box was relocated from behind the library to beside to the U of I extension building on Main St.

Mayor Penrod informed council that IDOT was in the process of getting appraisals for all three buildings involved in the partial roof collapse at the bottom of the square on n 4<sup>th</sup> Street.

As there was no further business to discuss, Alderman Tuey made a motion to adjourn. Seconded by Alderman Moore. Mayor Penrod declared the meeting adjourned at 7:20 p.m.
