ORDINANCE NO. 26-04

**AN ORDINANCE AMENDING CHAPTER 30, SECTION 30.02, COMPENSATION,
OF THE CODE OF ORDINANCES OF THE CITY OF VIENNA, ILLINOIS, TO
ADJUST COMPENSATION FOR ALDERMEN**

BE IT ORDAINED by the City Council of Vienna, Illinois:

SECTION 1: Chapter 30, City Council, Section 30.02, Compensation of the Code of Ordinances is hereby amended to read as follows:

§ 30.02 COMPENSATION.

Pursuant to **65 ILCS 5/3.1-50-15**, the compensation for the office of Alderman is amended/established at ~~\$50.00~~ **\$75.00** per regular meeting of the City Council.

Provided, however, a member shall not receive compensation for more than one (1) regular and/or special or committee meeting per week. All members shall be allowed two (2) absences in each year for which compensation will be paid, unless the absence is excused by council.

This rate shall take effect at the commencement of the next term of office following the **April 2027 consolidated election**, and shall apply only to those terms commencing after said election.

SECTION 2: This Ordinance shall be in full force and effect upon its passage and approval by the City Council of the City of Vienna, Johnson County, Illinois.
