ORDINANCE NO. 25-08

AN ORDINANCE EXTENDING THE TERM OF THE VIENNA TAX INCREMENT FINANCING REDEVELOPMENT PLAN AND PROJECT AREA AND REDEVELOPMENT PLAN #1 TO DECEMBER 31, 2043

WHEREAS, the City of Vienna (the "City"), on May 7, 2008, pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11- 74.4-1 et seq. (the "Act") adopted the Vienna Tax Increment Financing Redevelopment Plan (the "Plan"), established the Vienna Tax Increment Financing Redevelopment Project Area #1 (the "Area") and established tax increment financing ("TIF") for the Area pursuant to Ordinances 08-05, 08-06, and 08-07; and

WHEREAS, pursuant to Ordinance 08-05, the City established May 7, 2031, as the estimated date of completion and the retirement of obligations issued to finance for redevelopment project costs of the Redevelopment Plan and the Redevelopment Project; and

WHEREAS, pursuant to Public Act 104-0322, the City may, by ordinance, extend the term of the Redevelopment Project Area to 35 years; and

WHEREAS, Section 65 ILCS 5/11-74.4-3.5(c)(290) of the Act provides that, for the purposes of real property TIF under Section 11-74.4-8 of the Act, the estimated dates of completion of the redevelopment project and retirement of obligations issued to finance redevelopment project costs may not be later than December 31 of the year in which the payment to the municipal treasurer as provided in subsection (b) of Section 11-74.4-8 of the Act is to be made with respect to ad valorem taxes levied in the 35th calendar year after the year in which the ordinance approving the redevelopment project area was adopted if the ordinance was adopted on May 7, 2008 by the City of Vienna to create Vienna TIF #1; and

WHEREAS, the City Council of the City wishes to extend the term of the Redevelopment Project Area until December 31, 2043.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIENNA, ILLINOIS:

- Section 1: The term of the Vienna Tax Increment Financing Area #1 is extended until December 31, 2043.
- **Section 2:** Reaffirmation of Previous Action. All actions of the corporate authorities, proper officers, agents, and employees of the City taken regarding the adoption and extension of the Vienna Tax Increment Financing Redevelopment Project Area #1 and Redevelopment Plan, and their implementation are hereby ratified and reaffirmed.
- **Section 3:** Extension of Time. The estimated time for completion of the Vienna Tax Increment Financing Redevelopment Plan and Projects and the retirement of obligations issued to finance Redevelopment Projects Costs is hereby extended until and including the tax year 2043. Completion of projects shall include projects that are under contract on or before December 31, 2043, even if work is to be performed after that date.
- **Section 4:** Calculation of Tax Increment Financing accrual and disbursement. Taxes are accrued the year previous and collected and disbursed the following year. Thus, taxes accrued in 2025 are collected in 2026 and subsequently disbursed to the City of Vienna TIF #1 Fund. The final disbursement of tax increment financing revenues for the Vienna TIF #1 Redevelopment Project Area will accrue through December 31, 2043, be due and collected in 2044 and subsequently disbursed to the City of Vienna TIF #1 Fund.

employees of the City are hereby authorized, empowered and directed to do all such acts and to execute all such documents as may be necessary to carry out the intent and accomplish the purposes of this Ordinance.
Section 6: The City Clerk is hereby directed, within 10 days from the date of passage and approval, to forward a copy of this Ordinance by mail to each affected taxing district and registrant on the interested parties registry and publish a copy in the, a newspaper of general circulation within the affected taxing districts.
Section 7: This ordinance shall be in full force and effect immediately upon its passage.
