LIMITED 7 DAY WARRANTY

THE PUPPY YOU HAVE SELECTED IS WARRANTED BY THE BREEDER TO THE PURCHASER TO BE FREE OF DISEASE AT THE TIME OF PURCHASE. TO KEEP THIS WARRANTY IN EFFECT, YOU MUST HAVE YOUR PUPPY EXAMINED BY A LICENSED VETERINARIAN OF YOUR CHOICE WITHIN THREE (3) DAYS OF THE DATE OF PURCHASE BELOW. DURING THE INITIAL EXAM, SHOULD YOUR VETERINARIAN FIND THIS PUPPY HAVE DISEASE THAT WOULD REQUIRE FURTHER VETERINARY CARE OTHER THAN REQUIRED VACCINATIONS AND/OR WORMINGS, YOU MUST NOTIFY THE BREEDER WITHIN TWENTYFOUR (24) HOURS.

IN ACCORDANCE WITH THE ABOVE, THE BREEDER WARRANTIES YOUR PUPPY TO BE FREE FROM PARVOVIRUS, DISTEMPER, HEPATITIS, CORONA VIRUS, KENNEL COUGH, AND CANINE INFLUENZA FOR A FULL SEVEN (7) DAYS FROM THE DATE OF PURCHASE. SHOULD YOUR VETERINARIAN DETECT WITH A TRUE-POSITIVE TEST OF ANY OF THE ABOVE-MENTIONED DISEASES, & CONSIDERATION FOR THE TIMING OF THE LAST VACCINATION, WITHIN THE SEVEN (7) DAY PERIOD IMMEDIATELY FOLLOWING YOUR PURCHASE, YOU MUST NOTIFY YOUR BREEDER WITHIN TWENTYFOUR (24) HOURS. YOU MAY THEN CHOOSE A REPLACEMENT PUPPY AT THAT TIME OR WHEN AVAILABLE

LIMITED 26/12 MONTHS EXTENDED WARRANTY

THE BREEDER WARRANTS YOUR PUPPY FOR 26 MONTHS FROM THE DATE OF PURCHASE AGAINST HIP, ELBOW & EYE DEFECTS THAT MAY INTERFERE WITH YOUR PUPPY'S ABILITY TO LEAD A NORMAL LIFE. THE BREEDER WARRANTS YOUR PUPPY FOR 12 MONTHS FROM THE DATE OF PURCHASE FOR ALL OTHER HEREDITARY DEFECTS THAT MAY INTERFERE WITH YOUR PUPPY'S ABILITY TO LEAD A NORMAL LIFE. THE BREEDER PROVIDES YOUR PUPPY SOLELY FOR THE PURPOSE OF A COMPANION PET. THERE IS NO WARRANTY EXPRESSED OR IMPLIED THAT YOU WILL BE ABLE TO USE YOUR PET FOR SHOWING OR BREEDING PURPOSES.

IN THE EVENT THAT YOUR LICENSED OFA VETERINARIAN CERTIFIES YOUR PUPPY TO HAVE HIP, ELBOW OR EYE DEFECTS, WITHIN 26 MONTHS, OR YOUR LICENSED VETERINARIAN CERTIFIES YOUR PUPPY TO HAVE ANY OTHER HEREDITARY DEFECT WITHIN 12 MONTHS, YOU MUST SUPPLY THE BREEDER WITH THE VETERINARIAN'S WRITTEN REPORT WITHIN FORTYEIGHT (48) HOURS OF DIAGNOSIS. YOU MAY THEN CHOOSE A REPLACEMENT PUPPY AT THAT TIME OR WHEN AVAILABLE.

LIMITATION OF LIABILITY

BUYER HAS READ AND UNDERSTANDS THE BREEDERS WARRANTY AND ACKNOWLEDGES THAT ARE NO CASH REFUNDS OR REIMBURSEMENT OF VETERINARIAN FEES FOR THE INITIAL EXAMINATION OR FOR ANY OTHER VETERINARY SERVICES RENDERED, NOR REIMBURSEMENT FOR CONSEQUENTIAL OR INCIDENTAL EXPENSES WILL BE MADE, AND THAT THE INITIAL EXAMINATION AND THE TIMELY SUBMISSION OF VETERINARY REPORTS ARE CONDITIONS PRECEDENT TO THE EFFECTIVENESS OF THE WARRANTY.

THE ABOVE CONSTITUTE THE ENTIRE WARRANTY PROVIDED BY YOUR BREEDER. THE BUYER AGREES THAT THERE ARE NO OTHER WARRANTIES THAT EXTEND BEYOND THE WARRANTY IN THIS DOCUMENT. TO BE ELIGIBLE FOR THE WARRANTY, YOU MUST KEEP THE PUPPY UNDER ANNUAL AND CONTINUED CARE OF A LICENSED VETERINARIAN. CARE MUST INCLUDE ANNUAL VACCINATIONS AND REGULAR WORMINGS, AS RECOMMENDED BY YOUR VETERINARIAN. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.
