


BAY AREA ALLIANCE FOR YOUTH & FAMILIES ANNUAL REPORT FY2015



Additional Trends Identified by the TPII

(Compiled by Research and Educational Services)

83.5 % of students surveyed stated that youth in the community obtained alcohol through house parties, friends or their friend's homes, other adults, or from parents with or without permission.

73.6 % of students surveyed cited that their parents disapproved of them using alcohol.

89.1% of students surveyed cited that their parents disapproved of them using marijuana.

89.7% of students surveyed cited that their parents disapproved of them using cigarettes.

95.3% of students surveyed perceive *cigarettes* as harmful as compared to 66.8% for *alcohol* and 75% for *marijuana*.



Medication Take Back Events & Permanent Drop Box

Since September of 2010, over **2,400** community members have participated in ten Medication Take Back events coordinated by the Alliance and partnering with local law enforcement. In September of 2014, the Drug Enforcement Administration enacted new procedures to encourage local entities to be responsible for the disposal of medication and announced that the September 27, 2014 Medication Take Back would be the last one sponsored and funded by the DEA. Thanks to the commitment of League City and Nassau Bay PD, these Take Back events continued in April of 2015 with the Bay Area Medication Take Back Day. Through all of these events since 2010, this initiative has helped to dispose of over **9,455** pounds of unwanted, unused, or expired medications.

On February 25, 2015, the City of Nassau Bay hosted a Ribbon Cutting for a Permanent Drop Box in their City Hall outside the Police Department. This initiative is valuable as it provides a permanent option for medication disposal.



CRAZY Krewe

CRAZY Krewe was created in 2010 to provide an avenue to communicate important family prevention messages to the community while also lending itself to fundraising and increased visibility of the community effort. March 7, 2015 was the fifth annual CRAZY Krewe event at Clear View High School. The morning began with a 7K Run over the Nasa Bypass (the only race of its kind) and a 3K Family Walk. After the race, there was an after-party with various healthy-family related vendors providing activities and information in addition to lots of games and prizes. The Alliance and SALSA students also provided Asset-Building activities to help build the 40 Developmental Assets in our community.



Be the Reason!

Did you know that 83% of youth who report they do not drink alcohol cite their parents as the number one reason for their decision? Many parents today are under the misconception that their teenage children don't listen to them. The reality is that parents and other adults have more impact than they know! To help underscore this principal, the Alliance created a new campaign this year entitled "Be the Reason!" We've asked our partners and everyone in our community to take a photo and post it on our Facebook and Twitter Accounts to take a stand and "Be the Reason!" Many of these photos have been highlighted in local magazines and newspapers to be an encouragement to parents!



Character Crusade and Family Game Night at Ross Elementary

The Alliance partnered with Thrivent Financial to bring Ross Families together for a Character Crusade on November 14. At this event, students and their families' demonstrated character as their "super power" as they put together baskets for local nursing home residents, made lip balm cards for local First Responders, and packaged gifts for the homeless. Ross PTA sponsored this event and provided dinner for all attendees.

The second ever Alliance Family Game Night was held at Ross Elementary School on Friday, April 10. The idea behind Family Game Night was to encourage families to set aside time to interact and have fun while promoting positive conversations. Game correlations with the TEKS (Texas Essential Knowledge and Skills) were also provided to help parents learn new ways to improve their children skills using board and card games. ACU of Texas sponsored this event and provided pizza for all attendees.



SALSA

Student Adult Leadership Service Alliance

As part of a grant from the Texas Department of State Health Services called THAI (Texas Healthy Adolescent Initiative), the Alliance has worked with Clear View HS to create a Youth Adult Committee. This committee provides equal voice to both youth and adults while addressing several risk factors including substance abuse, mental health disparities, and transition to adulthood. As of May 2015, this group consists of 31 youth and 9 adults. The group voted to name themselves SALSA – Student Adult Leadership Service Alliance.



Texas Healthy Adolescent Initiative THAI

In September, the Alliance was awarded a grant by the Texas Department of State Health Services as one of nine pilot projects in the State of Texas. This initiative is focused on addressing seven possible risk factors including substance abuse, mental health, and transition to adulthood. Along with the Youth Adult Council, SALSA, the Alliance has also worked with Clear View HS to support the first year of the Peer Assistance and Leadership (PAL) and hosted a number of campus-wide events and activities including "Don't Let Drugs Make You a Monster," "Love Above Week," and a prom week alcohol awareness campaign. The THAI project also worked to increase community involvement at CVHS by hosting a Christmas Open House, a breakfast for leaders at the City of Webster, and assisted with the hosting of CCISD's Senior 2 Senior Prom.



A Bitter Pill to Swallow & Legalization Landscape: What Law Enforcement Needs to Know

This year, the Alliance partnered with the Drug Enforcement Administration, Houston High Intensity Drug Trafficking Area (HIDTA) office, and the US Attorney's Office to bring some great speakers to the Bay Area. On September 18, 2014, we hosted a full-day training at the Green Event Center focused specifically on the dangers of prescription drug abuse. We were so fortunate to have had Joseph Rannazzisi, Assistant Deputy Director of DEA to provide a national update of the prescription drug epidemic. We also had Jeff Walterscheid, Ph.D., D-ABFT and Dwayne A. Wolf, M.D., Ph.D. with the Harris County Institute of Forensic Sciences provide a snapshot of how the epidemic is affecting our communities. On April 17, we had Monte Stiles come to the South Shore Harbour Resort to present a "Legalization Landscape: What Law Enforcement Needs to Know." Representatives from many of our local law enforcement agencies were in attendance for this luncheon.



Evaluation and Efficacy

The Alliance has a Program Development Committee that works through an evaluation matrix alongside our independent evaluator to look at both quantitative as well as qualitative outcomes of each strategy. This committee meets regularly to review results of each initiative including surveys, general outputs, committee summaries, and other data provided by volunteers, staff, and the evaluator.

Utilizing the matrix, the Program Development Committee then asks certain questions regarding sustainability including cost, increase in partnerships, benefit to community, success in mission, and ease of replication. They also make suggestions for increased success or recommendations to revise and rethink if the program was not successful.

Evaluation is the key to the Strategic Prevention Framework and one in which the Alliance is particularly committed. This Committee has been instrumental in the success of the Alliance's growth and helping identify both strengths and weaknesses as the Executive Board looks at future sustainability.
