The Plot To End America

Foreword

My name is Rich Marin and I am an independent investigative journalist. I have been trying to expose the plot to end America that is playing out on the news. I have sent information to hundreds of journalists over the course of the past year in an effort to stop this plot. I allege that it's been adapted to time and that the candidate that they have in mind is Vice Presidential Candidate J. D. Vance, of Middletown, Ohio – mere miles from Centerville, Ohio, the location I allege is the home of this conspiracy.

I first testified at length about this plot in 2019 to Senator Bernie Sanders at Hahnemann Hospital, which I believe led directly to preparedness measures against the coronavirus pandemic. It's also entirely possible my testimony was completely suppressed and it's the group that planned COVID-19 who have the dominant narrative. That's why I'm publishing this book.

However evil this plot is, however cruel these individuals have been, the answer to refusing what they are trying to force upon us is to say no. To share the truth without bias and to learn the truth without bias. My messages were ignored by hundreds of people, more chose not to act in a way that would be consistent with stopping the plot and not allowing it to move forward.

I do not believe that the most culpable individuals are our elected officials – I believe that they are the unelected and often unchecked individuals in secretive agencies such as the CIA. I name the Central Intelligence Agency as the originator of the plot, but it was a group of individuals who carried it out. I have extremely detailed information and sources at some of the highest levels who have been sharing information in the honest effort of saving the country.

The escalating international crises are a direct result of the plans of this group and their ideologies being enacted. Some of these ideas have been passed off as innocuous ideas, but have extremely harmful and detrimental effects because by the nature of their implementation, they force actions upon people. We are in a hostage situation to a band of lies.

Our food supply is being tainted and humans are experiencing the massive influx of mental pain that comes from prions, caused by cannibalism. That plot is by a cult called the Golden Dawn, a cannibalistic cult that created the McDonald's franchise. Our water supply is tainted with fluoride, a drug intended to slow our mental faculties and fail to see reason. That plot was enacted by Nazis who were brought over to control the populace by American businesspeople who believed they could control their evil.

There is a confluence of events occurring right now, and I hope to provide some context.

Learning About The Plan - 2009

In early 2009, I was in contact with a man named Ralph Attanasia III, who I knew from the underground music scene and had just recently started appearing on television, working at Carlo's Bakery as a cake artist for the Cake Boss, Buddy Valastro.

I had learned at a prior event that he had invited me to that he had been recruited by the CIA, and I had intended to find out as much as possible about why and how they recruited him.

I visited him in New Jersey, and the following excerpt is of the interactions that led to me learning about the plot that is presently unfolding in enough detail to do something about it. The conversation starts with the CIA agent who I believe recruited him, Paige Pinckney.

She had me sit down and I asked her why she was going along with whatever the CIA had planned if it meant Ralph would die. I said that if she was his girlfriend she must have some attachment to him. She agreed that she liked Ralph but the Agency had big plans for him. I asked her what big plans entailed. She said that if the drugs didn't work, she would have Ralph wrap me in a rug and dump me in a river, so she would discuss some of it. I told her that Ralph wouldn't want to do that and she replied that he's already done things he hasn't wanted to.

She began by telling me that being in intelligence is less about spying and more about killing people that could potentially be a problem. One of the missions of the agency was to keep the racial breakdown of America relatively the same, which generally meant sabotaging minority communities to prevent them from growing or becoming more influential.

She said that she was involved to fight for what she saw as the real America, the one with no economic opportunities and crumbling infrastructure compared to the relatively well off urban areas on the coasts. I replied that just because the buildings looked nicer didn't mean that people were much more well off. She doubted that, but went on.

She said that this was all surrounding the 2020 election and that the ultimate goal of the plans was to institute open fascism. I questioned why fascism and she said that she didn't know; that the architects had possibly determined that was the ideal form of government to preserve the most number of lives in a harsh future. She then went on to say that there would be a lot coming that would mean hard decisions would have to be made.

First, she said that in 2016, two candidates would run against each other - both very unlikeable. The Democrats would likely run Hillary Clinton and the CIA had a very unlikeable candidate lined up. After a long and vitriolic election cycle, their unlikeable candidate would win, with the appearance of being helped by outside foreign actors. In reality, it would be the CIA influencing the election.

He would be used to implement some of the worst policies imaginable. It would be a trial balloon for the upcoming fascist state. He would use the excuse of a caravan of migrants to institute concentration camps and use it as motivation for being a terrible, unlikeable president.

Eventually, she said, he would be impeached but not removed from office.

Parallel to that, she and Ralph would get engaged and he would make efforts to become an actor. The engagement would run long and they would never marry and his attempts at becoming an actor would fail. This would serve as a narrative for why he would then assassinate the president during the Easter Egg Roll at the White House. This would serve to have his Vice President be the candidate in 2016 and continue with more or less the same administration.

She also mentioned that Pete Buttigieg would run and that he and Chasten were both CIA groomed for the role.

They would also push Bernie Sanders to run and lose - "discrediting socialism". The agency planned to manipulate as much of the election cycle as possible to maximize their likelihood to push through their narratives.

There would be other factors involved in pushing America towards fascism. In late 2019 an agency would release a virus that Paige was told was a weapon of war in China from a lab in China. It would prevent the nation from taking a larger role on the world stage but she was told that it wasn't really going to spread here. It would be used as an excuse to institute a quarantine, which would be in place during the big event - a 4 km asteroid that would hit near Venezuela on April 29th 2020.

It was large enough that it would wipe out part of South America, Cuba, and Haiti. With all of that happening, the idea was that the only viable way forward for America would be a fascist state. Eight years of a far right government would lock up the Supreme Court for the next half-century and it would be impossible to pull society to the left once such a government was entrenched.

I questioned this as she told me about it. I asked why fascism and why not socialism or communism? She offered Venezuela as an example of a failed socialist state, to which I replied by saying that the CIA had a long history of sabotaging socialist and communist nations. There wasn't a good example of the system working because the CIA always intervened.

I said that it sounded like she would be in the public eye.

How did she know that they wouldn't have Ralph or whoever would actually be the trigger man kill her, too?

She replied that she was loyal and that part of the plan involved her going on TV and pushing the narrative that the CIA had set up. They would give her money in a one-time payment to live off of.

I asked her if there was a way for all of this to happen without Ralph dying. She said that if he didn't do it, some other patriot would. I asked her how she could do that to someone who she cared about. She said that she liked Ralph, but her mission came first. She said that the reason she agreed to be with him was because he reminded her of me and how kind I was when she escorted me through the program in New Orleans. I told her that I didn't remember and she said that I wouldn't.

She told me a bit about what happened, but nothing too specific. I would remember it on my own, later.

At that point she said that it was time to stop talking and told me to lay down next to a rolled up rug and watch TV. I fell asleep at that point and was awoken shortly after by Ralph telling Paige that he had looked me up on her handheld and that I was on a protected list. He told me to get up and I apologized, saying that I must have had too much to drink. I feigned not remembering anything and Ralph drove me back to the train station.

I told him on the way about Paige's mission but I

specifically told him that she did seem to really care for him. If there was another option, she might take it. He dropped me off at the platform and told me that his life was too dangerous for us to keep hanging out. I agreed.

On the train ride back from Ralph's, I felt the memory of what I had learned slipping away, so I began repeating it to myself in my head. I might have made a note in my phone but I found it difficult to operate.

As soon as I got in, I rushed home and told both of my parents that "Cake Boss Ralph was going to kill the next President." I had no memory of their previous association with the CIA so I had no reason to distrust them at the time. I mentioned the flu-like disease and the asteroid, but my mind was fixated on that one phrase. I couldn't stop repeating it, so they called a neurologist. I

don't recall his name but I selected it from the phone book.

He made a house call and diagnosed it as a benzo loop.

He said that it was due to a thought getting stuck in my head while being under the influence of hyoscine which he was aware of being used by the CIA. My parents asked him how he could know that and he said that he had come across it once or twice before. He said that the solution would be to give me another dose and do my best to clear my head while under the influence. I didn't want to forget, but it was such a persistent influence. I didn't want to forget, but it was so persistent that I didn't really think I had a choice.

After I took it, he told me that I would have to be held for a mandatory observation period at the local hospital.

I didn't have a choice, so I went with him. After around an hour or two, a CIA station chief came and drugged me again. He said that they were government secrets, not my secrets and to let them go. If I didn't forget them they would have to kill me.

I was released after an overnight stay and told my father that I still remembered everything. I insisted on doing something, so he made an appointment at the New York State Federal building a couple days later. The person we met there said that if it had to do with the CIA, it was outside of his jurisdiction and that they knew more about the structure of America than anyone. He drugged me but not my father. I promised my father that I would leave it alone as long as he told his parents to get out of Florida before the asteroid hit. He agreed.

After that, I wrote down the things other than the

asteroid, which I knew I couldn't do anything about on my own. China, the 2020 election and planned assassination, and contacting Senator Sanders would be the things I could try to affect.

I decided that I had to do something, so I thought about what I could possibly do to set something in motion ten years in advance. I decided on two things - I would send an email or letter to Senator Sanders, who Paige had confirmed was not part of the CIA. I would also meet with a friend from college, who was an aspiring journalist. I would tell her what I knew about the virus and the hopes that it could be prevented. I texted her and asked if she would be able to meet in person about something related to being a journalist.

She agreed to meet with me at the outside food court at Penn Station. After confirming that, I created a burner AOL account and wrote an email to Bernie Sanders. I told him that the CIA was planning something around the 2020 election and he would be pushed into entering the race. They did not think he would be able to win but I thought he could.

I said that if he was able to push the youth turnout and run a strong issues based campaign, he had a chance. He would have a lot of opponents but he would have the strongest message. He would also need to be aware of the labyrinthine caucus rules. If he made it to the general election, his opponent on election day would not be the same one he was initially running against. I sent the message and nearly immediately received a reply saying that he was aware of rumblings around 2020 and that he was shown my email. I deleted the account after that.

A few days later, I met with my friend at Penn Station.

However, as soon as I got there, I was ambushed by Paige and a taller male CIA agent. She asked me why I had contacted her and she was very interested in what I was planning to tell her. I stammered that it was nothing, but she insisted on putting a wire on me and told me that if I said anything, they would kill me.

I met with my friend, who had a bowl of miso soup. I tried to think of how I could communicate in any way.

The best I could do was write the word of the province the lab that the virus was going to be leaked from on a piece of paper and ask her if she knew what it was. She said that it was a province in China and asked why I wrote it. I said that something was going to happen there in 10 years, but I couldn't say. She became frustrated and left.

Paige and the other agent returned and said that my friend was drugged via the soup and wouldn't remember, then drugged me too. She said that I hadn't revealed any state secrets but they would be keeping a close eye on me.

The following is an excerpt from a prior book, *An American Reich: Exposing The Nazi Cult In The CIA*. It is of the final chapter, which I believe is the most relevant considering the nature of the call I had with him on February 10th, 2024. I consider the group that I provided detailed testimony to him regarding, The Reich, to be one of the greatest single threats to the world at this time.

The below summarizes much of the substance of the testimony I provided to him, testimony that he confirmed having heard in the recorded call below. It is my hope that mainstream media and journalists who are willing to pursue this story hold the Senator to his promise of committing to an investigation and prosecuting these individuals, who are responsible for far more than people know at this time.

“Senator Bernie Sanders”

As I distrusted most federal authorities, but had previously reached out to Senator Bernie Sanders in 2009 regarding the plans that The Reich had planned to enact through the CIA, I decided to speak with him, if at all possible. I was living in Pennsylvania at the time and found that he would be speaking at Hahnemann Hospital just over a week after I had made up my mind.

I parked my car at Doylestown Train Station, having had taken leave of work and knowing that my wife at the time would be occupied at her job. I took the SEPTA train to Philadelphia and walked to the hospital, realizing when I got there that the event was sold out that I would have to somehow get to the Senator by other means.

He had just finished speaking outside so I asked what the remainder of his schedule looked like. I was told by the attendant that he would be speaking inside with donors and would then be leaving. I thanked the attendant, turned towards the hospital and walked inside.

I recognized that the room directly to the right of the entrance was where he was speaking with donors and walked in just as if I was meant to be there, not waiting to see if I was being followed by security. I spotted the Senator immediately, standing towards the right of the stage at floor level, speaking with several people.

Knowing that I could be apprehended at any moment but that if I missed this chance I would not get another I approached him and recited what I had been going over in my head on the way there “Senator Sanders, I reached out to you ten years ago about the CIA’s plans for the 2020 election. I found out a lot more and it’s a lot worse.”

He seemed surprised but quickly asked “How much worse?” “If everything they plan for happens, a lot of people will die.” He told the security guards who had apparently followed me that it was okay and had an aide bring one into a side room to the right side of the auditorium, down the hall several feet and on the right.

Once I sat down towards the back of the room across from the door, the aide bent down and began looking furtively in a mini fridge to the left of it. I asked him what he was doing. and he told me that I must be stressed out and so he was offering me a drink to cool my nerves. Sensing a pending hyoscine drugging about to happen, I asked him what kind of drink and he replied that it was like liquor.

Knowing that my best shot would be to keep him talking and delay him until Senator Sanders was finished speaking with donors, I told him that I was very particular about my alcoholic beverages and considered myself to be a bit of a mixologist, asking him what liquor it was closest to. Visibly frustrated by my questions he replied that it was closest to vodka. That seemed to confirm my suspicions.

“In that case.” I replied, “can I have a diet soda as a mixer?” Careful to not reveal that I knew that he was planning to drug me, I played dumb and even offered him change for the vending machine. He briefly left and I waited, trying to work out if it seemed like I would actually have a chance to speak with the Senator or if this aide would successfully deter me.

I didn’t have much time as he returned just a moment later with the soda and poured it and a vial of clear substance, the hyoscine into a cup. I took the cup from him and followed his eyes with mine as I took an exaggerated sip, trusting my experience resisting the drug previously to help me retain control. It worked.

I let out a laugh and kept drinking. He seemed relieved and that’s when I asked him how long it would be until I spoke with Bernie. He told me that he wouldn’t be speaking with me because I wouldn’t be there when he got back. I asked him why that would be, that I wasn’t planning on going anywhere. Then, realizing he was planning on taking advantage of the drug’s effects and suggesting that I leave and forget the meeting, I played my only card. “Here’s the thing,” I said, taking another sip. “This stuff doesn’t affect me like it affects other people. I’m not going anywhere.” At that he turned pale and ran out of the room down the hall to the right.

Immediately after, Bernie Sanders and a younger man in his 30's rushed into the room; Bernie asked what had just happened. I explained that the aide had drugged me and Bernie told the younger man to go get him, turning to me and apologized that it happened.

I said that I was fine and that there was a chance that due to the nature of the drug I might actually remember more. He asked me if I would be okay to still give testimony and I told him that was what I was there to do. I asked him if this room was safe, considering the actions of the aide and he confirmed that it was as safe as any other room in a similar building.

I don't recall the exact sequence of events immediately after, but the aide was apprehended and brought back into the room by the younger man. That man, who introduced himself as Faiz Shakir, said that the aide was at the end of the hall trying to make a phone call, presumably to his superiors. I made the assertion that he was almost certainly CIA as the drug he administered me was something that they used in interrogations and to make people forget. Bernie's reaction seemed to be disbelief, that he seemed like a regular aide, but I told him that was how they got you.

I let Faiz and Bernie know to look in the fridge for a black bag, which Faiz pulled out. Bernie said that the aide had claimed that he was diabetic and that it contained insulin, but I identified that as the bag that he had taken the hyoscine out of. At that point, they brought the aide out of the room and returned without him, telling me that he would be waiting, presumably being watched over by other staff. At that point, Bernie asked me exactly what I was there to tell him.

I began by explaining that I had sent him an email approximately ten years prior telling him that the CIA had plans culminating with the 2020 election, involving him, and that was how I knew that I could trust him. He asked me what I meant and I told him that when I learned of their plans, the agent that I spoke with claimed that they had selected him to convince to enter the 2020 race as they believed him to be so far to the left so as to discredit the cause and that he was outside of the influence of the agency. He said that he had always known that the CIA was corrupt, but he was acting on his own politically and had no other affiliation beyond that of himself and his supporters.

I asked him how loyal to the political left he was and he said that he had a poster of a labor leader whose name I did not immediately recognize framed at his home in Vermont. I felt a bit foolish for asking the question like that, but in my experience, the CIA corrupts people by offering people something otherwise beyond their means at far below it's value.

As my personal history was marked by betrayal, especially during attempts to reach out to law enforcement and higher authorities. I wanted to ensure, as much as possible, that my testimony would be given to someone who would act on it in the face of such temptation. I explained as much to him and he seemed to understand.

At that point. Faiz began taking notes and I began by giving my full name, Richard Anthony Marin. I had first become aware of the CIA's plans for 2020 approximately ten years prior and had more recently discovered that the corruption ran far deeper. I had recently learned from a long conversation with Jean Marin, my apparent biological mother and daughter of Adolf Hitler, that I was not only related to one of the most reviled men in human history, but that the remnants of the Third Reich had established themselves in America and were acting through the Central Intelligence Agency.

I do not recall exactly where my testimony began, but I will recount it here to the best of my ability. I answered several clarifying questions, which I will include.

Broadly, their plan, consisting of several seemingly unrelated operations, was intended to destabilize the United States to the degree that it would be receptive to openly fascist rule and openly take power after establishing conservative rule in all three branches of government. Their plans began with the 2016 election, using their resources to make it appear that a foreign nation had interfered in favor of Donald Trump, their preferred candidate. He was not privy to their machinations and, according to Jean, had been too difficult for them to keep in line, which is why they placed Bill Barr in his administration.

At that point, I described the structure of The Reich and how Barr was loyal to them and had been since the start of his career, later providing a favorable plea deal to Jeffrey Epstein to buy his silence regarding their mutual cooperation in setting up a human trafficking operation on Little Saint James.

I also provided detailed testimony regarding his hosting of Jean and her ex-husband turned bodyguard, Richie, during her recruitment of a college student to the CIA, I detailed how she held a diner at the Barr home, drugged him and a female friend, and induced him to murder her in an initiation killing. I also explained that I had made contact with that same person years later and that he agreed to help take them down. He also said that he would be willing to testify in full once sufficient evidence was presented. Both of us know that extracting such a deeply rooted corruption would take years of work and testimony from any one individual wouldn't be enough without the support of at least one Senator and one Representative.

While Donald Trump was in office, they intended to enact a plan formulated by Stephen Miller, who described it as turning immigration centers into concentration camps to deter and harm both individuals without valid immigration papers and incoming refugees and migrants. The intent of this plan was to use existing immigration infrastructure and enforcement laws to quietly commit cultural genocide in a way that would not attract public outcry — Miller had described the smoke-stacks of the Holocaust as a “public relations nightmare”.

Miller had a clearly stated desire to transform America into a “white European ethnostate” and had attempted to reach out to me in 2006 in an attempt to recruit me because of my family connection to the Nazis. I rebuffed this attempt and reported him, but later learned that the agent I reported him to recruited him for their efforts, likely under the guise of legitimately recruiting him as a CIA asset.

At the point I was giving Senator Sanders my testimony, these policies were already in place and being opposed politically, but it wasn't going to The Reich's satisfaction, in large part because of Donald Trump's desire to be liked by everyone. As Miller described it to me in 2006, very few political leaders write or fully flesh out their own policy, relying on staffers and outside groups to craft and construct it instead. His desire to be that in the Trump policy team was out weighed by other voices, not all of them loyal to the ideologies he was selling.

Despite his political views taking prominence early in the Trump administration, the Reich understood that they would be a hard sell on the surface without a sociopolitical climate that would prime the populace into being receptive to them. In the absence of such a climate they had plans to manufacture one starting in late 2019, just months away.

They would begin with the intentional release of a coronavirus, a term that I wasn't aware defined a class of viruses. Faiz Shakir, who had mostly been taking notes at that point, said that he recognized the term. I asked him if he had heard about this specific virus from someone, but he clarified that it was a term for a specific family of viruses referring to an aspect of their structure.

I described it as something like a flu but worse, intended to be released first from a lab in a specific province in China, then expected to spread to the United States. I was told that it was being held in the lab by Chinese scientists, working for the military, as a potential bioweapon for use against naval vessels as it had a longer than normal incubation period of approximately three weeks and was airborne in nature. I had learned that the CIA agent who would leak it from the lab would do so with an apparent goal of destabilizing China, being told specifically that it would not make it to the United States populace. They were also told it was not any more deadly than a flu and that leaking it would cause illness, not death, primarily. This was a lie.

The Reich had always intended for the coronavirus to reach the United States and work its way through the population, triggering a lockdown in the face of a pandemic and killing a projected 11 million people. They planned for it to be a culling of the weak and immunocompromised, as well as the many Americans who were unable to afford or access sufficient healthcare if they became ill. They knew that it would likely affect those who were poor and of racial minorities,

as those are the people that are affected the most by lack of healthcare in the United States. Senator Sanders was aghast, likening it to another Holocaust. He asked if there was anything that could be done to stop it.

I told him that earlier that year. I had spoken with a member of the British Royal Family, Prince William, at the New York City consulate in an attempt to defect to the United Kingdom. Bernie seemed surprised that I had interacted with someone of such a high profile and asked me what had occurred. I explained that since The Reich considered themselves to be ruling America through an American cadet branch of the Rothschild family, the Marins, the Hitlers, who they were directly descended from were considered a royal family and I was their apparent heir. In the unplanned meeting, I informed him of everything I could recall at that point, admitting that he did administer a dose of hyoscine via a drink as was apparently the policy.

I let him know of the potential pandemic and that the Reich expected one of the major bottlenecks in treatment to be a shortage of ventilators and he came up with a plan to contact several companies, including Dyson, in advance and under the Official Secrets Act to develop a ventilator that could be quickly produced and distributed. We also discussed how to potentially extricate The Reich from America, but he said that any effort to do so would have to come from within America and that the country I believed that I knew had never existed.

When I brought up my relation to the Hitlers and the fact that Jean had Tony, the man who I believed to be my grandfather, but was actually my biological father killed upon order of the Central Intelligence Agency, from what I believed, he told me that it was a crime for a member of a royal family to kill another member of the royal family. This predated my claim to her that I would abdicate my role given the chance and she would have been eligible under semi-salic law to continue ruling after that murder.

I did not realize it at the time, but I technically inherited the throne as soon as I turned 18 in 2003. I am, under the eyes of international law, who apparently recognize The Reich as the true rulers of the American nation, The King of The Westlands. As I would later find out, the treaty that the Welsh prince Madoc established in 1168 CE with the indigenous peoples of the continent was still in place, and it is my legal responsibility to the entirety of the Americas to enforce the common law as the highest legal power in those lands.

At that point Senator Sanders seemed taken aback by the secret history I was apparently unfurling and seemed pensive. While I had much more testimony to get through, he openly wondered if I might one day run for President as a unity candidate. I replied that I believed in the political left more than the political right so I didn't know how much people would perceive me as a unity candidate but he referred to my association with The Reich, something that I consider by genetic relation only, as what people would see. I was wary that he believed so many Americans would vote for someone that they perceived to be a Nazi but didn't say as much at the time. I told him that I was coming to him because I believed that he had no allegiance to the Central Intelligence Agency and that, despite their predictions, I thought that he could win. He clarified that this would be at some point in the future. after all of this came to light.

I asked him what he thought about the idea that America was technically a monarchy and he said that he considered the laws and institutions of the nation to supersede any claims, as American democracy was devised and defined as rule without kings. I told him that was what I had learned in school too, but I had learned that the governments of the world apparently recognized The Reich's rule and that it seemed difficult to fight.

Setting aside the historical context, I continued my testimony related to the events of 2020. Shortly after the coronavirus reached its peak and lockdowns were in place, they expected an asteroid strike in early May just south of Haiti. Because of the region of the world it was expected to strike and the relative minimum expected damage they projected to the southern United States, they intended to allow it to strike despite projecting it over a decade in advance.

I spoke through his expressed disbelief explaining that I believed that this was a potentially false prediction by a scientist, telling my mother what she wanted to hear, that it would pass through something called a keyhole and drastically change

course, striking the Earth after a declining orbit. This would cause massive agricultural harm and wipe out the island nations south of the United States, which was in line with The Reich's political goals of extermination of the other and opposition to Communism, as Cuba was expected to be in its path as well.

I later researched the asteroid 1998OR2 as its date of approach came close. I learned that a conservative radio host, independently of my testimony, floated the idea that it was expected to hit and that was the real reason for the lockdowns. I also learned that a self-identified former CIA agent on Reddit, a social media platform, shared a similar belief and that the virus was intentionally distributed to cause the lockdowns. I observed a livestream of the approach which had apparently garnered an unusual amount of interest compared to other near-Earth objects, despite its officially projected unlikelihood of striking and found that it had been recorded as observed more than any other recent asteroid by far. There were real rumors that it would hit, independent of my testimony to Senator Sanders. Thankfully, it did not.

At this point, I will summarize the rest of my testimony as to its form and substance, recognizing that, after the fact, with the exception of the false expectation that asteroid 1998OR2 would hit, they will read as a summary retrospective of the 2020 election cycle. Despite that perception. I know that my testimony was a significant factor in these events and that with it, deaths were prevented and the course of these plans were changed.

To his credit, Senator Sanders focused on how to prevent certain actions and save lives in the event that The Reich's and by extension, their assets within the Central Intelligence Agency's plans of destruction came to fruition. However, in hindsight, it appears that political opportunists took my testimony, given freely, and used it to their political advantage while allowing The Reich to continue to exist and attack the structure and values of our society unabated.

As much of my following testimony relates specifically to the election and actions preventable if an investigation had been opened either immediately or as soon as it became obvious that my testimony was accurate, by early 2020 or at the start of the pandemic, it could have made a significant difference.

During the above mentioned events, the CIA planned to amplify the murder of a black man at the hands of police and use the opportunity to amplify other such incidents in an attempt to stoke cultural tensions in America, even choosing the police officer that they would be permitted to commit that crime — Derek Chauvin — a man who I named in my testimony on that day in 2019.

I was told by Jean that there was a man Chauvin had targeted and was just waiting for the opportunity to murder. As that was in early 2019 and the murder of George Floyd occurred in 2020, that shows premeditation. As it was spurred on by the elements within the CIA, legitimate or otherwise, it shows elements of state-sponsored terrorism on the African-American community committed by those loyal to The Reich or those following their orders, wittingly or unwittingly.

They intentionally timed those events to coincide with the death of Chadwick Boseman, who had famously been a hero on screen and off and had privately been suffering from colon cancer. He had worked for as long as he could before succumbing to the disease.

Amongst all of these events, the CIA hoped to have their candidate, Trump, go through Impeachment for the policies he had pushed forward. They knew that there wouldn't be enough votes in the Senate to convict, but they would push the narrative that he deserved impeachment for his crimes, either perceived or political. After impeachment failed, they intended for him to be assassinated by a man who they would frame as a failed actor seeking political retribution.

I told Senator Sanders that the intended assassin, Ralph Attanasia III, was a friend of mine and it was through Paige Pinckney, his girlfriend at the time and now spouse, that I learned of the CIA's plans in 2009. I didn't want to reveal his identity at first because I didn't believe that he was going to be forced to commit the crime, but Senator Sanders rightly insisted that I do and so I told him as much as I remembered.

She was working for the CIA at that point and had revealed the plans believing that they were endorsed by the government . She was told that she would have to go on television afterwards and play the role of mournful partner but that he would also die in the attempt, mashing the President during a public event.

This would play into their assumption that their extremist policies could not win on their own and that Pence would likely win on the sympathy vote, especially after Trump's adult children would speak positively about in the wake of his death , him and what he had wanted to do for the nation With no strong candidate expected to put their name forward in 2020 by the CIA's assumption that most modern presidents were, by default , the favorite to win in a reelection your by virtue of the incumbency alone, they expected this to fill the scales.

While a significant portion of my testimony was related to future and past crimes of the Reich, the joint operation with Saudi Arabia that resulted in the September 11th attacks as planned by Leslie Alan Cambey among them, the sacrifices were one of the most significant crimes that I brought forward testimony about and they seemed to be a footnote, not even recorded in the notes Faiz prepared, which he briefly showed me at the end of the conversation. I believe that it is fear of being exposed that has prevented my testimony from becoming the foundation of an investigation by federal authorities, despite it being foundational to the Democratic victory in the 2020 election and many of the positive and life- saving actions and policies that were enacted since and before then.

To give examples. I was asked during the testimony, which was given to a sitting Senator in their capacity as a representative of the US government, to provide my advice on how to both save lives from the coronavirus pandemic and how to win the election for the Democrats on the promise that a federal investigation would begin as soon as they were in office. I waited, after the fact, for years until I realized that no such investigation was carried out and that the beneficiaries of the information were using it as ammunition to defend their political positions and not defend the number of people who were increasingly being hurt by the Reich and the actions.

For example, when asked how lives might be saved in the face of a global flu-like pandemic. I suggested face marks, like many people wear in some East Asian nations when ill, despite it seeming unlikely that masks would be adopted here. I also suggested putting a vaccine into early enough production that it would be available to people prior to the peak of the pandemic, not realizing that the mutation rate and bad actors on the production side of the vaccine would negate some, but not all, of the benefits there. I truly believe that this saved lives, even if the leak of the virus itself was preventable.

I shared many other details of my own personal experiences, including testimony that I've detailed earlier and in words forthcoming, but all of it was given in truth and good faith. Watching President Biden practically ceding America to the Reich via a television broadcast press conference in July 2021 alongside Angela Merkel, one of the children of Adolf Hitler, was like watching a surrender. Her half-siblings Boris Johnson and Vladimir Putin both acted according to the group's plans as well.

The lack of a serious response to coronavirus by the UK government, the War in the Ukraine, and the early vaccination in Germany against COVID-19 were all international actions on behalf of this group individually, but serving the common interest of the Reich and the legacy of their father, Adolf Hitler. While I recognize that one Senator is only one Senator, there are indications that the intelligence I gathered was provided to Joe Biden during the 2020 campaign prior to his election victory which would potentially violate the law as it was given with the expectation that it would be used in a criminal probe, not a political playbook. I was also told at a later date that my testimony was shared with Representative Ocasio- Cortez by Senator Sanders, who claimed that she did not fully believe the contents, but time would prove its validity, accuracy and value by this point. At this point in time, I have written multiple letters and spoken multiple times with both political figures' offices, but as of this book's initial publication, neither have responded. I hope that changes soon.

While I also provided the identities of the three regional leaders of The Reich. Fernando Music, one of the Sosland family and prior to his death, Merv Griffin, none have apparently been prosecuted. I also gave testimony about several actions taken against me in an effort to fabricate compromising situations and intimidate me and people close to me from speaking, which have continued to this day When I left that room at Hahnemann Hospital. I expected the world to be saved and my life to be free from a group that had destroyed so much and so many As I left, I expected that within two years, the investigation would be underway and the Nazis would be stopped, it has been nearly four years since then and things have just gotten worse. It took me a long time to recognize why.

I hope this changes. Until then, I will keep trying to expose this group and hold their leaders accountable.

It didn't change.

I sent letters, made phone calls, tried the news, tried the media, tried the police, and so many more avenues in seeking justice.

I compiled a list of over 15,000 contacts – law enforcement, news media, journalists, the Senate, the House, congressional staff, and media figures.

I wrote and put out two books, both with real and serious actionable information.

I went to the FBI. I spoke with the Secret Service.

This effort has been ongoing.

I sent these messages to Senator Sanders after we briefly spoke on Saturday, October 21st. He stated that he remembered our conversation in 2019 and to send him text messages to the number I have on file. I was working off of memory and not my records, so I misremember a couple of specific details, such as the date of the meeting, which was the 15th – not the 19th, but otherwise everything seemed actionable at that time, nearly a year ago.

Senator Sanders, I am sorry for calling a private number, but this is incredibly urgent. I've reported the date 10/23/2023 to the FBI and many others but no action appears to have been taken yet. Something is going to happen and I need to urgently speak with investigators and be in New York City on that date. I have compiled as much evidence that I can and it is enough to prosecute. More than enough once you get me in front of investigators. Everything I said would happen happened, with the exception of that asteroid, but I said at the time that I didn't believe that part would occur as they claimed.

7 million people are dead from COVID-19 because The Reich, that Fifth Column in the CIA, was not stopped in time from releasing it. They will not stop until everyone who is not a Nazi is dead or under their rule. Please take this seriously. I need to be in federal custody immediately. I am ready to turn state's witness and provide everything I know.

I've compiled an evidence archive, but this smaller folder contains a written summary of our meeting on July 19th, 2019, Testimony.pdf, that I hope you will review. TESTAMENT.pdf contains much of the written testimony that I was able to compile for this investigation. I have shared this via email with the media and hundreds of others, including lawmakers, but I don't know if it's being acted upon. This is a fraction of my full evidence archive, but I have so many leads that I could provide to investigators that it could fill a warehouse.

You promised that you would act on this in your capacity as a Senator even if a new administration would not. I am begging you to do that. I know that some of my behavior has been questionable, but I am truly trying to choose the best possible choices out of so many bad ones. I hope that you will respond, either here or via an official channel, to my email richmarinkt@gmail.com.

I am presently at [REDACTED]. I am under [REDACTED], but the feds can bring me in ASAP from there. Lives are at risk. They will not stop at 7 million.

I Uncovered Massive CIA, COVID-19, and Human Trafficking Conspiracies.

My name is Rich Marin and I am an independent investigative journalist. My testimony, given to Senator Sanders in July of 2019 was urgent and could have saved many lives. It is being suppressed and not fully acted on. I'm taking the extreme step of posting his office's phone number, along with my testimony, in the hopes that you, the internet, will be able to get him to act. My testimony involves significant knowledge of COVID-19 months prior to its intentional release as a bioweapon by a group with high level access to CIA assets and resources. My name is Richard Anthony Marin, and I am reaching out to you because we have met before. As you likely recall, on July 15th at Hahnemann Hospital in Philadelphia, during an event held by Senator Sanders, I approached the Senator with urgent testimony that you recorded in writing and he listened to for at least an hour. This testimony was related to many topics, but was centered around the efforts by a Fifth Column group, known as "The Reich" with connections to the Central Intelligence Agency, and their efforts to disrupt and subvert American democracy.

One of the most important elements of my testimony, which you were present during, was that the group planned to intentionally leak and spread a novel coronavirus during the 2020 election cycle from a lab in Wuhan Province, China. This is extremely urgent. There are reports in the news, daily, consistent with this group's plans that they have executed both prior to my testimony and since. If they have their way, millions more will die and so will the idea known as American democracy.

I have tracking data on every message I sent, and it is clear that thousands of people were warned of this plot months in advance, including law enforcement.

Both were involved in recruiting girls but he was the person with the most influence on the on them.

The intent behind the group was to influence people by feeding their desires and utilize blackmail to push them towards a political agenda that supported the goals of their backers, the shadowy cabal of individuals that seems to lurk in the background of every story about Epstein. The group has long provided young girls to powerful people, long before Epstein became involved. They also procured and provided children, both boys and girls, celebrities, and even set up private events that were indistinguishable from brothels in major cities such as New York. I don't think that I need to elaborate on a worst case scenario - that is precisely what this group has planned.

I am writing to you with the hopes that I will be brought in to provide testimony in person. I am at extreme risk from these individuals and am known to them. I have been sending warnings and testimony on this group for over a year to the Senate, House, law enforcement, and the media. I believe that my warnings were ignored as unlikely conspiracy theories. I do not believe that anyone can truly claim that now.

I will be publishing a book, including copies of my communications going back to 2023 at least, with regards to my attempts to get this group prosecuted. I provided detailed testimony to Senator Sanders, in person, in July of 2019, but I believe it and the fact that I even gave it has been covered up, as I warned of a coronavirus pandemic during the 2020 primary season that was intended to suppress voter turnout and subvert the election.

I am only doing so as my prior warnings have not been heeded and I believe that the public has every right to know how much was known ahead of time, by whom, and who did nothing to stop it. Worse - who allowed it to happen.

I recognize that there are failures of intelligence and there is intentional suppression. However, I have not been contacted by any federal agent or authority in all of the past two years since I've been warning individuals about this plot, other than being threatened by the Secret Service in an in-person meeting in late 2022. I am willing to provide all of this evidence and more if you bring me to DC. I am presently in Chicago and have been retaliated against due to my efforts to expose this group.

I sent this email to the media a few days ago, and included an email I sent to the individuals noted as the lead investigators on the case. To be clear - each person copied on the last email is on the lead of the investigation - they already have my evidence and what they have or have not done with it will make or break this investigation. I don't want my social media footprint to affect the perception of the validity of this information. I believe that America is an active crime scene and it is necessary to truthfully investigate - and that means no stone left unturned.

I hope to speak with someone regarding the Senate investigation as soon as possible.

Urgent Information About The Trump Assassination Plot

I am contacting the news because I have urgent and actionable information on individuals who I believe are involved with the recent assassination plot against President Donald Trump. I published this thread months ago, after reporting in-person to the FBI in Chicago:

I also reported to the Secret Service. My tips were not acted upon and I was not followed up with. The Secret Service actually hung up on me. I have records and proof of making these reports, and have been reporting on a plot to assassinate President Trump for months.

I've been sending news organizations this information for months and I've seen some elements of it in the news. What I've not seen is a phone call from any major news organization - of any type - asking to speak with me. I have extremely detailed information about the specific individuals in the Central Intelligence Agency who have created and enacted this plan.

There is an extremely strong likelihood of potential further actions by this group, such as the CrowdStrike update "virus" that knocked out pretty much every single commercial flight, 911 call centers, and several other key elements of our infrastructure. They are likely to step up their efforts in the coming months to ensure that their coup attempt is successful. This is about ending America.

If that had happened four months ago, this would not have. I have learned that an individual involved in the Central Intelligence Agency as a former consultant and named in prior testimony was involved in furthering and potentially directly encouraging this plot. I have names and addresses and have been intimidated by these individuals in an effort to prevent me from testifying against them. While the policy architect named in my email to law enforcement below was involved in constructing the plan, it was a man named Leslie Alan Cambey of Pearl River, New York, who I have information which indicates he psychologically manipulated the individual who fired that rifle by convincing him that Donald Trump was "too old" and his personal bias from his work at a nursing home was manipulated into anger. Cambey convinced him to take up the plot, using tactics of manipulation and potentially a substance called hyoscine, also known as scopolamine, while doing so.

I do not have physical evidence of this, but investigators should be able to follow up on this lead. As this plot matches nearly everything to the plot I reported on and wrote about months ago, I believe that not only has law enforcement completely stumbled on this investigation, but so has the news media. I have been sending out thousands of emails and none have covered my allegations to the level that it would have helped prevent this.

I have been sending emails for months to law enforcement and media regarding a plot that I learned of to assassinate or attempt assassination of President Trump in an effort to shift the political discourse towards retribution and ensure a Republican win in 2024. A man was shot on live television and I've sent out thousands of emails to you, the news, the FBI, and congress warning you in advance, months ago, that this would happen if you didn't listen to me. Guess what? It happened. It is a failure of your agencies that it did.

Earlier today, I spoke with someone at the Secret Service Chicago office again, and they took down my report this time. The FBI hung up on me immediately, as soon as I mentioned the involvement of the CIA. This is proven, not speculative - I have been a personal witness to multiple high-level planning meetings and have details that others do not. I have proof. I even have recordings of admissions of knowledge.

This goes beyond an attempt on one person's life, this is part of a coup on American soil to replace the federal government and two-party system with an unquestioned supremacy through voter suppression, intimidation, and, essentially, chaos. This is not the first time that this group has done something like this nor will it be the last if they are not stopped.
