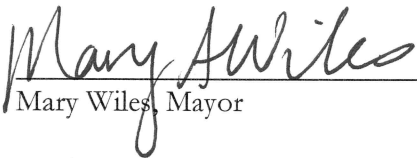

ADJOURNMENT.

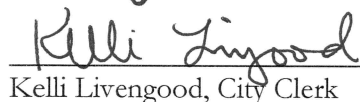
