## **AMENDMENT**

- (c) Registered sex offenders are prohibited from residing or visiting in Steamboat Shores. The purpose of this restriction is to safeguard the safety and wellbeing of Steamboat Shores Community. This restriction applies to all residents, property owners, and tenants within the jurisdiction of Steamboat Shores owners Association.
  - For this restriction a registered sex offender is defined as an individual who has been convicted and is listed on the official registry maintained by relevant law enforcement agencies for offenses involving sexual misconduct.
  - 2) No person designated as a registered sex offender shall be permitted to reside within any property located within confines of Steamboat Shores Community.
  - 3) The Steamboat Shores Owners Association reserves the right to conduct periodic checks with relevant law enforcement agencies to verify the residency status of community members.
  - 4) All residents, property Owners, and tenants within Steamboat Shores are expected to comply with this restriction. Failure to comply may result in disciplinary actions.
    - a. Violation of this restriction may lead to penalties including but not limited to fines, suspension of privileges and if necessary legal action.
  - 5) If any of this Restriction is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
