Key responsibilities for successful applicants will be:

- Be a key person to a group of children, liaising closely with parents/carers and ensuring all children's needs are recognised and met.
- Help to set up and clear away the rooms and garden daily
- Work co-operatively as part of a team and where necessary provide cover at pre-school or our holiday club.
