Buyer understands that any veterinarian bill for medical treatment or surgery is NOT covered by this agreement of sales terms. Seller/Breeder, Nicole Robinson, has provided buyer with all medical/vetting documentation for the dog and has provided all knowledge of any possible health concerns if any are present.

Provided the terms below, buyer agrees that the seller is not liable or held responsible for any cost relating to the future care of the adult dog being sold:

1. Seller/Breeder is not responsible for any future vet bills relating to the treatment or surgery of Adult dog being sold.
2. Seller/Breeder does not guarantee against any possible congenital defect that may show up down the road in the Adult dogs life.

3. Seller/Breeder does not guarantee against any possible parasites or possible fecal. The Adult dog has been dewormed throughout it's life with the breeder. Breeder suggest placing Adult on a monthly preventative to cover fleas, intestinal parasites and heartworm.
4. Seller/Breeder does not guarantee against luxating patella as this is very common in toy breed dogs.
5. Seller/Breeder does not guarantee against any sort of alopecia related in diluted colors or dogs who carry diluted colors in their pedigree.

Buyer understands that if for whatever reason the dog does not work out that they can bring the dog back at anytime in its life to the seller. Buyer also understands there will be no refunds or money back at anytime.

Buyer understand that if he/she has rehomed the dog to let the Seller/breeder know and to give the new owners information over to the Seller/Breeder.

This contract contains the entire agreement between the parties and no statement or verbal agreements made by either party that are not contained in this written contract shall be valid or binding. This contract may not be modified or altered except in writing and signed by both parties. If for any reason there be a dispute, all proceedings are to take place inside the Habersham County Georgia district.
