WARRANTY LIMITATIONS

THIS WARRANTY REPLACES, SUPERSEDES, AND EXCLUDES ALL OTHER WARRANTIES, ORAL, WRITTEN OR IMPLIED, ARISING BY LAW, COURSE OF DEALING, USAGE OF TRADE, CUSTOM OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

IN NO EVENT SHALL DMV WHOLESALE DISTRIBUTORS BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING ANY DAMAGE TO STRUCTURES, THEIR CONTENTS, OR ANY PERSON THEREIN, RESULTING FROM A BREACH OF THIS WARRANTY OR THE PURCHASE, INSTALLATION, OWNERSHIP, OR USE OF DMV WHOLESALE DISTRIBUTORS PRODUCTS.

DMV WHOLESALE DISTRIBUTORS DOES NOT AUTHORIZE ITS FIELD REPRESENTATIVES, DISTRIBUTORS, OR DEALERS TO MAKE ANY CHANGE OR MODIFICATION TO THIS WARRANTY.

PURCHASER'S EXCLUSIVE REMEDY AND DMV WHOLESALE DISTRIBUTORS EXCLUSIVE LIABILITY FOR ANY BREACH OF WARRANTY IS LIMITED TO WHAT APPEARS IN THIS DOCUMENT.

SOME STATES DO NOT ALLOW LIMITATIONS ON, OR THE EXCLUSION OF, IMPLIED WARRANTIES, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE.

COVERAGE

1. Subject to the following limitations, terms and conditions, DMV Wholesale Distributors warrants to each individual (hereinafter, the "Owner") who (i) purchases a Product (as defined herein), (ii) uses the Product solely for Residential Purposes (as defined herein) and (iii) is a resident of the United States of America at the time of the purchase of the Product, that the Product is free from defects in material and workmanship in the course of manufacture and that the finish on the Product will not chip, peel, flake or blister under conditions of ordinary use and wear for a period of 20 years commencing from the date of its purchase by the Owner, if installed and maintained according to the specifications and instructions of DMV Wholesale (hereinafter, the DMV"). In order to claim under this Warranty, the Owner must provide the applicable DMV Wholesale Distributors:

- prompt written notification of any defect in the Product including a full description of the defect and a photograph of the same;
- an original purchase receipt from an authorized DMV dealer; and
- proof, in a form satisfactory to the DMV Wholesale Distributors, that each of the other conditions specified herein have been satisfied.

2. Residential Purposes is defined in this Warranty as the installation of the Product onto a single family detached housing unit or onto a detached duplex housing unit, as the case may be, that is owned by the Owner and occupied by him or her as a place of residence and that is not used either in whole or in part as a rental property or for any other purpose.

3. Product is defined in this Warranty as any one or more components of the DMV Wholesale Distributors

LIMITATIONS

4. This Warranty covers only genuine Products of DMV which are purchased by the Owner from an authorized DMV dealer. This Warranty does not cover damage of any kind resulting from:

- normal wear, tear, weathering and the damaging effects of sunlight and extremes of weather and atmosphere that may cause any surface to fade, chalk, or become soiled or stained;
- claimed defects, malfunctions or failures that result in whole or in part from abuse, misuse, neglect or improper installation, assembly or maintenance;
- accidental or intentional damage, collision, crash, impact of foreign objects or vandalism;
- settlement, structural shrinkage, distortion or expansion of the property or property structure;
- harmful or corrosive chemicals, including harmful cleaning compounds and pesticides, fumes, or vapours;
- surface deterioration due to air pollution, seacoast environment, airborne stains, mould, or mildew;
- warping or distortion due to exposure to excessive heat sources or exposure to unusual or excessive reflective heat sources;
- cracking or crazing due to cold temperatures; and
- fire, lightning, flooding, hurricane, tornado, windstorm, earthquake, hail, other acts of God, or any other causes beyond the contemplation of the Peak Company.

OTHER LIMITATIONS

5. THIS WARRANTY IS VOID AND NO DMV COMPANY SHALL HAVE ANY RESPONSIBILITY OR LIABILITY IF:

- the Product was not purchased new from an authorized DMV Wholesale Distributors dealer;
- the Product was installed or used with a competitor's product or system, or used with a product or system not within the contemplation of DMV Wholesale Distributors;
- the Product was installed using improper fasteners, methods or techniques, or in nonconformity with applicable building codes or best building practices; or
- repairs, modifications, alterations or any changes of any kind were undertaken on the Product without prior written authorization from the peak company.

6. This Warranty is for the exclusive benefit of the Owner whose property the Product was installed on and is not transferable.

7. Should the Product be determined by a DMV Wholesale Distributors to be covered by this Warranty, DMV Wholesale Distributors will refund the original purchase price, or repair, replace, or refinish the Product at the sole option of the DMV Wholesale Distributors, whose decision will be conclusive and binding. The DMV Wholesale Distributors obligations under this Warranty will in no event exceed the purchase price of the Product found to be defective. Fasteners and the costs of installation and removal and freight are excluded from this Warranty. Any additional costs and expenses beyond the original purchase price are the Owner's sole responsibility and are excluded. In the event of repair, replacement or refinishing under this Warranty, the Warranty applicable to the replacement material or to the repaired or refinished product will extend only for the time remaining under the original Warranty.

8. Each DMV Wholesale Distributors reserves the right to discontinue or change any design or colour of the Product at any time and without notice or DMV Wholesale Distributors Company acknowledges that a claim will be covered, the DMV Wholesale Distributors may refund the original purchase price or substitute another product determined by the Peak Company in its sole and absolute discretion to be of comparable quality and price.

9. THIS WARRANTY IS THE OWNER'S EXCLUSIVE REMEDY AND SUPERSEDES ALL OTHER WARRANTIES AND CONDITIONS, EXPRESSED OR IMPLIED. ALL OTHER REMEDIES, OBLIGATIONS AND CONDITIONS, LIABILITIES, RIGHTS, WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, ARISING AT LAW OR OTHERWISE, INCLUDING ANY WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS, OR ARISING FROM COURSE OF PERFORMANCE, DEALING OR USAGE OF TRADE, ARE DISCLAIMED BY EACH PEAK COMPANY AND WAIVED BY THE OWNER. NO PEAK COMPANY SHALL BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OR ANY LOSSES OF ANY KIND.

10. Some provinces, states and other jurisdictions may not allow some or all of the limitations set forth herein, or the exclusion or limitation of incidental or consequential damages. If any provision is found to be unenforceable, only that provision shall be stricken and all others shall apply. This Warranty does provide the Owner with certain legal rights and recourse and the Owner may possess other rights or recourse, depending on the province, state or other jurisdiction.
