Insurance

Statement from National NAWGJ:

NAWGJ supplies our members with **Professional Liability Insurance**.

This includes an individual total of \$1,000,000 per claim. Each judge would have up to \$1,000,000 coverage.

This includes: Errors and Omissions, Breach of Contract, Sub-Contractor Vicarious Liability, Contingent Bodily Injury and Property Damage Liability, Intellectual Property Rights Infringement, Pollution Liability, Regulatory Cost and Fines, Dishonesty of Employees, Payment of Withheld Fees.

We also have our General Liability Policies which is for our Educational Events (not gymnastics meets that is through your sanction).

USAG membership includes accident participant, catastrophic and general liability secondary insurance coverage at USAG Gymnastics sanctioned events. USAG membership does **NOT** include Professional Liability Insurance.

Insurance

Exception:

If assignments are listed in the activity reports in GymJAS, NAWGJ will have a record on where you are judging so we can record for insurance purposes.

- This is also the same for critique meets
