

DONE WITH IT HAULING & REMOVAL, LLC
TERMS & CONDITIONS/SERVICE AGREEMENT:

Done With it Hauling & Removal offers junk removal services including demolition and waste hauling. Dumpster disposal service is provided using our roll-off containers. These services will also include any other tasks which the parties may agree on. By using our services, you are agreeing to follow our terms and conditions. Done With It Hauling & Removal reserves the right, at its sole discretion, to change, modify, add or remove portions of these terms of service for changes.

PROHIBITED ITEMS/NOT ALLOWED IN DUMPSTER:

Flammable Liquids, Harsh Cleaning Chemicals, Hazardous Chemicals/Waste, Pesticides and Herbicides, Pressurized Containers, Wet Paint, Tires, Lead Acid Batteries, Dead Animals

ALLOWED IN DUMPSTER WITH CONDITIONS:

(1) Heavier items such as: Shingles, Dirt, Rock, Brick and/or Concrete cannot be loaded higher than one quarter full and/or must not exceed our maximum load weight of 5 tons (10,000 lbs.). **If overloaded or overweight, there is a minimum \$550 overload/overweight fee plus any additional tonnage charges (see more information under Service Fees & Other Charges).**

(2) Appliances - MUST BE EMPTY, no old food or trash inside. Please load at the back of the dumpster OR on top so we can remove them to be recycled. The landfill does not accept these items conveniently and may charge a fee.

NOT ALLOWED INSIDE DUMPSTER BUT CAN BE PICKED UP:

Tires* (without rim \$10/each, with rim \$20/each), Lead Acid Batteries* (no extra charge). *Customer must notify us of these items and keep them separate as they are not allowed inside dumpsters.

PAYMENT METHODS:

Pay for free with Cash, Zelle, ACH Bank Transfer, and Bitcoin. Please note 3% will be added for Credit/Debit Cards, Paypal, and Venmo.

RESTRICTIONS:

1. Prohibited items
2. Dumpster Rental includes 3 tons (6,000 lbs.) of disposal fees
3. Maximum load weight: 5 tons (10,000 lbs.)
4. Maximum load height: Loaded junk/debris must not extend above the sides of the dumpster OR ¼ full capacity only (for Conditionally Accepted Heavier Items).
5. Inclement weather may cause a cancellation/rescheduling.

SERVICES: ROLL-OFF DUMPSTER RENTAL

Dumpster to be moved by Done With It Hauling & Removal only. Customers are not permitted to push or pull dumpster.

1. Payment at the time of reservation is required.
2. We will deliver the dumpster to your site on the agreed upon date.
3. Other charges as described herein.
4. Additional invoices are due upon receipt.

SERVICE FEES & OTHER CHARGES:

Customer must pay the amount in the invoice(s) as described. PLEASE NOTE THESE CHARGES WILL BE BILLED ON A SEPARATE INVOICE (IF APPLICABLE):

- ADDITIONAL TONNAGE (over 3 tons/6,000 lbs.) will be charged after weigh-out at the landfill at \$75/ton. Up to 15 days after pickup.
- ADDITIONAL DAYS on your rental period will be \$25 Per Day, in excess of the booked rental period until we've been notified by customer that dumpster is ready for pick up. Maximum rental period up to a month. Does not apply to special monthly rates.
- ADDITIONAL DUMPSTERS/SWAP FEE- Price for additional dumpsters will be the same as your initial rental fee minus any additional days.
- DAMAGE TO DUMPSTER - Customer is responsible for any repair or replacement costs attributable to any damage to the dumpster while in their possession.
- EMPTY DUMPSTER - If nothing gets loaded into the dumpster, the customer is still responsible for payment.
- NOT allowed in dumpster but can be picked up:
 - Lead Acid Batteries - no charge
 - Tires - without rim \$10/each, with rim \$20/each
- OVERLOADED / OVERWEIGHT DUMPSTERS - If material is loaded above the maximum height capacity or exceeds the maximum tonnage allowed (5 tons/10,000 lbs.), it can result in refusal of service and off-loading shall be required. A non-negotiable \$550 overload/overweight fee will also apply plus any additional tonnage charges as stated above.
- PROHIBITED ITEMS - Any fines, disposal fees, or damages will be passed along to the customer.
- RELOCATION OF DUMPSTER - If you request the dumpster to be relocated at the service address, a fee of \$150 per move will be charged.
- THEFT OF DUMPSTER - Customer is responsible for theft while it is in their possession.

ALL ITEMS BECOME THE SOLE PROPERTY of Done With It Hauling & Removal at time of departure. At times, we may collect revenue from recycling. At no time shall the customer have any rights to any revenue generated by the disposal of said property.

CREDIT CARD AUTHORIZATION - Customer authorizes Done With It Hauling & Removal to process and charge the customer's credit or debit card account for any and all amounts due in this agreement. This authorization includes any additional charges incurred. Customer acknowledges receipt of the goods and services indicated in this agreement and agrees to perform the obligations set forth in their Cardholder Agreement with the issuer of the credit/debit card. Credit/debit card transactions must be approved before they are accepted as payment.

COSTS OF COLLECTION - Customer agrees to pay all collection costs, including legal fees, incurred by Done With It Hauling & Removal. Once collected, payments will be applied first to costs incurred for collecting, next to accrued interest and finally to the principal owed. Interest begins accruing from the due date. Customer agrees that any claim for price adjustment shall not be reason, cause, or defense for failure to make full payment of the amount owed in this agreement.

DISCLAIMER OF LIABILITY - Done With It Hauling & Removal is not responsible for bodily injury, dumpster fires, or damage to customers property. No compensation will be paid to the customer for any medical liabilities at any time. Customer agrees to file no lawsuits for any injuries sustained while the dumpster is on the property.

TERMINATION - At any point Done With It Hauling & Removal may terminate services. We will pick up the dumpster and charge based on the load size, type of items, and any excessive tonnage/yards.
