Conditions of Sale:

- (1) Both purchaser and Seagull Kennel acknowledge that no representations, verbal or implied, have been made with regard to said Jack Russell Terrier's future abilities.
- (2) Seagull Kennel warrants to the best of their ability, said Jack Russell Terrier is sound and free from disease. The purchaser agrees to have said terrier examined by a licensed veterinarian of their choice, at their expense, within 48 hours of physical possession of terrier. If the terrier is found not to be in good health, the purchaser will return at their expense, the terrier to Seagull Kennel immediately. Seagull Kennel will either (1) replace the terrier; or (2) return it in good health within thirty (30) days. The adverse health report must be in writing and signed by a licensed and qualified veterinarian.
- (3) Terrier is guaranteed until one year of age against genetic conditions which are sufficiently serious in the opinion of two (2) licensed and qualified veterinarians, at least one of which is selected by Seagull Kennel, to warrant euthanization of the terrier. In such an unlikely case, a written veterinarian report, with autopsy, will be submitted and signed by both veterinarians. The terrier may be replaced with one of equivalent quality from the next litter, at the sole discretion of Seagull Kennel.

- (4) Purchaser will provide the terrier with a comfortable and safe environment, prompt medical attention, proper nutrition and responsible care. Terrier shall be kept free from parasites and up to date with all vaccinations. A health record will be provided of current worming and shots that the terrier has received at Seagull Kennel.
- (5) Terrier is guaranteed to qualify for registration or recording, in the Jack Russell Terrier Club of America (JRTCA). **SEAGULL** will be used as the first name of all dogs when shown or registered.
- (6) If purchaser is unable to keep said terrier for ANY reason, they will contact Seagull Kennel and return the terrier, at their expense, to Seagull Kennel. Seagull Kennel may assist with placement in another home, or the terrier may remain at Seagull Kennel. Under no circumstances will purchaser ever place this Jack Russell Terrier in an animal shelter, pound, or pet store of any type.
- (7) The purchaser further agrees to register or record this terrier with JRTCA at one year of age, and to have no association with any conflicting JRT organization or kennel club (relating to Jack Russell Terriers).
- (8) Purchaser assumes all responsibility for the terrier as of the date and time of this agreement. Seagull Kennel will not be held responsible for illness, accidents and/or injury to the terrier, upon physical possession of the terrier by the purchaser. All JRTCA paperwork will be provided to the purchaser upon physical possession of said terrier and the completion of all payments for said terrier.

Refund Policy:

- (1) If terrier does not qualify for registration or recording with the JRTCA, Seagull Kennel agrees to replace the terrier with another puppy upon return of the original terrier.

This agreement represents the entire agreement between the buyer and Seagull Kennel. No other agreements or promises, verbal or implied, are included unless specifically stated in this written agreement. All payments owed to Seagull Kennels will be completed as agreed. We, the undersigned, have read understand and agree with the terms of this contract.
