PRICE LIST

Effective date: January 1, 2024

The following format and content of the price list has been stipulated by the Bereavement Authority of Ontario and is required to be posted by all bereavement licensees.

INTERMENT RIGHTS

Interment right prices listed below include a non-refundable contribution to the cemetery's Care and Maintenance Fund.* The prices listed below do not include the opening and closing of the grave, memorialization costs (flat marker, upright monument, etc.) and associated installation fees.

BURIAL LOT OPTIONS & PRICES

Single Full Lot.....	\$1600.00
Cremation Lot (3ft x 3ft).....	\$800.00

A complete list of all prices for the above interment rights is available upon request.

*Care and Maintenance Fund Contribution:

As required under the *Funeral, Burial and Cremation Services Act, 2002* and Ontario Regulation 30/11, the amounts below will be contributed to a Care and Maintenance Fund/Account (*Bereavement Authority of Ontario Consumer Protection Fee*). Income (interest) from this fund is used to cover care and maintenance expenses of the cemetery in perpetuity.

*Upright Monuments/Headstones – all die stones must be at least 6" thick. If a die stone is more than 30" in width or 24" in height, the thickness must be 8"

**Flat Markers/Pillow tops – all markers must be made of granite or bronze. All granite markers must be 4" thick.

Note: All markers and headstones must be installed by the supplier. Cemetery personnel require 5 days' notice for installation and will stake the location as necessary.

CEMETERY SERVICES (PROVIDED BY EMCC)

Interment Fees (opening and closing of grave)

Interment – single full lot grave opening \$1000.00
(Saturday Interments at higher rate of \$1250.00)

Cremated Remains Disposition Fees

Interment of cremated remains \$500.00
(Saturday Interments at higher rate of \$650.00)

Administration fees

Staking fee for plinths, foundations, flat markers \$100.00
Foot Markers (must be 4" thick, with a maximum size of 16" x 8") \$25.00
(if installation requires staff to mark location, there is a fee. If not required, no fee)

Other Services

Corner Stones (set of 4) \$400.00
All cornerstones are purchased through the EMCC at the time of purchase of full lot(s). The cemetery installs the Cornerstones and these stones designate the boundaries of individual lots.

SUPPLIES

VAULTS & GRAVE LINERS

A concrete vault is encouraged for full lot burials. Cremation burials are encouraged to use either a concrete vault or a resin vault. Regardless of type of burial, concrete and resin vaults are purchased through the Funeral Home.

MONUMENTS AND MARKERS

When purchasing a Monument/Headstone for the cemetery, all foundations must be ordered through the Monument company. The cemetery will mark the grave for the foundation to be poured and notify the monument company when this is done. No foundations will be poured until the cemetery has received the appropriate paperwork and payment in full for staking fee and Care and Maintenance fee. Foundation cost is paid directly to the monument company.

For Monument Companies: please mail 1 copy of the headstone order to the cemetery with cheque for payment in full.

Staking Fee for marking the location where a foundation, marker or monument is to be installed \$100.00

Care and Maintenance Fund Contribution:

As required under the *Funeral, Burial and Cremation Services Act, 2002*, the following amounts must be paid to the cemetery operator before a marker is installed. Typically, this one-time fee is paid directly to the monument company and is in addition to the price of the monument and the foundation for the headstone. The monument company then forwards this fee to the Eden Mills Community Cemetery. If the monument company does not collect this fee from the customer, the customer must pay the cemetery directly. After each marker installation, the amount will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund (*Bereavement Authority of Ontario Consumer Protection Fee*). Interest from the fund will be used to cover expenses for the care and maintenance of markers and monuments in perpetuity.

For flat markers measuring less than 1,116.13cm ² / 173in ²	\$0
For flat markers/pillow tops measuring 1,116.13cm ² / 173in ² or larger	\$100
For upright monuments 1.22m / 4ft or less in height and 1.22m / 4ft or less in length, including base	\$200
For upright monuments more than 1.22m / 4ft in height and 1.22m / 4ft, including base.....	\$400

PAYMENT

For services at time of death:

Payment is due when signing the contract. Payment may be made by cash or cheque payable to Eden Mills Community Cemetery.
