## **Proposal 1: Ministry of Education Parents' Bill of Rights**

## Introduction

#### Province-wide Consultation:

# Amending the Education Act:

This involves legislating the presence of elected parent representatives at the school, district, and provincial levels. These representatives will have clearly defined roles and powers to influence curriculum and policy decisions. To support their effectiveness, they will receive appropriate training and resources.

#### **Desired Outcome**

The desired outcome of this initiative is twofold. First, the Parents' Bill of Rights will clearly define the rights and responsibilities of parents in their children's education and establish transparent communication channels between parents, schools, and the Ministry of Education. This will ensure regular updates on curriculum changes, policy decisions, and other relevant information.
