Check the status of your passport verification with Mumbai Police.

The PCC serves as proof of a person's criminal record status and is issued by the Maharashtra Police. Once the PCC form is completed, it should be submitted along with the necessary documents to local police station or the Maharashtra Police website, as per the specified instructions. It is important to accurately fill out the Maharashtra Police Clearance Certificate form and provide all required information to ensure a smooth processing of the application. Any incorrect or incomplete information may lead to delays or rejections in obtaining the certificate. Apply In-Person: To register Tenant's details in Maharashtra, get the Tenant Verification form from the nearest Police Station. Carry the photocopy of the Tenant's Id Proof and 2 Passport size Photos of Tenant. Fill the required details of the Property, Property Owner and Tenant. Attach the Required Documents such as Id Proofs and Passport size photographs. Duly sign the form and submit the form at the nearest Police Station. To find your Police Station, select your city or district from the Link Maharashtra Police. In the redirected district/city's webpage, click on "Police Station" and locate your Police Station from the list. Apply Online - Apply to get Tenant Verification Online with Images To register the Tenant's Details with the Police in Maharashtra, visit the link: Tenant Registration. Once you create your account, login and click on Citizen Services. Now select "Tenant/PG Information Request" and from there select "Add Tenant/PG Information Detail". Fill the Details of Property Owner and Property Details. Fill the details of the Tenant and Upload the required documents. Provide details of Persons knowing the Tenant. The Police would keep a record of the Tenant's information and would inform the landlord if the Tenant is a criminal or a troublemaker. Under any circumstances, it is advisable to collect details of your Tenant and Register your Tenant with the Police before you rent out your Apartment or Building. Terrorists and Criminals usually try to rent a place with forged documents. Thus, registering your Tenant with the Police would help you avoid any issues in the future. Information which might help[edit] When one registers their Tenant with the police, the Tenant's details are stored with the police. This protects the Tenant from being harassed by the police. It also provides a record of the Tenant's stay at the property. The landlord can also use this information to track the Tenant's movements. If the Tenant is involved in any illegal activities, the police can take action against them. For a major chunk of the Indian population, especially the aged, renting out a property is one of the main sources of income. However, while letting (renting) out a property, the owner(s) must exercise some basic caution to avoid any hassles in the future. Some of these acts of caution include executing a registered rent agreement, and insisting on tenant verification, among others. Verification of the tenants living in a rented property is often neglected by the owners of the property for whatever reasons. However, asking for tenant verification is as important as discussing about rent and security deposit while giving a property on rent. On the back of increasing concerns related to safety of the citizens, especially senior citizens, it is highly advised to ask the tenants for their Aadhar card, in addition to giving the usual tracking and informing persons in times of emergencies, as is advised by the police to register the details of tenants staying in a property. It is also advised that the landlord (owner) hire representative to submit all the basic details, ID proofs, employment proof, and any other documents of the tenants as required by the police personnel. The tenant, as well as the owner, is required to be present at the police station. You Might Also Like This tenant verification can be done in two ways. One as Offline Online method: For registering the tenant information online, you need to visit the official websites of Maharashtra Police for that respective area.

Major cities in Maharashtra have their respective websites for submission of tenant information. The procedure for this is very simple. The owner needs to visit the website of the police department under whose jurisdiction the property comes and enter the details of the owner, the property, and the tenant. The website links for submitting tenant information for some of the key cities in Maharashtra is as follows: Now, this facility of online information submission is not available for all cities of Maharashtra. For rest of the cities/ areas, this information can be submitted offline. Offline method: The offline way of tenant verification and information registration is useful in areas where the online facility of registering information is not available.

Also, it is preferred by the population who is not well versed with technology and prefers visiting the police station in person. This is a hassle-free process and involves the following steps: Step 1: Arrange for the self-attested photocopy of the following documents: The rent agreement executed 2 passport-sized photos of the tenant and the owner ID proof of the tenant (Aadhar Card is preferred) Employment ID card of the tenant (if salaried) Address proof of the property being rented (Electricity bill, telephone bill, etc.) Step 2: Visit the police station (tenant as well as the owner) under whose jurisdiction the property comes. Here, tenant refers to the person under whose name the rent agreement is made. All persons staying in the property are not required to visit the police station.

Step 3: Fill the form for registered entry for a property on a rental basis. The tenant, as well as the owner of the property, is required to sign on the form. Submit the documents in Step 1. This form is available within the police station campus. Below is a sample of such a form available with Kamothe police station in Navi Mumbai. This format of this form may vary area wise.
