An affidavit of residence is backed up with supplemental documents such as a phone bill, vehicle title, driver’s license, or lease agreement. Once the affidavit is completed, it will then be notarized and submitted to the agency requiring it. - Raise and support front of vehicle.
- Disconnect exhaust front pipe from manifold.
- Remove
 - RH front wheel
 - RH splash guard
 - Engine upper cover
 - Auxiliary drive belt
 - Lower torque reaction link
 - Flywheel housing lower cover
- Lock flywheel [1]. Use tool No (-) 0188-F
- Disconnect and seal off fuel pipes. Use tool No (-) 0188-T
- Remove timing belt cover [2]
- Refit timing belt upper cover bolt fitted with a 17 mm thick spacer [3]
- NOTE: Timing belt upper cover bolt [3] is also a water pump mounting bolt.
- Remove

The affidavit must be made in the presence of a Commissioner of Oaths (e.g. at a police station). Landlord: the person who owns the property that is being rented. Depending on its use, a landlord’s signature may be required on the affidavit.

Length of Residency: the length of time a person has lived there. **Notary Public:** the person who notarizes the affidavit of residence before submission to the intended party. Some sources use the terms "affidavit of residence" and "affidavit of domicile" interchangeably, but these documents serve different purposes. **Affidavit of Residence vs. Affidavit of Domicile** An affidavit of residence verifies the current residence of a living person as may be required by schools, employers, banks, and courts. In contrast, an affidavit of domicile is used to verify the last legal residence of a deceased person to transfer specific types of property to their beneficiaries.
