#### Special Meeting this Sunday, November 6



All homeowners have been advised by US Postal mail, email, newsletters, Facebook, and our website that there is a Special Meeting of the Lakeridge West Community Association this Sunday, November 6, 2022 at the Lutheran Church of the Good Shepherd, Route 516, from 1 to 3 p.m.

The purpose of the meeting is to discuss Lakeridge West finances and consider an increase in the annual dues assessment which has not been raised since 2015. Our current dues assessment will not cover operating expenses in 2023, nor does it address any long-term capital projects. The increase is supported by the Board of Trustees.



At the upcoming meeting, President Karen Paton will provide a presentation that provides some historical perspective, the current financial picture, future capital needs, and the voting process. Following a Q & A, homeowners will cast one ballot per household if they have not already submitted a proxy vote.

Homeowners should be prepared to present identification, either a state or federal ID, property deed, etc. Only homeowners in good standing (up-to-date on dues payments) are eligible to vote, as per the LWCA declaration and bylaws. Three proctors will conduct and monitor the vote.

The goal is to be as transparent as possible, to preserve the integrity of our voting process, and to maintain courtesy and respect for our neighbors.
