In previous newsletters, we have mentioned that LWCA is in the process of revising its 57-year-old Bylaws which govern the Board's operation. The process is complicated by the lack of historical records.

LWCA is governed by overarching documents known as the Declaration of Covenants, and the Certificate of Incorporation, both signed in 1966. We have located 1975 amendments to the Certificate; these amendments essentially transferred complete control of the Association from Levitt & Sons to the homeowners.

Here and there, we have found some dusty minutes from the 1990's and 2000's, but little else. If you have any documents in your attic or garage, can we borrow them?
